The Principal initiated the meeting with a warm welcome of the External expert Prof. (Dr.) R.K. Chaubey, and other BOS members.

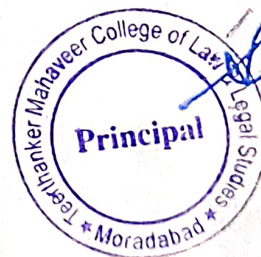
Agenda of Meeting:
