



**TEERTHANKER MAHAVEER UNIVERSITY**, having its registered office at Teerthanker Mahaveer University and located at NH 24, Delhi Road, Moradabad, UP-244001 (hereinafter referred to as "TMU", which expression shall include its successors and permitted assigns).

*Each of TMU and GHL shall individually be referred as a "Party" and collectively as the "Parties" depending upon reference.*

**WHEREAS:**

- A. The Parties are in a continuous arrangement since 2017 wherein GHL agreed to set up an AHA training site at TMU, wherein GHL shall impart AHA certified courses to such students of TMU desirous to enrol with AHA (defined as per the Original Agreement). Towards this, the Parties entered into various agreements from time to time including the last executed Memorandum of Understanding dated April 07, 2022 ("**Original Agreement**").
- B. The said Original Agreement expired with efflux of time on March 31, 2024.
- C. The Parties now hereby mutually agree to further renew the Term of the Original Agreement on such terms and conditions as set out hereunder.

**NOW, THEREFORE:**

- 1. Parties, in pursuance of Clause 5.1 of the Original Agreement, hereby agree to renew the Term of the Original Agreement for a period of 03 (three) years commencing retrospectively from April 01, 2024 and expiring on March 31, 2027 ("**Term**"), unless terminated earlier by the Parties in accordance with this Agreement. The Term may be renewed further for such extended period and on such terms and conditions as may be mutually agreed between the Parties.
- 2. All capitalized words and expressions not defined herein shall have the meaning ascribed to them in the Original Agreement.
- 3. Except to the extent specified in this Agreement all other provisions, terms and conditions of the Original Agreement shall apply and be enforceable during the renewed Term and nothing contained herein shall change or alter in any manner whatsoever the validity, enforceability and interpretation of the terms and conditions set out in the Original Agreement.
- 4. This Agreement shall form an integral part of the Original Agreement and shall be read in conjunction with the Original Agreement. The Original Agreement and the terms and conditions therein are incorporated in this Agreement by reference. In the event the provisions, terms and conditions set out in this Agreement are contradictory to and conflicting with the terms and conditions set out in the Original Agreement, the terms and conditions set out in this Agreement with respect to the Term shall supersede and shall be enforceable.
