

1.1. INTRODUCTION

Let us start with the story of Mr. Naveen who runs a readymade garment shop. Mr. Naveen purchased garments worth Rs.2,00,000. He sold them for Rs. 2,50,000. He also paid shop rent Rs.10,000. He is still left with goods worth Rs.20,000. Here we can see that Mr. Naveen carried few transactions. Why? for the purpose of running his garment shop i.e. his business. After carrying on these transactions now Mr. Naveen want to know what is the outcome.

He is left with the surplus of Rs.60,000.

Goods sold for: Rs.2,50,000

Goods in hand: Rs.20,000

Total: Rs.2,70,000

Less:

Goods purchased for: Rs.2,00,000

Rent of the Shop: Rs.10,000

Total: Rs.2,10,000

Earnings/Surplus: Rs. 60,000

So, here earnings/surplus of Rs.60,000 is known as 'event' and whatever Mr. Naveen did to earn this money i.e. purchase, sale, shop rent are known as 'transactions'. Every business organisation record these transactions to measure their transaction so as to see what are the earnings. Accounting is a discipline which serves the purpose of measurement of transactions and helps to develop useful information for the decision makers. Accounting is a process of identifying the transactions and events, measuring the transactions and events in terms of money, recording them in a systematic manner in the books of accounts, classifying or grouping them and finally summarizing the transactions in a manner useful to the users of accounting information. Accounting is one of the key functions for almost any business; it may be handled by a bookkeeper and accountant at small firms or by sizable finance departments with dozens of employees at larger companies.

Accounting is termed as the language of the business. Language serves the purpose of communication similarly the aim of accounting is to meet the needs of the rational and sound decision-makers.

1.2 MEANING AND DEFINITION

Accounting is a discipline which records, classifies, summarises and interprets financial information about the activities of an organisation so that intelligent decisions can be made. The main purpose of accounting is to ascertain profit or loss during a specified period and to show financial condition of the business on a particular date.

In the year 1961 *The American Institute of Certified Public Accountants* defined Accounting as "the art of recording, classifying and summarising in as significant manner and in terms of money, transactions and events which in part, at least of a financial character, and interpreting the results thereof".

As per this definition accounting starts with recording of information and ends at its interpretation. But today, the dimension of accounting has broadened. The globalisation of the business, increasing interest of the society in business activities, diversification of management and ownership has increased the importance of the communication of the accounting results. This requirement of communication of the results has also become the part of accounting. This aspect of accounting is very well defined in the following definition given by the American Accounting Association in the year 1966.

The American Accounting Association defines accounting as "the process of identifying, measuring, and communicating economic information to permit informed judgements

and decisions by users of the information." On the similar grounds Smith & Ashburne defined accounting as "the science of recording and classifying business transactions and events, primarily of a financial character and the art of making significant summaries, analysis and interpretations of these transactions and events and communicating the results to persons who must make decisions or form judgements."

In the year 1970, the *Accounting Principles Board of the American Institute of Certified Public Accountants* (AICPA) regarded accounting as a service activity. It defined the function of accounting as "to provide quantitative information, primarily of financial nature about economic entities that is needed to be useful in making economic decisions."

The term 'Accountancy' is used for the profession of accountants i.e. who do the work of accounting and are knowledgeable persons. Accounting is concerned with recording all business transactions systematically and then arranging in the form of various accounts and financial statements. And it is a distinct discipline like economics, physics, astronomy etc. The word accounting tries to explain the nature of the work of the accountants (professionals) and the word Accountancy refers to the profession these people adopt.

Thus, in simple words we can say that accounting can be defined as the process of recording, classifying, summarizing, analysing and interpreting the financial transactions and communicating the results to its users. From the above the definitions the nature of the 'accounting, can be cearly understood:

1.4 NATURE OF ACCOUNTING

Accounting is an art: Art requires a perfect knowledge, interest and experience to do a work efficiently. Art also teaches us how to do a work in the best possible way by making the best use of the available resources. Accounting is that part of knowledge that enables us to reach our goals. It shows the way as to how these goals can be attained in the best possible way. The computation of profits or loss in a systematic manner is a clear evidence of accounting being an art. It is an art to deals with the application of various accounting rules, principles and concepts to achieve certain concrete results.

Accounting is a science: Science is a systematised body of knowledge. It establishes a relationship of cause and effect in the various related phenomenon. It is also based on some fundamental principles. Accounting is based on established laws, principles or rules. It is a science because processing of business transactions is done on the basis of certain principles, which are generally accepted and not universally applicable. Hence, accounting cannot be treated as pure science like physics, chemistry or life science, where cause and effect relationship is studies and perfect conclusions are drawn. It can be termed as social science, whose results depend upon social and economic factors and to a greater extent on human behaviour.

Accounting is a Process: Accounting has its process of recording, classifying, summarising and interpretation of the financial transactions.

(i) **Recording :** Accounting records transactions in chronological order soon after their occurrence in the proper books of accounts.

- (ii) **Classifying:** It then accumulate the transactions of similar type at one place. This function is performed by maintaining the ledger in which different accounts are opened to which related transactions are posted.
- (iii) **Summarising**: Accounting prepare and present the classified data in a manner useful to the internal as well as the external users. Various statements like the Income statement, the Statement of financial position, the Statement of Changes in Financial Position, the Statement of Cash Flow etc. are prepared to provide summary of the business transactions.
- (iv) **Analysing:** The figures given in summarised financial statements are not going to help as such if these are not simplified. Analysis is concerned with the establishment of the relationship between the Income statement and the Statement of the financial position.
- (iv) **Interpreting**: With the advent of information technology, the aforesaid three functions are performed by accounting software and now the accountant has to concentrate mainly on the interpretation aspects of accounting. The accountants should interpret the statements in a manner useful to action. The accountant should explain not only what has happened but also (a) why it happened, and (b) what is likely to happen under specified conditions.
- (v) **Communicating:** The summarised, analysed and interpreted financial information is then communicated to the end users to enable them to make rational decisions. This transmission of the information is done through the preparation and distribution of the accounting reports consisting of accounting ratios, graphs, diagrams alongwith other useful information.

Accounting as a service activity: As a service activity, accounting collects and provides quantitative information, primarily financial in nature, about economic entities that is intended to be useful in making economic decisions, in making reasoned choices among alternative courses of action. Accounting in itself cannot create wealth though, if it produces information which is useful to others, it may assist in wealth creation and maintenance.

Accounting as a profession: Accounting is a career and it requires formal education for rendering any service. The candidate must pass a vigorous examination to become accounting professional. In India, the accounting education is being imparted to the examinees by national body like the Institute of Chartered Accountants of India (ICAI), New Delhi. Similarly in USA, the American Institute of Certified Public Accountants (AICPA) provide this education and certification to work as a Chartered Accountant.

Accounting as a social force: Under the changing business environment, accounting is considered responsible for protecting the interest of the society i.e. of the people who are directly or indirectly linked with its operations. The information provided by accounting is used to solve the problems of the public at large such as determination and controlling of prices. Therefore, it becomes the responsibility of the accountants to provide proper, adequate and reliable accounting information for safeguarding public interest so as the society at large is benefited.

Accounting as a language: As stated earlier, accounting is referred as the "language of business". As language helps to converse and communicate, similarly accounting communicates business events. A language and accounting have common features as regards rules and symbols. Both are based and propounded on fundamental rules and

symbols. In language these are known as grammatical rules and in accounting, these are termed as accounting rules.

Accounting as an information system: Accounting as an information system serves the needs of both profit-seeking business and non-profit organisations. It provides relevant financial information on the resources of a business so as to enable the decision makers to evaluate the financial consequences of various alternatives.

1.4 EVOLUTION OF ACCOUNTING

The concept of Accounting is as old as money itself. It is considered that the seeds of accounting were most likely first sown in Babylonia and Egypt around 4000 B.C. who recorded transactions of payment of wages and taxes on clay tablets. Historical evidences reveal that Egyptians used some form of accounting for their treasuries where gold and other valuables were kept. The incharge of treasuries had to send day wise reports to their superiors known as Wazirs (the prime minister) and from there month wise reports were sent to kings. Babylonia, known as the city of commerce, used accounting for business to uncover losses taken place due to frauds and lack of efficiency.

In Greece, accounting was used for apportioning the revenues received among treasuries, maintaining total receipts, total payments and balance of government financial transactions. Romans used memorandum or daybook where in receipts and payments were recorded and wherefrom they were posted to ledgers on monthly basis.

(700 B.C to 400 A.D). China used sophisticated form of government accounting as early as 2000 B.C. In India evidences of practicing Accounting can be traced from the book named "Arthashastra" written by Kautilya, King Chandragupta's minister. Other than issues relating to politics and economics, it also explains the art of proper keeping of accounts.

The modern system of accounting based on the principles of double entry system owes it origin to the Franciscan Monk Fra Luca Pacioli (1445-1515) who first published the principles of Double Entry System in 1494 at Venice in Italy. Luca Pacioli, considered as the father of modern accounting published the first text of 36 chapters on accounting 'Summa de Arithmetica, Geometria, Proportioni et Proportionalita.' It described double-entry bookkeeping and other commerce-related concepts. Double entry bookkeeping is a system in which a debit and credit entry is entered for each transaction: "Every debit has its credit –every amount that is charged to on account must be placed to the credit of another". He used the present day popular terms of accounting Debit (Dr.) and Credit (Cr.). These were the concepts used in Italian terminology. Debit comes from the Italian debito which comes from the Latin debita and debeo which means owed to the proprietor. Credit comes from the Italian credito which comes from the Latin 'credo' which means trust or belief. By the time Pacioli published is later work, De Divina Proportione, in 1509, he was so well respected that Leonardo da Vinci contributed several engravings for his text.

The Colonial expansion in the 17th century and demand for foreign goods saw the rise of 'chartered companies', the first corporations requiring permanently invested and large investment thus leading to the development of book-keeping to keep track of the assets and profits of many distinct trading ventures at different stages of completion. With the development of the corporate forms of business, especially during industrial revolution, accounting developed further.

Josiah Wedgwood, the founder of famous pottery manufacturer Wedgwood is considered by many to be a pioneer in cost accountancy. After examining business accounts, Josiah Wedgwood discovered that his head clerk had been embezzling from the company and so after hiring a new clerk he implemented weekly account reviews to keep track of his finances. These reviews allowed him to calculate detailed costs for materials and labour, leading to the discovery of overhead costs and economies of scale. The method of recording got popularity. Australia witnessed double entry book keeping for the first time when John Croaker helped to establish bookkeeping practices at the first Bank of New South Wales. In 1854, the formal accounting profession emerged in Scotland with the formation of Edinburgh Society and Glasgow Institute of Accountants. The title 'Chartered Accountant' was decided upon and adopted for members of the Society, and was soon adopted by the Glasgow Institute and the later formed Aberdeen Society. Later, in 1880, the Institute of Chartered Accountants in England and Wales was formed. In 1887 the American Association of Public Accountants was formed.

Thus, the art of accounting has been practised for centuries but it is only in the late thirties that the study of the subject 'accounting' has been taken up seriously.

1.5 DISTINCTION BETWEEN BOOK-KEEPING AND ACCOUNTING

Book-keeping is a part of accounting and is concerned with the recording of financial data relating to business operations in a significant and orderly manner. It covers

procedural aspects of accounting work and embraces record keeping function. Sometimes book-keeping and accounting are considered as synonymous but these are different from each other. Following are the differences in book keeping and accounting:

1.6 OBJECTIVES OF ACCOUNTING

The following are the main objectives of accounting:

- 1. **To keep systematic records:** The basic objective of accounting is to keep a systematic record of financial aspect of business transactions. If the records are not kept systematically, there would have been terrific burden on human memory which in most cases would have been impossible to bear. These records are then classified and summarised in the form of financial statements.
- 2. **To know the financial position of the business:** Accounting helps the management to understand and know what the organisation own and what it owes by supplying the information like (i) Organisation's ability to meet the short term liability. (ii) The amount to be paid in long run. (iii) The amount to be received from others (iv) Fixed assets and current assets of the business etc. Information about the above matters helps the proprietor in assuring that the funds of the business are not necessarily kept idle or underutilised.
- 3. **To ascertain the operational results:** Accounting helps in ascertaining the net profit earned or loss suffered on account of carrying the business operations for a particular period of time. This is done by keeping a proper record of revenues and expense of a particular period. If the amount of revenue for the period is more than the expenditure

incurred in earning that revenue, there is said to be a profit. In case the expenditure exceeds the revenue, there is said to be a loss. Income Statement/ Profit and Loss Account will help the management, investors, creditors, etc. to understand whether the business has proved to be remunerative or not. In case it has not proved to be remunerative or profitable, the cause of such a state of affairs will be investigated and necessary remedial steps will be taken.


- 4. **To ascertain the financial position of the business:** The management is not only interested in knowing the Profit and Loss of the organisation but is also interested in knowing its financial health i.e. where he stands?, what he owes and what he owns? This objective is served by the Balance Sheet or Statement of Financial Position. The Balance Sheet is a statement of assets and liabilities of the business on a particular date. It serves as barometer for ascertaining the financial health of the business.
- 5. **To facilitate rational decision making:** Accounting not only records the information but also analyse and interpret the same and communicate to the stakeholders to enable them to make rational decisions. The American Accounting Association has also stressed this point while defining the term accounting when it says that accounting is the process of identifying, measuring and communicating economic information to permit informed judgements and decisions by users of the information. The accounting bodies all over the world and particularly the International Accounting Standards Committee have achieved success in laying down some basic postulates on the basis of which the accounting statements have to be prepared. This has further facilitated the usefulness of the accounting information beyond the national boundaries.

1.7 USERS OF ACCOUNTING INFORMATION

As understood from the previous section, the basic objective of accounting is to provide information which is useful for persons internal and external to the organisation. Following are the various internal and external users of the accounting information.



Internal Users of Accounting Information. Internal users of accounting information are those persons or groups which are within the organisation. Following are such internal users:

- 1. *Owners.* The owners provide funds to the business. They bear the risk of success or failure of the business. They are interested in knowing whether their funds are being properly used or not. They need accounting information to know the future, solvency and profitability position of the business. The financial statements prepared from time to time from accounting records depict them the profitability and the financial position.
- 2. Management. Management need the accounting information to understand the performance of the various segments and of business as a whole. Managers are responsible for the growth of the business. The increase in the value of the shareholders can be well understood from the financial statements. Accounting information also helps a manager in appraising the performance of the subordinates. Further accounting helps management in planning and controlling. On the basis of previous information management prepare various budgets. Actual performance of the management can be compared with the budgeted performance and corrective actions may be taken.
- 3. *Employees*. Employees are interested in the financial position of an organisation because their growth is directly related to the growth of the organisation. They too want to ensure the regular and timely payment of their salaries, growth opportunities, bonus and other employment linked benefits.

External Users of Accounting Information: External users are those groups or persons who are outside the organisation. Following can be the various external users of accounting information:

- 1. *Investors:* Those who are interested in investing money in an organisation seek accounting information to know the future prospects of the organisation. They want to ensure the safety of their principal amount and also want to earn adequate returns on their investments. They can know the return on investments by analysing profitability and the financial position of the organisation.
- 2. *Creditors:* Creditors (i.e. supplier of goods and services on credit, bankers and other lenders of money) are interested in the liquidity position of an organisation before giving loans or granting credit. They are interested in knowing whether the loan-principal and interest will be paid when due. This information helps them to frame the credit policy and to decide the rate of interest accordingly.
- 3. Public and Members of Non-profit Organisations. Public and Members of non-profit organisations such as schools, colleges, hospitals, clubs, charitable institutions etc. need accounting information to know how their contributed funds are being utilised and to ascertain if the organisation deserves continued support or support should be withdrawn keeping in view the bad performance depicted by the accounting information and diverted to another organisation. In knowing the performance of such organisations, criterion will not be the profit made but the main criterion will be the service provided to the society. The public at large is interested in the functioning of the organisation because it make a substantial contribution to the local economy in many ways including the number of people employed and their patronage to local suppliers.
- 4. Government. In order to implement the taxation policy, the Central and State Governments are interested in the accounting information. Further it also help the government in regulating the business enterprise for public food, allocate scarce resources among competing organisations, control prices, charge excise duties etc. Government also needs accounting information for compiling statistics concerning business which, in turn helps in compiling national accounts.
- 5. *Consumers.* Consumers need accounting information to understand the stability of the enterprise so as to ensure the supply of goods regularly.
- 6. Research Scholars. Research scholars are interested in accounting information to undertake their research studies. They collect the accounting information and analyse as per their research objectives.

1.8 LIMITATIONS OF ACCOUNTING

Accounting provides useful information to its users but we cannot say that accounting is free from limitations. Following are the limitations:

- **(a)** Accounting permits alternative treatments: Though accounting is based on "generally accepted accounting principles", but existence of more than one alternative for the treatment of any one item make results incomparable. For example, closing stock is may be valued using LIFO, FIFO, Weighted average method etc.
- **(b) Estimates may not be accurate:** Accounting takes into consideration personal judgements alongwith the factual information which is often not accurate. For example estimating useful life of the machine for depreciation purpose, provision for bad and doubtful debts cannot be made with exactness. It is very difficult to expect accuracy in future estimates and objectivity suffers.

- **(c)** Financial accounting ignores important non-monetary information: Financial accounting considers only those transactions and events which can be described in money. The transactions and events of non-monetary nature, however important, are ignored. For example, integrity of management, loyalty of employees, product quality, customer satisfaction are vital factors but do not find any place in accounting.
- **(d) Ignores price level changes:** Accounting records all transactions at historical cost. So, changes in the value of assets are not recorded. Thus, it fails to present the current value of the business.
- **(e) Does not highlight efficiency or inefficiency:** Accounting presents the overall picture of the organisation and does not disclose the contribution of each department in the profit and losses. It is difficult to ascertain which product is profitable and which is not. Accounting is mere presentation of the business figures which themselves are not self-explanatory. It depends upon the analysis and interpretation ability of the user who uses the information.

1.9 BASIC ACCOUNTING TERMS

Entity: Entity means a thing that has a definite individual existence. Business entity means a specifically identifiable business enterprise like Kalyan Jewellers, Reliance Industries, etc. An accounting system is always devised for a specific business entity (also called accounting entity).

Transaction: Any exchange of value for value involving money or money's worth between two or more parties is known as transaction. It can be a purchase of goods, receipt of money, payment to a creditor, incurring expenses, etc. It can be a cash transaction or a credit transaction.

Turnover: Turnover means total trading income from cash sales and credit sales.

Assets: Assets are values or financial resources owned by business. Assets are tangible objects or intangible rights owned by the organisation and carrying probable future benefits. These are economic resources of an enterprise that can be usefully expressed in monetary terms. For example, land, building, motor vehicles etc. These are shown on the asset side of the balance sheet. Assets can be broadly classified into two types: Fixed Assets and Current Assets.

Fixed Assets: Fixed assets are Asset held for the purpose of providing services and that is not held for resale in the normal course of operations of the organisation. These are held on a long-term basis, such as land, buildings, machinery, plant, furniture and fixtures. These assets are used for the normal operations of the business.

Current Assets: Current assets held on a short-term basis such as debtors (accounts receivable), bills receivable (notes receivable), stock (inventory), temporary marketable securities, cash and bank balances. These assets that are expected to be converted into cash or consumed in rendering of services in the normal course of operations of the organisation.

Account Receivable: Person from whom amounts are due for goods sold or services rendered or in respect of contractual obligations. Also termed as debtor, trade debtor, sundry debtor. The words 'Receivables' and 'Debtors' are used interchangeably.

Finished Goods: Goods held for sale in the ordinary course of business.

Investments: Assets held not for operational purposes or for rendering services, i.e., assets other than fixed assets or current assets (e.g. securities, shares, debentures, immovable properties).

Net Assets: The excess of the book value of the assets of an accounting unit over its liabilities to outsiders.

Qualifying Fixed Asset: A Qualifying Fixed Asset is an asset that necessarily takes a substantial period of time to get ready for its intended use or sale. Ordinarily a period of twelve months is considered as substantial period unless a shorter or longer period can be justified on the basis of facts and circumstances of the case. In estimating the period, the time which an asset takes, technologically and commercially, to get it ready for its intended use or sale should be considered.

Depreciable Asset: An asset which is expected to be used during more than one accounting year, has a limited useful life, and is held by the organisation or use in the supply of goods and services, for rental to others, or for administrative purposes and not for the purpose of sale in the ordinary course of operations of the organisation.

Depreciation: A measure of the wearing out, consumption or other loss of value of a depreciable asset arising from use, obsolescence through technology and market changes. It is allocated so as to charge a fair proportion in each accounting period during the useful life of the asset. It includes amortisation of assets whose useful life is predetermined and depletion of wasting assets.

Liabilities: Liability is an amount owing by one person to another, payable in money, or in goods or services: the consequence of an asset or service received or a loss incurred or accrued; particularly any debt (a) due or past due (current liability), (b) due at a specified time in the future (e.g. funded debt, accrued liability), or (c) due only on failure to perform a future act (contingent liability). Liabilities are obligations or debts that an enterprise has to pay at some time in the future. They represent creditors' claims on the firm's assets. Both small and big businesses find it necessary to borrow money at one time or the other, and to purchase goods on credit. Liabilities are classified as long-term liabilities and short-term liabilities (also known as short-term liabilities).

Long-term liabilities: These are usually payable after a period of one year, for example, a term loan from a financial institution or debentures (bonds) issued by a company.

Short-term liabilities/ Current Liability: Liability including loans, deposits and bank overdrafts which fall due for payment in a relatively short period, normally not more than twelve months. These are obligations that are payable within a period of one year, for example, creditors, bills payable, bank overdraft.

Contingent Liability: An obligation relating to an existing condition or situation which may arise in future depending on the occurrence or non-occurrence of one or more uncertain future events.

Capital: Capital refers to money or money's worth invested in business. It may be brought in the form of cash or assets by the owner. It is treated as owner's equity and is a claim against assets. For the business entity capital is an obligation and a claim on the assets of business. It is, therefore, shown as capital on the liabilities side of the balance sheet.

Sales: The amount at which the goods are sold. Sales are total revenues from goods or services sold or provided to customers. Sales may be cash sales or credit sales.

Revenues: Money or money equivalent earned or accrued during an accounting period, increasing the total of previously existing net assets, and arising from provision of any type of services and rentals. These are the amounts of the business earned by selling its products or providing services to customers, called sales revenue. Other items of revenue common to many businesses are: commission, interest, dividends, royalties, rent received, etc. Revenue is also called income.

Expenses: A cost relating to the operations of an accounting period or to the revenue earned during the period or the benefits of which do not extend beyond that period. Costs incurred by a business in the process of earning revenue are known as expenses. Generally, expenses are measured by the cost of assets consumed or services used during an accounting period. The usual items of expenses are: salary, electricity, wages, discount, interest etc.

Expenditure: The amounts that were to be paid or are paid for services received or needed in the current operation of the business. Spending money or incurring a liability for some benefit, service or property received is called expenditure. For examples rent, carriage, insurance, purchase of furniture, stock, etc. If the benefit of expenditure is exhausted within a year, it is treated as an expense (also called revenue expenditure). On the other hand, the benefit of expenditure lasts for more than a year; it is treated as an asset (also called capital expenditure) such as purchase of machinery, furniture, etc.

Profit: The excess of revenues of a period over its related expenses during an accounting year profit. Profit increases the investment of the owners.

Gain: A profit that arises from events or transactions which are incidental to business such as sale of fixed assets, winning a court case, appreciation in the value of an asset.

Loss: The excess of expenses of a period over its related revenues its termed as loss. It decreases in owner's equity. It also refers to money or money's worth lost (or cost incurred) without receiving any benefit in return, e.g., cash or goods lost by theft or a fire accident, etc. It also includes loss on sale of fixed assets.

Discount: Discount is the deduction in the price of the goods sold. It is offered in two ways. Offering deduction of agreed percentage of list price at the time selling goods is one way of giving discount. Such discount is called 'trade discount'. It is generally offered by manufactures to wholesalers and by wholesalers to retailers. After selling the goods on credit basis the debtors may be given certain deduction in amount due in case if they pay the amount within the stipulated period or earlier. This deduction is given at the time of payment on the amount payable. Hence, it is called as cash discount. Cash discount acts as an incentive that encourages prompt payment by the debtors.

Voucher: The documentary evidence in support of a transaction is known as voucher. For example, if we buy goods for cash, we get cash memo, if we buy on credit, we get an invoice; when we make a payment we get a receipt and so on.

Goods: It refers to the products in which the business units are dealing, i.e. in terms of which it is buying and selling or producing and selling. The items that are purchased for use in the business are not called goods. For example, for a furniture dealer purchase of chairs and tables is termed as goods, while for other it is furniture and is treated as an asset. Similarly, for a stationery merchant, stationery is goods, whereas for others it is an item of expense (not purchases)

Drawings: Withdrawal of money and/or goods by the owner from the business for personal use is known as drawings. Drawings reduce the investment of the owners.

Purchases: Purchases are total amount of goods procured by a business on credit and on cash, for use or sale. In a trading concern, purchases are made of merchandise for resale with or without processing. In a manufacturing concern, raw materials are purchased, processed further into finished goods and then sold. Purchases may be cash purchases or credit purchases.

Stock: Stock (inventory) is a measure of something on hand-goods, spares and other items in a business. It is called *Stock in hand*. In a trading concern, the stock on hand is the amount of goods which are lying unsold as at the end of an accounting period is called *closing stock* (ending inventory). In a manufacturing company, closing stock comprises raw materials, semi-finished goods and finished goods on hand on the closing date. Similarly, *opening stock* (beginning inventory) is the amount of stock at the beginning of the accounting period.

Debtors: Debtors are persons and/or other entities who owe to an enterprise an amount for buying goods and services on credit. The total amount standing against such persons and/or entities on the closing date, is shown in the balance sheet as *sundry debtors* on the asset side.

Creditors: Creditors are persons and/or other entities that have to be paid by an enterprise an amount for providing the enterprise goods and services on credit. The total amount standing to the favour of such persons and/or entities on the closing date is shown in the Balance Sheet as *sundry creditors* on the liabilities side.

Account Payable: Amount owed by an enterprise on account of goods purchased or services received or in respect of contractual obligations. It is also termed as trade creditor or sundry creditor.

Account: A formal record of a particular type of transaction expressed in money or other unit of measurement and kept in a ledger.

Accounting Entry: A record of financial transaction in the books of account like journal, ledger, cash book, etc.

Accounting Period: The period of time for which an operating statement is customarily prepared.

Accrual Basis of Accounting: The method of accounting whereby revenues and expenses are identified with specific periods of time, such as a month or year, and are recorded as incurred, along with acquired assets, without regard to the date of receipt payment of cash; distinguished from cash basis.

Balance Sheet: A statement of the financial position of an organisation as at a given date, which exhibits its assets, liabilities, capital, reserve and other account balances at their respective book values.

Credit: Credits are value owed, given or parted with. A bookkeeping entry recording the reduction or elimination of an asset or an expense, or the creation of or addition to a liability or item of net worth or revenue; an entry on the right side of an account; the amount so recorded.

Debit: Debits are value owned or received. In a transaction the value received in recorded as debit. The goods or benefit received from a transaction; a bookkeeping

entry recording the creation of or addition to an asset or an expense, or the reduction or elimination of a liability, or item of net worth or revenue; an entry on the left side of an account; the amount so recorded.

Deferred Revenue Expenditure: Expenditure for which payment has been made or a liability incurred but which is carried forward on the presumption that it will be of benefit over a subsequent period or periods. This is also referred to as Deferred Expenditure.

Financial Statement: A balance sheet, income statement (income and expenditure), receipts & payment statement or any other supporting statement or other presentation of financial data derived from accounting records.

2.0 OBJECTIVES

After studying this lesson you should be able to

2.1. INTRODUCTION

As discussed in the previous lesson, the basic objective of accounting is to provide the financial information which is useful for the stakeholders such as shareholders, creditors, potential investors, proprietors and others, in making rational decisions. This information is supplied with the help of accounting reports. It is very important that these reports should be prepared in such a manner that it is commonly understood by all. In order to maintain uniformity and consistency in preparing and maintaining books of accounts, certain rules or principles have been evolved. The basic rules are summarised as 'generally accepted accounting principles'. Accounting principles are basic norms and assumptions on which the whole accounting system has been developed and established. The accounting standards as introduced by the regulatory authority of a particular country has to be followed while preparation of the accounting reports. The present lesson will focus on 'Generally Accepted Accounting Principles'.

2.2 MEANING AND NATURE

The Canadian Institute of Chartered Accountants defines accounting principles as "The body of doctrines commonly associated with the theory and procedure of accounting serving as an explanation of current practices and as a guide for the selection of conventions or procedures where alternatives exists. Rules governing the formation of accounting axioms and the principles derived from them have arisen from common experience, historical precedent statements by individuals and professional bodies and regulations of Governmental agencies".

Hendriksen opined that Accounting principles are logical set that form the general frame of reference for the evaluation and development of sound accounting practices.

As per *The American Institute of Certified Public Accountants (AICPA)* Principle means "rule of action". These principles represent the most current consensus about how accounting information should be recorded, what information should be disclosed, how it should be disclosed, and which financial statement should be prepared.

The Institute of Chartered Accountants of India states that "Accounting principles are a body of doctrines commonly associated with the theory and procedures of accounting serving as an explanation of current practices and as a guide for selection of conventions or procedures where alternatives exits." Accounting principles must satisfy the following conditions:

- (1) They should be based on real assumptions
- (2) They must be simple, understandable and explanatory
- (3) They must be followed consistently
- (4) They should be able to reflect future predictions
- (5) They should be informational for the users.

Thus, Accounting Principles can be defined as those rules of action or conduct which are adopted by the accountants universally while recording accounting transactions. The general acceptance of an accounting principle usually depends on how well it meets three basic norms: a) Usefulness b) Objectiveness, and c) Feasibility




Fig:1 Norms of accounting principles

A principle is said to be useful if it increases the utility of the records to its readers. It should results in providing meaningful or relevant information to those who need it. Accounting principle is said to be objective when it is supported by facts and the information is free from personal biasness. Principle must ensure reliability which

means that the information is accurate and can be verified. The norm of feasibility states that it can be implemented without undue difficulty or cost.


2.3 BASIC ACCOUNTING PRINCIPLES

Accounting principles are classified as concepts and conventions.

Accounting concept defines the postulates i.e. necessary assumptions on the basis of which financial statements of a business entity are prepared. The main objective is to maintain uniformity and consistency in accounting records. Concept means idea or notion which has universal application. These accounting concepts have been developed over the years of experience and thus they are universally accepted rules.

Conventions are customs or traditions. Basically, accounting conventions emerge out of accounting practices adopted by the organisations over a period of time. These conventions are derived by usage and practice. These are a guide to the preparation of accounting statement. The accountancy bodies of the world may change any of the convention to improve the quality of accounting information. Further, accounting conventions need not have universal application.

Following are the accounting concepts and conventions:



2.3.1. ACCOUNTING CONCEPTS

1. Business Entity Concept. Business entity concept states that business and owner of the business are two separate entities. All the business books of accounts records day to day financial transactions related to the business only. Transactions related to the owners are recorded in his personal books. Accountants should treat business as separate entity from its owners.

Thus, when owner contribute capital to start of the business, it is treated a liability in the books of accounts. Similarly, if the owner takes cash from the cash box for meeting certain personal expenditure, the accounts would show that cash had been reduced even though it does not make any difference to the owner himself. This withdrawal for personal use is termed as 'drawings'. Thus, in recording a transaction the important question is how does it affects the business?

Business entity concept helps in keeping business affairs free from the influence of the personal affairs of the owners. The concept is applicable to all forms of business enterprises viz. sole proprietorship, partnership, companies, etc. It may be noted that it is only for accounting purpose that partnerships and sole proprietorship are treated as separate from the owner (s), though law does not make such distinction. In fact, the business entity concept is applied to make it possible for the owners to assess the performance of their business and performance of those whose manage the enterprise.

The major significance of the business entity concept is that it helps in ascertaining the profit of the business only. Further, it restraint accountants from recording of private/personal transactions of the owners. The personal transactions are ignored.

2. Money Measurement Concept. Money measurement concept states that only those business transactions are recorded which can be expressed in terms of money. Thus, the transactions which cannot be expressed in terms of money are not recorded in the books of accounts i.e. this concept excludes those transactions or events which cannot be expressed in terms of money.

The main advantage of the money measurement concept is that money provides a common denominator by means of which heterogeneous facts about an entity can be expressed as numbers that can be added and subtracted.

The major limitation of the money measurement concept is on the scope of an accounting report. Accounting does not report the state of the CEO's health, quality of the human resources, working environment in the organisation etc. Accounting does not give the complete picture of what is happening in an organisation. Further money is expressed in terms of its value at the beginning of an event. Subsequent changes in the price level are not recorded. For example, a land purchased for Rs.10,00,000 in the year 2000 will be recorded at the same value in the year 2014 as well though the purchasing power of the rupee has been decreased over a time period. It is sometimes said that money is an unvarying yardstick of value, but this statement is inaccurate. Accountants know full well that the purchasing power of rupee changes but they do not attempt to reflect such changes in the accounts.

Business entity concept and money measurement concept are viewed as the basic concepts on which other procedural concepts hinge.

3. Dual Aspect Concept. Dual ascrect concept is the core of the double entry bookkeeping system. According to this concept every transactions has two aspects to be recorded. The recognition of these two aspects of every transaction is known as a dual aspect analysis. According to this concept every business transactions has dual effect. For example, it increased one asset and decreases other asset; it increases an asset and simultaneously increases liability; it decreases one asset, increases other asset; or it decreases one asset and decreases a liability also. Suppose, if a firm sells goods of Rs. 10,000 then as per dual aspect concept this transaction involves two aspects. One aspect is the delivery of goods and the other aspect is immediate receipt of cash (in the case of cash sales). Accounting systems are set up so as to record both these aspects of a transaction and that is why accounting is called a double entry system. According to this system the total amount debited always equals the total amount credited. It follows from 'dual aspect concept' that at any point in time owners' equity and liabilities for any accounting entity will be equal to assets owned by that entity. This idea is fundamental to accounting and could be expressed as the following accounting equation, which is the formal expression of the dual-aspect concept:

Owners' Equity (E) = Assets (A) – Liabilities (L).....(2)

The above relationship is known as the 'Accounting Equation'. The term 'Owners Equity' denotes the economic resources supplied by the owners of the entity while the term 'liabilities' denotes the claim of outside parties such as creditors, debenture-holders, bank against the assets of the business. Assets are the resources owned by a business. The total of assets will be equal to total of liabilities plus owners capital because all assets of the business are claimed by either owners or outsiders.

To repeat, every transaction recorded in the accounts affects at least two items. There is no conceivable way that a transaction can result in only a single change in the accounts.

4. Going Concern Concept. Accounting assumes that the business entity will continue to operate for a long time in the future unless there is good evidence to the contrary. Financial statements are normally prepared on the assumption that an enterprise is a going concern and will continue in operations for the foreseeable future. In other words, there is neither the intention nor the necessity to liquidate the particular business venture in the predictable future. Because of this assumption, the accountant while valuing the assets does not take into account forced sale value of them.

The assumption that the business is not expected to be liquidated in the foreseeable future establishes the basis for many of the valuations and allocations in accounting. For example, the accountant charges depreciation of fixed assets values. It is this assumption which underlies the decision of investors to commit capital to enterprise. Only on the basis of this assumption can the accounting process remain stable and achieve the objective of correctly reporting and recording on the capital invested, the efficiency of management, and the position of the enterprise as a going concern.

However, if the accountant has good reasons to believe that the business, or some part of it is going to be liquidated or that it will cease to operate (say within six-month or a year), then the resources could be reported at their current values. If this concept is not followed, International Accounting Standard requires the disclosure of the fact in the financial statements together with reasons.

The major significance of the going concern concept can be indicated by contrasting it with a possible alternative, namely that the entity is about to be liquidated. Under the latter assumption, accounting would attempt to measure at all times what the entity's resources are currently worth to potential buyers. Under the going-concern concept, by contrast, there is no need to constantly measure an entity's worth to potential buyer, and it is not done. Instead, it is assumed that the resources currently available to the entity will be used in its future operations. For example, in case of manufacturing organisation, accounting recognises the value of the goods as evidenced by their selling price. The current resale values of the individual machines, supplies, and the other resources used in the manufacturing process are irrelevant because there is no intention of selling them individually.

5. Accounting Period Concept. As per going concern concept there is an indefinite life of an entity. But it is not desirable to measure its performance at the end of its life. If indefinite period is followed then nothing will accrue. There cannot be unpaid expenses and non-receipt of the revenue. So, a small but workable fraction is chosen out of infinite life cycle of the business entity for measuring performance and looking at the financial position. Accounting Period concept refers to the length of financial reporting periods. Account period is the time between two successive balance sheet dates.

Accounting period concept requires that the life of the business should be divided into appropriate segments for studying the financial results shown by the enterprise after each segment. Although the results of operations of a specific enterprise can be known precisely only after the business has ceased to operate but the knowledge of the results periodically is also necessary. Thus, the accountant must report for the changes in the wealth of a firm for short time periods for those who are interested in the operations of the business entity. Generally one year is taken up for performance measurement and appraisal of financial position.

Some accountants adopt financial year of the government, some other calendar year. In India, the financial year is followed which starts from 1st April of a year to 31st March of the immediately following year. Although a twelve month period is adopted for external users, a shorter span of interval, say one month or three month is applied for internal users of the accounting information.

The major significance of the accounting period concept is that it facilitates the comparison of the financials statements of different periods which further helps in ascertaining the performance of the entity over a time period. Secondly, it ensures uniform and consistent accounting treatment for ascertaining the profit and assets of the business. Further the matching of periodic revenues with expenses for getting correct results of the business operations gives better understanding of the operating activities of the organisation.

The accounting period concept suffers from one limitation of the allocation of long term costs. All the revenues and all the cost relating to the year in operation have to be taken into account while matching the earnings irrespective of the fact whether or not they have been received in cash or paid in cash. Despite the difficulties which stem from this concept, short term reports are of vital importance to owners, management, creditors and other interested parties. Hence, the accountants have no option but to resolve such difficulties.

6. Cost Concept. According to the cost concept an asset is ordinarily entered on the accounting records at the price paid to acquire it i.e. the historical cost or the acquisition

cost. For example, if a business buys a property for Rs. 50 lakh, it would be recorded in the books at Rs. 50 lakh, even if its market value at that time happens to be Rs. 60 lakh. Thus, assets are recorded at their original purchase price and this cost is the basis for all subsequent accounting for the business. The assets shown in the financial statements do not necessarily indicate their present market values. The term 'book value' is used for amount shown in the accounting records.

The major significance of the cost concept is that it ensures objectivity. Other measures are not so objective. For example present value base is highly subjective because to know the value of the asset one has to chase the uncertain future.

There are certain limitations also. A balance sheet based on this concept can be very misleading as it shows assets at cost even when there are wide difference between their costs and market values. Secondly, in inflationary situation then prices of all commodities go up on an average, acquisition cost loses its relevance. So, the valuation of the assets at historical cost does not reflect true position. Further, historical cost may lose comparability. Many assets do not have acquisition cost for example, human resources. The cost concept fails to recognise such asset although it is a very important asset of an organisation.

Despite of these limitations, the cost concept meets all the three basic norms of relevance, objectivity and feasibility.

7. The Matching concept. This concept is based on the accounting period concept. According to matching concept, all expenses matched with the revenues of that period should be taken into consideration i.e. when a given event affects both revenues and expenses the effect of each should be recognized in the same accounting period. For example, the sale of goods has two aspects; revenue aspect and expense aspect i.e. increase in earnings equal to the amount of revenue realized and decrease in earnings equal to the expenses. To ascertain net effect of earnings both these aspects must be recognised in the same accounting period.

Matching concept is based on accrual concept as it considers the occurrence of the expenses and incomes and do not concentrate on actual inflow or outflow of cash. It is the entire process of periodic earnings measurement, often described as a process of matching expenses with revenues. It may be noted that costs incurred do not become expenses until the goods or services in question are exchanged. Cost is not synonymous with expense. Only costs that have expired during an accounting period are considered as expenses. For example, if a commission is paid in January, 2014, for services enjoyed in November, 2013, that commission should be taken as the cost for services rendered in November 2013. This leads to adjustments for all prepaid expenses, outstanding expenses, accrued income, etc, while preparing periodic reports.

8. Accrual Concept. As per accrual concept, the effect of transactions and other events are recognised as and when they occur and are recorded in the financial statement of the periods to which they relate. Accrual means recognition of revenue and costs as they are earned or incurred and not as money is received or paid. Accrual concept makes a distinction between the receipt of cash and the right to receive it, and the payment of cash and the legal obligation to pay it. It relates to measurement of income, identifying assets and liabilities. This concept provides a guideline to the accountant as to how he should treat the cash receipts and the right related thereto.

The major significance is that accrual concept helps in proper measurement of income. Financial statements prepared on the accrual bass inform users not only of past events involving the payment and receipt of cash but also of obligations to pay cash in the future and of resources that represent cash to be received in the future. Accrual concept provides the foundation on which the structure of present day accounting has been developed.

The accrual concept, matching concept and the accounting period concepts work together for income measurement and recognition of assets and liabilities. Accounting period concept fixes up the time-frame for which the performance is to be measured and financial position is to be appraised. Accrual concept operates to measure revenues accrued and not the cash received.

9. Realisation Concept. Realisation concept is used to identify precisely the amount of revenue to be recognised and the amount of expense to be matched to such revenue for the purpose of income measurement. Realisation refers to inflows of cash or claims to cash arising from the sale of goods or services. It closely follows the cost concept. Any change in the value of asset is to be recorded only when the business realises it.

The realisation concept states that the amount recognised as revenue is the amount that is reasonably certain to be realized i.e. that customers are reasonably certain to pay. Thus, when an asset is recorded at its historical cost and appreciates due to the current value, such change is not counted unless there is certainty that such change will materialise.

Economists are highly critical about the realisation concept as they believe that this concept creates value distortion and makes accounting meaningless

2.3.2. ACCOUNTING CONVENTIONS

1. Convention of Materiality: There is a doctrine called *de minimis non curat lex,* which means that the court will not consider trivial matters. Similarly the accountant does not attempt to record events so insignificant that the work of recording them is not justified by the usefulness of the results. **Materiality** captures the notion that financial reports need not include items that are so small as to be meaningless to users. Immaterial items do not appear in the financial reports. No precise quantitative materiality threshold exists, so financial statement preparers must apply judgement to decide whether a given item is immaterial.

The convention of materiality concept states that items of small significance should be ignored, if the effect is not considered material. It means that all items that have material effect on the business should be disclosed in the financial statements and items that are insignificant and not relevant to the users should not be disclosed. For example, an ordinary calculator is considered as stationery item and treated as an expense in the year of purchase though it may be used for 10 years.

Unfortunately there is no agreement as to the exact line separating material events from immaterial events, The materiality depends not only upon the amount of the item but also upon the size of the business, nature and level of information, level of the person making decision etc.

This convention suffers from a limitation of subjectivity. It depends on the discretion of the accountant that which item is material or which item is not material. An item which is material for one may be immaterial for another person. It will unnecessarily overburden an accountant with more details in case he is unable to find an objective distinction between material and immaterial events. Despite this limitation, it is necessary to disclose all material information to make the financial statements clear and understandable. This is required as per IAS-1 and also reiterated in IAS-5. As per IAS-1, materiality should govern the selection and application of accounting policies.

2. Convention of Conservatism: The convention of conservatism states that accountant should not anticipate profits but provide for all possible losses. In simple words, this concept requires that the accountants must follow the policy of "playing safe" while recording business transactions and events.

The rule of valuation of inventory at the cost or market value whichever is lower is originated from this convention. This rule means that an accountant should record lowest possible value for assets and revenues, and the highest possible value for liabilities and expenses. This is the reason why provisions are made for all known liabilities, expenses and losses, Probable losses regarding all contingencies are also be provided for, for example provision for doubtful debts on debtors in anticipation of actual bad debts', 'adopting written down value method of depreciation as against straight line method', not providing for discount on creditors but providing for discount on debtors etc.

According to the realisation concept no change should be counted unless it has materialised. The convention of conservatism takes this further by stating that it is not prudent to count unrealised gain but it is desirable to guard against all possible losses.

The convention of conservatism has been criticised by many accounting authors on the grounds that it essentially leads to understatement of income and wealth and it should not be the basis for the preparation of financial statements. The financial statements do

not present a true and fair view of state of affairs especially, when the accountant create secret reserves, by creating excess provision for bad and doubtful debts, depreciation, etc. The American Institute of Certified Public Accountant have also indicated that this concept need to be applied with much more caution and care as over conservatism may result in misrepresentation.

3. Convention of Consistency. The convention of consistency states in order to achieve comparability of the financial statements of an entity year on year, the accounting policies and methods once chosen should be followed consistently; a change in an accounting policy is made only in certain exceptional circumstances. For example, if depreciation is charged on fixed assets according to straight line method, this method should be followed year after year. Similarly, if stock is valued at 'cost or market price whichever is less', this principle should be applied in each subsequent year.

However the convention of consistency does not forbid the adoption of improved method of accounting. The accounting policy can be changed to bring the books of accounts in accordance with the issued accounting standards; in order to comply with the provision of law; or when as per changing circumstances it is felt that the new method will reflect more true and fair picture in the financial statement.

The major significance of the convention of consistency is that it facilitates the comparison of the financial statements. One could draw valid conclusions from the comparison of data drawn from financial statements of one year with that of the other year. But the inconsistency in the application of accounting methods might significantly affect the reported data.

4. Convention of Disclosure: The convention of disclosure states that all accounting statements should be honestly prepared and all facts and figures must be disclosed therein. A business should include in its financial statements anything that might affect the decisions of its shareholders to invest in the company or its lenders to provide loans. The disclosure of financial information is required for different parties who are interested in the welfare of that enterprise. For example, interested parties might want to know about the sale of a large asset for a loss that reduces the income reported for the time period, or about the special terms of a new bank loan. These details would be included as footnotes to the income statement and balance sheet. The Companies Act lays down the forms of Profit and Loss Account and Balance Sheet. Thus convention of disclosure is required to be kept as per the requirement of the Companies Act and Income Tax Act.



2.4 BASES OF ACCOUNTING

Accounting bases are the methods which have been developed by accountants to apply the fundamental concepts. These are measurement methods that are available to entities in the preparation of their financial statements. Due to the complexity of business activities and involvement of different types of transactions, there may be more than one basis which may be applied to the accounting treatment of a particular item. This means that the range of accounting bases is very wide and there is frequently more than one recognised accounting bases for dealing with a particular item. In particular, accounting bases are the methods developed for determining the (a) accounting periods in which revenues and costs should be recognised in the income statements and (b) amounts at which material items should be stated in the statement of financial position.

For example, a business enterprise is required to depreciation of its fixed assets and also to value the stock at the end of the accounting period, so that, following the accrual or matching concepts, such stock items can be set out against the sale proceeds of those items in the future accounting period and the assets can be shown at their carrying values in the statement of financial position. There are, however, a number of alternative methods of valuing stock for example LIFO or FIFO or of providing for depreciation for example straight line or written down and these are accounting bases.

Accounting policies are the specific accounting bases judged by business enterprises to be most appropriate to their circumstances and adopted by them for the purpose of preparing their financial accounts. The relationship among accounting concepts, accounting bases and accounting policies can be illustrated with the following block diagram:




2.5 NATURE OF ACCOUNTS

According to Rorrem and Kerrigan, "An account is an comprehensive and classified record of transactions affecting one person, one kind of property or one class of gains or

losses arising out of expenses or incomes. Each account is dignified as a separate financial entity, having debtor-creditor relations with other accounts." Basically an account is a basic information format used for recording transactions relating to revenues, expenses, asset, liability or owner's equity. An account can be perceived of having a format similar to the capital letter "T". The details are discussed in the next lessons. The nature of accounts can be well understood from its following classification:

(a) Traditional Classification and (b) Modern Classification



(A) Traditional Classification of Accounts:

As per traditional classification following is the nature of accounts:

1. Personal Accounts: Personal accounts are related to persons, that is, specific parties the business is dealing with. These accounts show the transactions with the customers, suppliers, creditors, the bank and the owner etc. For example Ram a/c, Shayam and Sons a/c, State Bank of India a/c. A business may have many credit transactions with the above persons or organizations. A separate account is to be prepared for each of them. Persons or organizations with whom the business has credit transactions are either debtors or creditors. If they have to give some money to the firm, they are called debtors. Conversely, if the firm is to pay them some money they are known as creditors. The main purpose of preparing personal accounts is to ascertain the balances due to or due from persons or organizations.

Personal accounts can be classified into following three categories:

(a) Natural Person Personal Account: The term 'natural person' means persons whoa recreation of God. For example: Prachi Account, Revti Account, Naveen Account etc.

- (b) Artificial Person Personal Account: These are accounts of corporates, institutions etc. For example: Bank of Baroda Account, LIC Account etc.
- (c) Representative Person Personal Account: These accounts represent a certain person or groups of persons. For example salary due to employees are termed as 'outstanding salary' account, income due not received is termed as 'accrued income' account etc.
- **2. Real Accounts:** Real accounts are of a tangible nature, that is, the items which can be physically possessed. These accounts are accounts of assets and properties such as land, building, plant, machinery, patent, cash, investment, inventory, etc. When land is purchased for cash, the two accounts involved are land and cash both are real accounts. But if the same land is purchased from Shyam & Co. on credit, the two accounts involved will be those of land and Shyam & Co., the former being a real account and the latter being a personal account.
- **3. Nominal Accounts:** Nominal accounts are accounts of intangible nature, that is, accounts of items that are not visible or cannot be touched. These are the accounts of incomes, expenses, gains and losses. Examples of nominal accounts are rent paid, salary paid, discount allowed or received, etc. These accounts generally accumulate the data required for the preparation of income statement or trading and profit and loss account.

(B) Modern Classification of Accounts:

Modern accountants classify accounts as follows:

1. Asset Account: Assets are properties or things of value, such as cash, equipment, copy rights, buildings, and land owned and controlled by an economic unit or business entity. These account are used to record all types of assets like building, machinery, computer, vehicles and others assets. Assets are balance sheet items and can be brought forward to the next period. They are tangible objects or intangible rights owned by an enterprise and carrying probable future benefits. Assets may be classified as:

Fixed Assets: These are assets acquired for relatively long period for carrying on the business of an enterprise. Examples are land, building, machinery etc.

Current Assets: These are assets acquired with the intention of converting them into cash during the normal business operation of an enterprise. Examples are cash, inventory, bills receivables etc.

Liquid Assets: These assets are also termed as 'floating assets' or 'circulating assets'. Examples are all current assets excluding prepaid expenses and inventories.

Fictitious Assets: These are assets that have no real value but are shown in the books of accounts only for technical reasons. Examples are preliminary expenses.

Wasting Assets: These are assets which are exhausted with or which lose themselves in the goods they produce. For example mines, etc.

2. Liabilities Account: In this account all types of liabilities like loan given by borrowers, expense payable, good purchased on credit are recorded. Liability is also a Balance sheet item and can be brought forward to next period. These are used to denote amount which a business owes and has to return or account for. Liabilities can be divided into two categories:

Current Liabilities: The liabilities which will be due within a short time. Examples are bills payables, outstanding expenses etc. These are generally paid out of current assets.

Fixed Liabilities: Liabilities that will not due for a comparatively long time are termed as 'fixed liabilities'. Examples are long term loans, debentures, etc.

3. Capital Account : Capital is owners' equity in the business. It is the residual claim against the assets of the business after the total liabilities are deducted. Capital may be classified as:

Fixed Capital: This is capital invested in or represented by fixed assets.

Circulating Capital: It is capital in the form of current or floating assets.

Working Capital: It is excess of current assets over current liabilities.

- **4. Revenue Account :** Revenue or Income accounts are used to record income earned during the year like sale of goods, interest earned on saving account, rent earned from property etc. Whenever income is earned this account is always to be credited. Revenue is the income of a recurring nature from any source.
- **5. Expenditure Account:** Expenditure accounts are used to record all type of expense incurred during the accounting period. Expenditure may be of following types:

Capital Expenditure: Expenditure incurred for obtaining a long term advantage for the business

Revenue Expenditure: Expenditure where benefits expire within a year or which has been incurred merely to maintain the business or keep the assets in good working condition.

Deferred Expenditure: Expenditure for which payment has been made or incurred ut which is carried forward on the presumption that it will be of benefit over a subsequent period (s).

2.6 LET US SUM UP

In order to maintain uniformity and consistency in preparing and maintaining books of accounts, certain rules or principles have been evolved. The basic rules are summarised as 'generally accepted accounting principles'. Accounting principles are basic norms and assumptions on which the whole accounting system has been developed an established. Accounting principles are classified as concepts and conventions. Accounting concept defines the postulates i.e. necessary assumptions on the basis of which financial statements of a business entity are prepared. Accounting conventions are customs or traditions. These are a guide to the preparation of accounting statement. The accountancy bodies of the world may change any of the convention to improve the quality of accounting information. To apply the fundamental concepts, the accountants have developed certain methods which are also known as accounting bases. There is a wide range of measurement methods that are available to entities for the preparation of their financial statements. Accounting policies are the specific accounting bases judged by business enterprises to be most appropriate to their circumstances and adopted by them for the purpose of preparing their financial accounts.

2.7 KEY WORDS

3.0 OBJECTIVES

3.1 INTRODUCTION

After reading first two lessons it is clear now that accounting is a systematic method (it follows rules) of recording the economic transactions of a business so that the information can be used by both insiders (owners and managers) and outsiders (investors, suppliers and creditors) to make financial decisions. The overall accounting process comprises of identification of financial transactions, preparation of vouchers, recording entries in the books of original entry, posting to ledger, preparation of trial balance and financial statements and communication of the financial information of the organisation to the interested users.

Accountant should follow the accounting process properly to avoid any confusion or error while recording the financial transaction. This will help in the efficient functioning of financial activities of an organisation. This chapter deals with the first step of the recording aspect of the accounting process i.e. origin of transaction source, documents and vouchers. Then it covers the identification of the appropriate account

and application of the rules of debit and credit. The lesson will also deal with formation of the accounting equations.

3.2 ORIGIN OF TRANSACTION SOURCE DOCUMENTS

Accounting deals with the facts which can be verified by source documents. Source documents can be defined as an accounting terms to describe the original records that contain the details that substantiate the financial transactions that are entered into the internal accounting system of a business. In simple terms, source document is a document which becomes the basis for recording a transaction in the books of account. These documents provide the documentary evidence of a business deal or accounting event and are a critical part of an audit trail that establishes the authenticity and tracking history of an accounting system's financial records. Thus, source document acts as a written documentary evidence of the transaction that has taken place.

Source documents are real, visible, legible and meaningful records certifying the actual happening of the transactions of financial nature. In accountancy, every journal entry must be supported by source documents. So, there must be a source document for each entry to be recorded in the books of accounts. Thus, we can say that the authenticity and accuracy of the transaction can be verified with the help of source documents. These documents show the nature of the transaction and amount involved in the transaction. Even for internal events like depreciation charged, materials issued to production department for manufacturing of finished goods, the source documents are prepared. Source documents contain the following information:

- Date of transaction.
- Names and addresses of parties involved in the transaction.
- Description of the goods or services.
- Amount involved.
- Terms and conditions related to trade discounts, cash discount and other details related to delivery.
- Signature of the concerned parties.

A source document in a manual accounting system is a paper form, docket or note which records details of a transaction and provides evidence that the transaction took place. Source documents serve following **purposes:**

- They form inputs into the accounting system so that the transactions they record can be entered into the first of the accounting record i.e. journal.
- They assist internal control of the resources of the business making sure that there is documentary evidence to support the purchase or sale of items and the receipt and payment of money (that is, it makes it more difficult for people to misappropriate or steal cash or other items).
- These source documents are also required by both company and tax auditors.
- The details from the source document are recorded in the appropriate accounting journal after the transaction has occurred. After recording, all source

- documents are filed away in a document system where they can be retrieved at a later date if required.
- They are required in order to comply with the government tax law which requires that these source documents are kept for a number of years (typically from 3-7years depending on the country). In the event of an audit, these source documents should support the data.

Following are the various types of source documents:

1. Cash Memo. Cash memo is a document that a seller passes to a buyer at the time of a specific purchase of goods or services. It indicates the amount, date and details of cash purchases and cash sales. We receive cash memo on cash purchases and issue cash memo on sales. On the basis of these cash memos, cash purchases, cash sales and cash payments are recorded in the books.

A cash memo contains the following information:

- Name and address of the supplier.
- Name and address of the purchaser.
- Serial Number of cash memo.
- Date of cash memo.
- Customer or Purchaser's Order number.
- Description of goods.
- Quantity of goods.
- Rates of Goods.
- Amount involved.
- Discount
- Sales Tax number of purchaser and supplier in case of sale of goods.
- Service tax number of the supplier in case of sale of services.
- Total amount of cash memo must be written in words and figures.
- The cash memo must be signed by the duly authorized person.
- The area of Jurisdiction must be defined in cash memo.
- Normally, E. & O. E. also printed on all cash memos. It means if there is any mistake in cash memo that is subject to correction.

The cash memo is made in duplicate but according to the requirement of business firm more than two copies also can be prepared. Following is a format of cash memo:



2. Invoices and Bills. Invoice and bills are used for credit purchases and credit sales. In case of credit sale of goods invoices/bills are issued, which indicate the date, amount and details of sale. Normally, three copies of invoice are made. The first copy is given to purchaser or sent to the purchaser through post office or bank. The second copy is kept in the bundles, packets or cases of the goods and vendor retains the third copy. This third copy is used as source document for recording credit sale. In case of credit purchases of goods, the buyer receives invoice or bills and record credit purchases on its basis.


There are many similarities between cash memo and invoice/bills. The content of both cash memo and invoice are same. A cash memo is recognized as a legal document, in the same way that an invoice is. The only difference is that the cash memo is for any transaction that is paid for in cash. It is a document stating cash received for the goods sold. It is a paid bill for cash sales. An invoice can also be used in this respect, but many companies find it easier to differentiate between cash sales and credit sales. An invoice is a document showing the amount due from the buyer or the debtor it is a bill for credit sale. Further, cash memo does not create creditor debtor relationship between the seller and the buyer. Invoice creates creditor debtor relationship between the seller and the buyer. In accountancy while recording transactions cash memo is entered in the

cash book of the seller. Invoice is the basis for making entries in sales book and purchase book. In case of Cash memo, one revenue stamp is to be affixed if the cash receipt exceeds Rs.500/- (In India) but in case of an Invoice, there is no need to affix a revenue stamp.

3. Receipt. Receipt is a written acknowledgment of having received, or taken into one's possession, a specified amount of money, goods, etc. It indicates the date and amount of payment, details of the payer and the purpose of payment. The counterfeit or the carbon copy of the receipt issued is used as source document for the receipt of the amount. In the same way, when any payment is made, the issued receipt is used to record the payment in the books of accounts.


4. Pay-in-Slip. Pay-in-slip (Deposit slip) is a slip which a person can use to deposit his money or cheque in his bank account. A pay in slip needs to be filled in any a deposit of cash or cheque is made in bank account. The main body of the Pay-in-Slip is retained by the bank and the counterfeit duly signed and stamped is returned to the customer. The counterfoil is used as the source document for recording the deposits.




5. Cheques. Cheques are issued against different payments. The counterfoil of the cheque or notes on the cheque book containing details of the payment is used for recording the payment or withdrawal for self. Cheques received are deposited into the bank through Pay-in-Slip, which is used as source document.



6. Debit Note. In case the goods purchase don credit are returned, a Debit Note is issued to the seller, meaning that the Sellers' Account has been debited with the amount of purchases return. This debit note is used as source document for recording purchase return. A format of Debit Note is given as under:



7. Credit Note. In case customer returns goods sold to him, then a Credit Note is issued to him. It means that the customer's account is credited with the amount of sales return. The Credit Note is used as source document. A format of Credit Note is given as under:



8. Miscellaneous. Correspondence, registration deeds, wages, salaries, water, electricity, telephone bills, tickets, conveyance bills, counterfoils and receipts, etc. are also used as source documents.

The source document may be created in either paper or electronic format. For example, automated accounting systems may generate the source document electronically or allow paper source documents to be scanned and converted into electronic images. Accounting software often provides on-screen entry forms for different types of transactions to capture the data and generate the source document. The source document is an early document in the accounting cycle. It provides the information required to analyse and classify the transaction and to create the journal entries.

3.3 VOUCHERS

A voucher is a written document to be used in support of entry made in the books of accounts. According to *J.R. Batliboi*, "A voucher may be defined as documentary evidence in support of an entry appearing in the books of accounts". According to

Ronald A. Irish, "A voucher may be a receipt, an invoice, an agreement, written requisition slip or in short any suitable written evidence, which confirms a written transaction." Following are the features of a voucher:

- (i) Vouchers are documentary evidence.
- (ii) Vouchers are written document.
- (iii) Vouchers support the entry appearing in the books of accounts.
- (iv) Vouchers present full description of the transaction.
- (v) Vouchers substantiate the accuracy of entries in the books of accounts.

3.4 ACCOUNTING EQUATIONS

As per the dual concept 'for every debit, there is a credit'. Every transaction should have two-sided effect to the extent of same amount. This concept has resulted in accounting equation. Accounting equation states the equality of debits and credits. The left side of the equation represents Assets (Debit) and right side represents Liabilities and Owners' Equity (Credit). The relationship of assets on the left side and liabilities and owners' equity on the right side in the equation form is known as 'Accounting Equation' as given below:

Assets (A) = Liabilities (L) + Owners' Equity (E)

The above equation can be stated in any of the following forms:

```
A = L +E
or A - L = E
or A - E = L
or A - L - E = 0
```

Since the components of balance sheet are depicted in the accounting equation, it is also called as 'Balance Sheet Equation'. The owners' equity represents the amount invested by owners in the business plus retained earnings.

Assets: As discussed in the previous lesson assets are economic resources of a company. They are owned by the company and have cash value or can be converted to cash. Bank accounts, receivables (money owed to the business by customers), supplies, inventory, equipment, buildings and land are typical assets for most businesses.

Liabilities: Liabilities are the debts of the business, the money owed to various creditors, or payables. They include bank loans, mortgages, and payables to vendors

that supply goods and services to the business or to various government agencies for tax liabilities.

Equity: Equity is defined as residual ownership i.e. what's left from the assets after all creditors have been paid. In other words equity is assets minus liabilities. Equity includes capital contributed by the owners, plus any amounts of surplus income from doing business or less any losses from previous business periods. Assets are equal to the liabilities plus equity, the sources of the assets.

Let us consider the facts of the following case, step by step, to understand as to how the equation remains true even in changed circumstances.

Illustration 1

- 1. Started business with cash Rs. 5,00,000
- 2. Bought goods for cash Rs. 1,20,000 and on credit Rs. 1,30,000
- 3. Goods sold for cash Rs. 70,000
- 4. Rent paid Rs. 10,000
- 5. Bought computer for Rs. 25,000 on credit
- 6. Bought furniture for personal use Rs. 20,000
- 7. Sold goods to Ram for Rs.20,000
- 8. Salary paid Rs.20,000

3.5 RULES OF DEBIT AND CREDIT

As discussed in lesson 2 an account is a summary of the relevant transactions at one place relating to a particular head. It records not only the amount of transaction but also their effect and direction. These accounts are of three types:

- (1) Personal Accounts
- (2) Nominal Accounts
- (3) Real Accounts

Depending on the type of accounts there are certain rules which help in recording the transaction in the books of accounts. These are popularly known as 'The Golden Rule of accounting'.

Before we move on to the 'Golden Rule of Accounting' let us first understand the double entry book-keeping system. The double entry book-keeping system is a systematic record keeping methods of all financial transactions of an organisation. It emphasises the fact the every transaction has two aspects i.e. every transaction affects at least two accounts. The basic principle is every debit has a credit and every credit has a debit. As per accounting equation also the total amount debited to the records must be equal to the total amount credited.

These golden rules of accounting provide how the duality aspect of transactions is to be recorded in the books of accounts. These rules are –

The terms, debit and credit, in accounting indicate whether the transactions are to be recorded on the left hand side or right hand side of the account. Every transaction involves give and take aspect. The debit represents take aspect and credit the give aspect in a transaction. For example, when furniture is purchased for cash, then

furniture represents take aspect and cash represents give aspect. Thus, furniture is debited and cash is credited. Let us take following example to explain the above rules:

Illustration 4:During the month of April 2014, ABC Ltd. has made the following transactions –

Analysis of Transactions

April 1: Commenced business with cash Rs.50,00,000.

Cash is an asset, a real account. Rule of real accounts say Debit what comes in and credit what goes out. Here cash is coming in so Cash is debited.

Cash is given by the Ram, a personal account. Rule of personal accounts say Debit the receiver and credit the giver. Here Ram is giver so Ram's capital account is credited.

Cash is given by shareholders. Cash comes in — Cash A/c is debited and shareholder *April 2 : Purchased machinery worth Rs.5,00,000 from XYZ & Co.*

Machinery is a real account and it comes in. So, Machinery A/c is debited

XYZ & Co. is a personal account and they are giver. So, XYZ & Co. A/c is credited

April 3: Purchased furniture worth Rs.50,000 from Rohit & Co.

Purchasing of furniture is a real account and is coming in. So, furniture A/c is debited Rohit & Co. is a personal account and is giver. So, Rohit & Co. A/c is credited.

April 4: Paid rent of the building Rs.20,000

Rent is an expense, a nominal account. The rule of nominal account says debit all expenses and losses and credit all incomes and gains. Here, rent is an expense therefore, it should be debited.

Cash is paid and it is a real account which goes out and it should be credited.

April 5 : Sold goods worth Rs.20,000

Sale of goods resulted in goods going out, hence, credited.

Cash is a real account and is coming in so Cash A/c should be debited.

April 6: Sold goods to Hira Lal for Rs. 50,000

Here goods are going out, hence credited.

Hira Lal has received the goods and is a personal account. So Hira Lal A/c is debited.

April 7: Paid cash to XYZ & Co. Rs. 5,00,000

Here cash is a real account and it is going out. So, Cash A/c is credited.

XYZ & Co. is receiving cash. It is a personal account thus XYZ Ltd. is debited.

April 8: Withdraw goods for personal use worth Rs.10,000

Here goods are going out. Hence, goods A/c are credited.

Goods are withdrawn for personal use. Owner, a personal account, is receiving goods.

Hence, drawings A/c is debited.

Hence, these rules of debit and credit helps in deciding about correct posting of the account at right and left side of the financial statements.

3.6 Let Us Sum Up

Accounting is a process to systematically evaluate and take events and transactions into consideration in determining the organisation's financial statements at the end of each accounting period. The first step in this process is to identity the transaction on the basis of origin source of document, such as cash memo, invoice, debit note, credit note, bill, cheque, receipt etc. The source document may be created in either paper or electronic format. For example, automated accounting systems may generate the source document electronically or allow paper source documents to be scanned and converted into electronic images. Accounting software often provides on-screen entry forms for different types of transactions to capture the data and generate the source document. The source document is an early document in the accounting cycle. It provides the information required to analyze and classify the transaction and to create the journal entries. The next step is to identify the account i.e. whether personal account, real account or nominal account. The rules of debit and credit are then applied to understand whether the account is to be posted on the right side or on the left side of the financial statements.

4.0 OBJECTIVES

4.1 INTRODUCTION

As discussed in previous lesson the source documents if the first step in recording the accounting transactions. When the source document is received the next step of recording is done. The transactions are recorded in the books of original entry i.e. journal. Since, the transactions are recorded first time, it is called book of original entry. Journal records all daily transactions of a business into the order in which they occur.

4.2 BOOKS OF ORIGINAL ENTRY-JOURNAL

After obtaining the source document, as discussed earlier, is received the transaction is recorded in the books of original entry. The book in which the transaction is recorded

for the first time is called journal or book of original entry. The word journal is derived from a French word 'jour' which means a daily, day book or log book. These transactions are recorded in chronological order i.e. in order of dates, as and when they take place. So a journal can be defined as a book containing a day-to-day record of transactions. The journal is prepared with the help of memorandum or waste book, which is a rough and temporary record of the financial transactions of the business. The literal meaning of the journal is a record of day-to-day financial transactions. The journal is an important book under the double-entry system. Journal is the first book of systematic record of the financial transactions of the business.

According to Carter "The journal as originally used, is a book of primary entry in which transactions are copied in order of dates from a memorandum or waste book. The entries as they are copied are classified into debit and credit so as to facilitate their being correctly posted afterwards in the ledger."

Maheshwari and Maheshwari defines journal as "a book containing a chronological record of transactions. A journal does not replace but precedes the ledger." Thus, journal helps in preparation of ledger.

The act of entering the transaction into journal book is called entry and registering transaction is called journalizing. It just specifies account to be debited and credited. In the following paragraphs, we will discuss the process of journalizing and posting the transactions. There are few types of transactions which occur repetitively in the business. For economic reasons, instead of recording all the transactions in journal, the similar transactions are recorded separately in subsidiary books.

Objectives of the Journal

The following are the main objectives of the journal

- * Journal is prepared to keep a systematic record of financial transactions.
- * It shows financial transactions in chronological order.
- * It presents necessary information about the financial transactions. Adequate explanation of each entry may be obtained from journal as every journal entry is supported by narration.
- * Journal is prepared to use as a legal evidence of financial transactions.
- * It facilitates the preparation of ledger book. The use of journal simplifies ledger.
- * Journal helps in solving misunderstanding and disputes in the business.

Importance & advantages of journal

- Transactions in the journal are recorded on chronological order so there's less chance to leave the transaction un-entered.
- It ensures the adoption of double entry system.

- The transactions recorded in the journals with details of the account debited and credited and the amount of each transaction.
- From journal adequate explanation of each entry may be obtained as every entry in journal is supported by the narration relating to that transaction.
- The use of journal simplifies ledger as details regarding the business transaction and are not required to be noted down in the ledger.
- From legal point of view, journal is more reliable evidence of business transactions than the ledger.

Journalizing:

The process of recording transactions in the journal is called **journalizing**. Each transaction is separately recorded after determining the particular accounts to be debited and credited.

Following are the steps followed in journalising business transactions:

Step 1 Ascertain what accounts are involved in a transaction.

Step 2 Ascertain what is the nature of the accounts involved i.e. whether it is personal account, real account or nominal account..

Step 3 Ascertain which rule of debit and credit is applicable for each of the accounts involved (see rules of debit and credit in lesson 3).

Step 4 Ascertain which account is to be debited and which is to be credited.

Step 5 Record the date of transaction in the 'Date column'. As discussed earlier the transactions are recorded in chronological order.

Step 6 Write the name of the account to be debited, very close to the left hand side i.e. the line demarcating the 'Date column' and the 'Particulars column') along with the abbreviation 'Dr.' on the same line against the name of the account in the 'Particulars column' and the amount to be debited in the 'Debit Amount column' against the name of the account.

Step 7 Write the name of the account to be credited in the next line preceded by the word 'To' at a few spaces towards right in the 'Particulars column' and the amount to be credited in the 'Credit Amount column' against the name of the account.

Step 8 Write 'Narration' (i.e. a brief description of the transaction) within brackets in the next line in the 'Particulars column'.

Step 9 Draw a line across the entire 'Particulars column' to separate one Journal entry from the other.

The columns of the Journal are explained below:

Date Column: The first column in a journal is date column which shows the date on which the transaction recorded against it took place.

Particulars' Column: The particulars column the account to be debited is written in the first line starting from the left hand corner of this column. In the second line the account to be credited is written leaving sufficient margin on the left side

Ledger Folio: At the time of the posting to the ledger, we need to write the Ledger Folio (in the computerized accounting the traditional ledger folio is referred to as Reference Number. Besides each account has its code number). The ledger folio (LF) column in the manual system of accounting is filled in at the time of posting of these transactions in ledger only. Thus the ledger folio shows the folio number of ledger where the transaction is posted.

Narration: After writing these two accounts, within the brackets a brief explanation of the transaction (also called narration) is given. The explanation can be in simple words and there is no need to start the narration with the word being which a practice was earlier. The journal provides date wise complete record of transactions along with the documentary evidence available to prove the occurrence of the transactions.

Debit Column: In the debit column, the amount to be debited is entered.

Credit Column: In the credit column, the amount to be credited is shown.

Some examples of journalizing the transactions are given below:

Illustration 1. Journalize the following transactions:

Transaction 1: On 1 April 2014 Mr. Raj commenced business with Rs.1,00,000.

Transaction 2: On 2 April 2014 Mr. Raj purchased goods for Rs. 35,000 for cash.

Transaction 3: On 30 April 2014 paid Rs. 2300 as rent of the office.

Transaction 4: On 3 May 2014 purchased furniture for Rs. 4,000.

Transaction 5: On 8 May 2014 sold goods for Rs.18,000 for cash.

Transaction 6: On 10 May 2014 Deposited in bank account opened in the name of business Rs.15,000.

Transaction 7: Purchased goods on 11 May 2014 from Gill & Co. on credit for Rs. 3,000.

Solution:

Transaction 1: On 1 April 2014 Mr. Raj commenced business with Rs.1,00,000.

In this transaction Mr. Raj started business with cash Rs.1,00,000. Raj is a personal account, a giver, so Raj's Capital A/c it will be credit. Cash is a real account, it is coming in, so Cash A/c will be debited.

Transaction 2: On 2 April 2014 Mr. Raj purchased goods for Rs. 35,000 for cash.

In this transaction, goods are purchased for Rs.35,000. Goods are purchased, a real account, it is coming in, so Purchase A/c will be debited. Cash is a real account, it is going out, so Cash A/c will be credited.

Transaction 3: On 30 April 2014 paid Rs. 2300 as rent of the office.

In this transaction the office rent is paid Rs.2300. Office rent is an expense, a nominal account, so Rent A/c is debited. Cash is going out, a real account, so Cash A/c will be credited.

Transaction 4: On 3 May 2014 purchased furniture for Rs. 4,000.

In this transaction furniture is purchased for Rs.4,000. Furniture is an asset, a real account, it is coming in, so Furniture A/c will be debited. Cash, a real account, is going out, so, Cash A/c will be credited.

Transaction 5: On 8 May 2014 sold goods for Rs.18,000 for cash.

In this transaction, goods are sold. Goods are going out, these are sold so Sales A/c will be credited. Cash is coming in, a real account, so Cash A/c will be debited.

Transaction 6: On 10 May 2014 Deposited in bank account opened in the name of business Rs.15,000.

In this transaction, the cash is deposited in bank. Bank is a personal account, it is a receiver, so Bank A/c will be debited. Cash is going out of a business, so Cash A/c will be credited.

Transaction 7: Purchased goods on 11 May 2014 from Gill & Co. on credit for Rs. 3,000.

In this transaction, goods are purchased on credit basis. Goods is a real account, purchased, i.e. coming in, so Purchase A/c is debited. Goods are purchased from Gill & Co., a creditor, a personal account. Gill & Co. is giver, hence Gill & Co. A/c is credited.

COMPOUND ENTRY:

A compound journal entry is an accounting entry which affects more than two account heads. A simple journal entry has one debit and one credit whereas a compound journal entry includes one or more debits and/or credits than a simple journal entry. A compound journal entry may combine two or more debits and a credit, or a debit and two or more credits, or two or more of both debits and credits.

The compound/combined entries should not be interpreted to mean that more than two elements are affected in a single/simple accounting transaction. A compound/combined entry is a journal entry derived by combining two or more simple journal entries. The compound/combined entry can always be broken down into the constituent simple journal entries. Writing a compound/combined entry in place of two or more simple entries reduces the task involved in recording the transactions.

Example

The following examples illustrate the format of a compound journal entry:

Example 1: On Jan 1, 2014 Sohan Lal purchased a computer costing 50,000 from a supplier and issued a cheque of Rs.30,000. Balance amount to be paid after three months. This will be recorded as shown below:

4.3 IMPORTANT CONSIDERATIONS FOR RECORDING THE BUSINESS TRANSACTIONS

1. Goods Accounts:

In accounting the meaning of goods is restricted to only those items which are purchased by a businessman with an intention to sell it. For example, if a businessman purchase car for office and he himself deals in stationery items then stationary items will be goods and this car is the asset of business. Goods account can be subdivided into four different parts:

Purchases Account: This is opened for goods purchased on cash and credit.

Sales Account: This account is opened for the goods sold on cash and credit. Purchase Returns Account or Return Outward Account: This account is opened for the goods returned to suppliers.

Sales Returns Account or Return Inward Account: This account is opened for the goods returned by customers.

Illustration: 2 Ram started business with cash Rs.5,00,000. He purchased goods worth Rs.2,00,000 from Sampat. He found that 10% of the goods were not as per order so he returned those back. He sold goods costing Rs.1,00,000 for Rs.1,35,000 to Hira Lal. Hira lal returned 10% of the goods being not upto mark.

Transaction 1: Ram started business with cash Rs.5,00,000.

In this transaction Ram started business. Ram is a personal account, a giver, so Ram's Capital A/c will be credited. Cash, a real account, is coming in business, so Cash A/c will be debited.

Transaction 2: He purchased goods worth Rs.2,00,000 from Sampat.

In this transaction, Ram purchased goods on credit. Goods are coming in so Purchases A/c will be debited and Sampat is creditor, a personal account. He is giving the goods so Sampat A/c will be credited.

*Transaction 3:*He found that 10% of the goods were not as per order so he returned those back.

Here Ram returned 10% goods i.e. goods for Rs.20,000 were returned. A new account Purchases Return will be created. Goods returned means goods are going out so Purchases Returns A/c will be credited and Sampat A/c will be debited.

*Transaction 4:*He sold goods costing Rs.1,00,000 for Rs.1,35,000 to Hira Lal.

In this transaction Ram sold goods on credit. Goods are going out, so Sales A/c will be credited. Hira Lal is receiving the goods, since Hira Lal is a personal A/c, he is receiving goods so Hira Lal A/c will be debited.

*Transaction 5:*Hira lal returned 10% of the goods being not upto mark.

Hira Lal returned 10% goods i.e. sales return for Rs. 13500. So here goods are coming back, Sales Return A/c will be debited. Hira Lal is giving the goods, a personal account, so Hira Lal A/c will be credited.

2. Trade Discount

A trade discount is the amount by which a manufacturer reduces the retail price of a product when it sells to a reseller. Trade discount is usually allowed on the list price of the goods. It may be allowed by producer to wholesaler and by wholesaler to retailer for purchase of goods in large quantity. It is not recorded in the books of account and entry is made only with the net amount paid or received. If the seller were to record the retail price as well as a trade discount on an invoice to a reseller, this would create an unusually high gross sales amount in the income statement that might mislead any readers of the financial statements into thinking that the manufacturer has higher sales volume than is really the case (despite the presence of a large sales deduction for the trade discount). For example purchased goods of list price Rs. 8,000 at 10% trade discount from Vendor. In this case the following entry will be passed:

3. Cash Discount

Cash discount is paid by seller to buyer. It is a discount that is allowed to encourage early cash payment. It is a Nominal Account. The person who allows discount, treat it as an expense and debits in his books and it is called discount allowed and the person who receives discount, treat it as an income and it is called discount received and credited in his books of account as "Discount Received Account." For example, Amit owes Rs. 7,200 to Vendor. He pays Rs. 7,000 in full settlement against the amount due. In the books of Amit, the journal entry will be:

4. Goods distributed as free samples

In business activities sometimes the goods are distributed as free samples with the purpose of advertisement. The purchases account will be reduced to adjust such activities. In this case, Advertisement Account is debited and Purchases Account is credited. For example, goods costing Rs. 5000 were distributed as free sample. Following entry will be passed to record this transaction:

5. Interest on capital

When owner contributes capital in business then the business also pays interest on capital as a reward to the owner for his contributions. Interest paid on capital is an expense. Therefore as per rule of the nominal account, the interest on capital account should be debited. On the other hand the capital of the business increases. So the capital account should be credited. The following entry will be passed in journal:

6. Interest charged on Drawings

Like interest on capital is paid for contribution of capital similarly, interest on drawings are charged when the owner withdraw goods or cash from the business for his personal use (i.e. drawings). If the interest is charged on drawings then it will be an increase in the income of business, and as per rule of the nominal account the interest on drawings will be credited. On the other hand there will be increase in drawings or decrease in Capital. So Drawings Account will be debited. To record this, following entry will be passed:

7. Depreciation charged on Fixed Assets

Depreciation is the gradual, permanent decrease in the value of an asset due to wear and tear and many other causes. Depreciation is an expense and as per rule of nominal account it will be debited and particular asset will be reduced. Suppose 10% depreciation is charges on furniture account. Furniture was worth Rs.1,00,000. So 10% depreciation will be mean Rs.10,000/-. Following entry will be passed to record this effect:

8. Bad Debts

Bad debt occurs when a debtor of business fails to pay the amount due from him. Reasons may be many e.g. he may become insolvent or he may die. Such irrecoverable amount is a loss to the business. As per rule of the nominal account the bad debts will be debited. Suppose 2% of the total debtor of Rs.50,000 becomes bad. Following entry will be passed:

9. Bad Debts Recovered

When any amount becomes irrecoverable from any costumer or debtor his account is closed in the books. If in future any amount is recovered from him then his personal account will not be credited because that does not exist in the books. Suppose as given in above case the bad debts were for Rs.1,000. The account was closed in books and then the payment was given by this person. Following entry is passed:

11. Loss of Goods by Fire/Accident/theft

Sometimes, a business may suffer loss of goods on account of fire, theft or accident. It is a business loss and a nominal account. It also reduces the goods at cost price, and increases the loss/expenses of the business. In case the goods are insured and insurance company admits claim, then the loss will be reduced accordingly. If the insurance company admits full claim then the insurance company account will be debited and the purchases account will be credited. If the insurance company admits no claim then the Loss by fire/accident account will be debited and the purchase account will be credited. If the insurance company admits partly then the following entry will be passed:

12. Income Tax Paid

Business has to pay income tax on the net income earned by it. Income tax paid is an expense and as per rule of nominal account it should be debited. In case of sole proprietor or partnership firm, income tax paid should be debited to Capital Account or Drawings Account and credited to Cash Account. In case of company income tax is debited and cash account is credited. The following entry is passed:

17. Accrued Income

Income which has been earned but not yet received is known as accrued income. Income must be recorded in the accounting period in which it is earned. Therefore, accrued income must be recognized in the accounting period in which it arises rather than in the subsequent period in which it will be received. Let us take an example to understand the accounting entry to record accrued income:

Ram & Co. receives interest of Rs.10,000 on bank deposit for the month of March 2014 on $3^{\rm rd}$ April 2014.

Ram & Co. will recognize interest income of Rs.10,000 in the financial statements of year 2014 even though it was received in the next accounting period as it relates to the current period. Following accounting entry will be passed:

18. Outstanding Expenses

Outstanding expenses are those expenses which are due but not yet paid. At the time of making financial statement, we pass its adjustment journal entry.

Opening Entry

Opening entry is a journal entry by means of which the balances of various assets, liabilities and capital appearing in the balance sheet of previous accounting period are brought forward in the books of the current accounting period. While passing an opening entry, all assets accounts (individually) are debited and all liabilities accounts (individually) are credited and the Net worth (i.e. excess of assets over liabilities) is credited to Proprietor's Capital Account (in case of a proprietary concern) or Partners' Capital Accounts (in case of a partnership concern). If the balance of assets is more as compared to liabilities then the balancing figure is capital account. If the balance of liabilities is more than the balance of asset then the balancing figure is transferred to goodwill account.

Illustration 3 On Ist April 2014, Amit's assets and liabilities stood as follows:

Assets: Cash Rs. 10,000; Bank Rs. 25,000; Stock Rs. 30,000; Bills Receivable Rs. 5,000; Debtors Rs. 30,000; Building Rs.7,00,000; Investments Rs. 3,00,000; Furniture Rs. 40,000 Liabilities: Bills payable Rs. 15000, Creditors Rs. 19000, Mrs. Amit's Loan Rs. 1,30,000.

Pass an opening Journal entry.

Solution:

4.4 SPECIAL PURPOSE JOURNAL

Special journals are records of original entry other than the general journal that are designed for recording specific types of transactions of similar nature. Special journals are used to make recording and posting frequently occurring transactions more efficient. These are customized to fit the needs of each business. Posting from special journals occurs differently from the General Journal. Any amounts affecting a customer or creditor are posted immediately from the special journal to the appropriate account in the Accounts Receivable or Accounts Payable subsidiary ledger.

Following are the advantages of special journals:

- (1) their use permits a division of labor
- (2) they save time in posting from the journals to the general ledgers
- (3) they reduce recording time and errors.

Most firms use at least the following special journals:

- (a) Purchases
- (b) Sales/Revenue
- (c) Cash Receipts
- (d) Cash Payments

(a) PURCHASES JOURNAL

The Purchases Journal is used to record any purchase on account. The purchase invoice or receipt is the source document for recording the purchase. When using a Purchases Journal, follow these steps:

- 1. Post to the creditor accounts in the subsidiary ledger from the Purchases Journal immediately. This will increase the balance in the creditor account.
- 2. Post any entries affecting another account immediately.
- 3. Total and cross-foot the journal at the end of the month.
- 4. Post the column totals for the Purchases Journal at the end of each month.

Each account is posted according to its column heading. The total of the Other Accounts column is not posted since these amounts have already been posted individually. Place the account numbers under each column to show the column totals have been posted.

(b) REVENUE/SALES JOURNAL

The Revenue/Sales Journal is used to record providing a service (Revenue Journal) or product (Sales Journal) on account. The sales invoice or receipt is the source document for recording these transactions. When using a Revenue/Sales Journal, follow these steps:

- 1. Post to the individual customer accounts in the subsidiary ledger immediately. This will increase the balance in the customer account.
- 2. Total and cross-foot the journal (if necessary) at the end of the month.
- 3. Post the column totals at the end of each month. Debit Accounts Receivable and Credit the revenue account. Place the account numbers under each column to show the column totals have been posted.

(c) CASH RECEIPTS JOURNAL

The Cash Receipts Journal is used to record any receipt of cash. When using a Cash Receipts Journal, follow these steps:

- 1. Post any entries affecting another account immediately to the General Ledger. Place the account number in the PR column of the Cash Receipts Journal to show that this amount has been posted.
- 2. Total and cross-foot the journal at the end of the month.
- 3. Post the column totals at the end of each month. Each account is posted according to its column heading. The total of the Other Accounts column is not posted since these amounts have already been posted individually.

Place the account numbers under each column to show the column totals have been posted. A check mark is placed under the Other Account column to show that this total has been posted as individual amounts.

(d) CASH PAYMENTS JOURNAL

The Cash Payments Journal is used to record any payment of cash. When using a Cash Payments Journal, follow these steps:

- 1. Post any entries affecting another account immediately to the General Ledger. Place the account number in the PR column of the Cash Receipts Journal to show that this amount has been posted.
- 2. Total and cross-foot the journal at the end of the month.
- 3. Post the column totals at the end of each month. Each account is posted according to its column heading. The total of the Other Accounts column is not posted since these amounts have already been posted individually.

Place the account numbers under each column to show the column totals have been posted. A check mark is placed under the Other Account column to show that this total has been posted as individual amounts.

4.5 LET US SUM UP

Accounting process starts with the identification of financial transactions of a business. Such financial transactions are recorded permanently in the books of accounts systematically in different specialized books. These books of accounts are called journal. Journal is prepared to keep a systematic record of financial transactions in chronological order. Adequate explanation of each entry may be obtained from journal as every journal entry is supported by narration. Journal is prepared to use as a legal evidence of financial transactions. In order to avoid tedious work of recording all entries in general journal usually firms record similar types of entries in special journals. Special journals are used to make recording and posting frequently occurring transactions more efficient. These are customized to fit the needs of each business. After transactions are recorded in journal next step is to post the entries in ledger.

4.6 KEY WORDS

Journal: A Journal is a book in which transactions are originally recorded in the chronological order, i.e. in the order in which they are occurred, according to the principles of Double Entry System. A Journal is also called a Book of Original Entry or Prime Entry.

Journalizing: The process of recording transactions in the journal is called journalizing. Each transaction is separately recorded after determining the particular accounts to be debited and credited.

Special Journal: Special journals are records of original entry other than the general journal that are designed for recording specific types of transactions of similar nature.

Bad Debts: Bad debt refers to accounts receivable/debtors (or trade accounts receivable) that will not be collected. However, bad debts can also refer to notes receivable that will not be collected.

5.0 OBJECTIVES

5.1. INTRODUCTION

In the previous lesson we have understood the first step of accounting process i.e. how to record the financial transactions in the book of original entry-Journal. We have also covered the special journals. This lesson is devoted to the next step of accounting process i.e. posting of entries from journal to ledger.

In journal, all the business transactions are recorded irrespective of the nature of transactions. Journal records all transactions but fails to give a complete picture of what actually are the transactions with a particular account. Journal does not give a complete picture of the fundamental elements of book keeping i.e. properties, liabilities, proprietorship accounts and expenses and incomes at a glance and at one place. Business transactions being recurring in nature, a number of entries are made for a particular type of transactions such as sales, purchases, receipts and payments of cash, expenses etc., throughout the accounting year. The entries are therefore scattered over in the Journal.

In fact, the whole Journal will have to be gone through to find out the combined effect of various transactions on a particular account. Though the special journal tries to solve

this concern, but if special purpose journal is a solution then it means we have to make a number of journals as per the number of accounts the business is dealing in. There are many questions like how much is to be collected to debtors, how much is to be paid to creditors, what are total salaries paid to the staff and many more. This information is not easily gathered from the journal. Thus there is a need to summarise or group the transactions recorded in the journal related to a particular account, person, or a thing or expenditure to take managerial decisions. The mechanics of collecting, assembling and summarising all transactions of similar nature at one place can better be served by a book known as 'ledger' i.e. a classified head of accounts.

5.2 MEANING AND DEFINITION OF LEDGER

Ledger is a book of accounts in which data from transactions recorded in journals are posted and thereby classified and summarized. Ledger is a principal book of accounts of the enterprise. It is rightly called as the 'King of Books'. A ledger account is an account or record used to sort and store balance sheet and income statement transactions. Examples of ledger accounts include the asset accounts such as Cash, Accounts Receivable, Inventory, Investments, Land, and Equipment. Examples of the general ledger liability accounts include debtors, creditors, expenses, investments, sales, purchase, furniture account etc.

Ledger is a set of accounts. Ledger contains the various personal, real and nominal accounts in which all business transactions of the entity are recorded. The main function of the ledger is to classify and summarise all the items appearing in Journal and other books of original entry under appropriate head/set of accounts so that at the end of the accounting period, each account contains the complete information of all transaction relating to it. Here are few definitions of ledger:

"Ledger is a book of accounts which contains in a suitably classified form, the final and permanent record of trader's transactions." (V. G. Vickery)

"A ledger is the most important book of accounts and is the destination of the entries made in the subsidiary books." (William Pickles)

"Ledger is the permanent storehouse of all the transactions." (Fieldhouse Arther)

A ledger therefore is a collection of accounts and may be defined as a summary statement of all the transactions relating to a person, asset, expense or income which have taken place during a given period of time and shows their net effect. Ledger is bound book with pages consecutively numbered. It may also be a bundle of sheets.

Features of ledger

Following are the features of ledger:

- Ledger is an account book that contains various accounts to which various business transactions of a business enterprise are posted from book of original entry i.e. journal and special purpose journal.
- It is a book of final entry because the transactions that are first entered in the journal or special purpose Books are finally posted in the ledger.
- It is also called the Principal Book of Accounts.
- In the ledger all types of accounts relating to assets, liabilities, capital, revenue and expenses are maintained.
- It is a permanent record of business transactions classified into relevant accounts.
- It is the 'reference book of accounting system and is used to classify and summarise transactions to facilitate the preparation of financial statements.

Utility of a Ledger

Ledger contains all the accounts in which all the business transactions of a business enterprise are classified. At the end of the accounting period, each account will contain the entire information of all the transactions relating to it. Following are the advantages of ledger.

- Ledger provides detailed information about revenues and expenses at one place.
- Ledger records every asset separately. Hence, one can easily get the information about the book value of any asset whenever needed.
- The information given in different ledger accounts help the management in preparing budgets and to make relevant financial decisions.
- The businessmen always want to know what he owns and what he owe to it. The ledger accounts provide this information at a glance through the account receivables and payables.
- It provides complete information about all accounts in one book.
- It facilitates the preparation of Final Accounts.

5.3 RELATIONSHIP BETWEEN JOURNAL AND LEDGER

Journal and Ledger are the most useful books kept by a business entity. The points of distinction between the two are given below:

- * Journal is the first book of recording the transactions and ledger is the final book of recording of transactions.
- * The journal is a book of original entry whereas the ledger is the main book of account.
- * Journal is a chronological record of business transactions. Transactions are recorded as and when they occur i.e. date-wise. However posting from the journal is done periodically, may be weekly, fortnightly as per the convenience of the business.
- * The journal does not disclose the complete position of an account. On the other hand, the ledger indicates the position of each account debit wise or credit wise, as the case may be.

5.4 FORMAT OF A LEDGER ACCOUNT

A ledger account can be prepared in any one of the following two forms:

5.5 POSTING AND BALANCING

Posting

Basically, purpose behind preparation of the ledger is to bring all related items of this account which might have been recorded in different books of accounts on different dates at one place. The process involved in this exercise is called posting in the ledger. Thus, Posting refers to the process of transferring debit and credit amounts from the Journal or subsidiary books to the respective heads of accounts in the ledger. Journal will have at a minimum of one debit and one credit for each transaction. The ledger will have either a debit or a credit for each account used in the Journal.

Posting may be done daily, weekly fort nightly or monthly according to the convenience and requirements of the business, but care should be taken to complete it before the preparation of annual financial statements. The following rules should be followed

while posting business transactions to respective accounts in the ledger from the journal:

- i) Open separate account in the ledger for each person, asset, revenue, liability, expense, income and loss appearing in the Journal.
- ii) Enter the date of the journal entry in the Date Column of the account debited. Use the date of the journal entry, not the date on which the posting is done. Write the year and month in the left side of the date column. It is not necessary to write the year and month for other postings to the same account on the same page unless the month or year changes. The day, however is always entered.
- iii) The particulars column on the ledger contains the details of the account with which it is debited or credited.
- iv) In the ledger account Journal Folio (J/F) column, identify where the journal entry is recorded. Enter a letter for the specific journal and the journal page number.
- v) Enter the debit amount in the debit column of the ledger account, but the reference should be given of the other account which has been credited.
- vi) Similarly, the account credited in the Journal should be credited in the ledger, but the reference has to be given of the other account which has been debited in the Journal.
- vii) The debit posting should be prefixed by the word 'To' and credit posting should be prefixed by the word 'By'.
- viii) Return to the journal and, in the ledger folio (L/F) column, enter the account number of the ledger account to which debit part of the journal entry is posted. Be sure it is entered on the same line as the debit entry. This part is very important as the notation in the ledger folio indicates that the journal entry has been posted.

Let us take an example to understand the posting:

Illustration:1 On Jan 1, 2014 Sohan Lal purchased a computer costing 50,000 from a supplier and issued a cheque of Rs.50,000. On Jan 4 He purchased stock worth Rs.1,00,000 and paid by cheque. These will be recorded in the journal as shown below:

Posting of Compound Journal Entry

When a single entry is passed to record more than one transaction, it is known as a compound journal entry. However, it will be treated as several separate entries while posting. The following example will make the point clear:

Illustration 2 On Jan 1, 2014 Sohan Lal purchased a computer costing 50,000 from a supplier and issued a cheque of Rs.30,000. Balance amount to be paid after three months. This will be recorded as shown below:

Importance of Posting

Posting organizes business transaction details into the proper account. As discussed earlier, transactions that are itemized in the general journal are helpful, but do not summarize similar transactions into the same location. Posting summarises all business transactions so managers can see the cumulative effects on accounts.

Balancing of an Account

After transferring the entries from Journal to the ledger, the next stage is to ascertain the net effect of all the transactions posted to relevant account.

When the posting is completed, most of the accounts may have entries on both sides of the accounts i.e. debit entries and credits entries. The process of finding out the difference between the totals of the two sides of a Ledger account is known as balancing and the difference of the total debits and the total credits of accounts is known as balance.

If the total of the credit side is bigger than the total of the debit side, the difference is known as credit balance. In the reverse case, it is called debit balance.

Steps for Balancing Ledger Account

Ledger accounts may be balanced as and when it is required. Balancing is done either weekly, monthly, quarterly, biannually or annually, depending on the requirements of the business concern. The balances of various accounts are ascertained as under:

- 1. Total both sides of an account in a worksheet.
- 2. Write down the higher amount on the side obtained e.g. if the total of the debit side is higher as compared to the credit side than the amount on debit side will be written first.
- 3. Also write down the same total on the other side of the account i.e. the total of higher side is written against the total on the lower side also.
- 4. Find out the difference between the two sides of the account. In this example debit side is more than credit side; therefore, there will be a debit balance.
- 5. This debit balance is to be shown as "By Balance c/d" in the account on the credit side.
- 6. Finally, the amount of the closing balance should be brought down as the opening balance at the beginning of the next day. Remember that if the opening balance is not written on the next day, the balancing is incomplete.

Let us understand the balancing of accounts from the above illustration:

In the following computer account, the balance of debit side is Rs.50,000 and that of credit side the balance is nil. So the debit side is higher ad we will write Rs.50,000 on both sides. Thereafter the balancing figure is carried down as shown below:

5.6 LET US SUM UP

Journal which is a first step in the accounting process, is concerned with the recording of financial transactions in an orderly manner, soon after their occurrence. The function of systematic analysis of the recorded data to accumulate the transactions of similar type at one place is performed by maintaining the ledger in which different accounts are opened to which transactions are posted. Ledger is a book of accounts in which data from transactions recorded in journals are posted and thereby classified and summarized. Ledger is a set of accounts. Ledger contains the various personal, real and nominal accounts in which all business transactions of the entity are recorded. The main function of the ledger is to classify and summarise all the items appearing in Journal and other books of original entry under appropriate head/set of accounts so that at the end of the accounting period, each account contains the complete information of all transaction relating to it.

5.7 KEYWORDS

Ledger: Ledger is a book of accounts in which data from transactions recorded in journals are posted and thereby classified and summarized.

Posting: Posting refers to the process of transferring debit and credit amounts from the Journal or subsidiary books to the respective heads of accounts in the ledger.

Balancing: The process of finding out the difference between the totals of the two sides of a Ledger account is known as balancing and the difference of the total debits and the total credits of accounts is known as balance.

6.1 INTRODUCTION

So far we have discussed that transactions are first recorded in journal, and then posted to ledger. In case of large organizations where there are numerous transactions, it will be difficult to record all these transactions through journal. Hence, for convenience of recording, the journal is divided into a number of special journals. These are known as subsidiary books. The number of subsidiary books maintained by a business organization depends on the size of the organization and the nature of transactions. Now, we will discuss the subsidiary books maintained by a business organization in general.

6.2 MEANING OF SUBSIDIARY BOOKS

Subsidiary books are the books of original entry that are maintained under the modern methods of book-keeping for recording the various transactions. Subsidiary books are also called primary records because the first entry of transaction is made in subsidiary books. On the basis of subsidiary books postings are made into concerned account afterwards. If the number of transaction is very large then there will be bulky journal. For quick, efficient and accurate recording of business transactions, the journal book is sub-divided. The subdivision of journal ensures that the size of journal will not be too bulky. This helps in getting useful information about liquidity position of business. These special journals are called Subsidiary Books as these facilitate the preparation of Ledger book.

Following types of books are used under subsidiary books—

- 1. Purchase book
- 2. Sales book
- 3. Purchase return book
- 4. Sales return book
- 5. Bills Payable book
- 6. Bills Receivable book
- 7. Journal Proper

6.3 NEED FOR MAINTAINING SUBSIDIARY BOOKS

There are following reasons for which it becomes necessary to sub-divide the journal:

- 1. Recording of Transactions: if the number of transactions is very large then it is not possible for a single person to record transactions in time. But if two or more persons are employed for the same purpose then it is possible only if the journals are divided.
- 2. Size of journal: the size of journal will become too bulky if all the transactions are recorded in one book. It will become difficult to handle this by one person.

- 3. More time and labour: it as a time and labour consuming process to record transactions in one journal and then post each and every individual item to the ledger.
- 4. Accuracy of information: if only one journal is maintained and all the transactions are recorded in this, then it may lead to certain errors and mistakes. In such a case the derived information may not be accurate and correct.
- 5. Classification of records: when a business records all the transactions in one book i.e. journal, then it fails to provide classified information such as monthly credit sales or purchases etc.
- 6. Checking and verification: it is difficult to check and verify the recorded transactions in one bulky sized journal.

ADVANTAGES OF SUBSIDIARY BOOKS

The practical system of book keeping is very useful as it has various advantages given below:

- 1. Division of work: this system permits the division of work among the accounting staff. There are various subsidiary books, therefore, different clerks can be entrusted with the job of writing different sub journals.
- 2. Time saving: due to the division of work, it possible to perform various accounting processes simultaneously. Thus, lesser time is required to complete the accounting records.
- 3. Increase in efficiency: each person is required to write up only one class of transactions, therefore, he is likely to develop proficiency in his work. It increases the efficiency of work in a accurate and exact manner.
- 4. Minimum errors and frauds: the systematic recording of business transactions in special journals reduces the possibilities of errors and frauds. It also helps in location of errors, if any.
- 5. Effective internal check system: the subsidiary books leads to the division of work and each person is assigned with the specialized work so the internal check system of business becomes more effective.
- 6. Facility in auditing: it makes information available regarding each particular class of transactions at one place. Therefore, it facilitates the work of auditoRs.
- 7. Location of errors: different persons carry on the checking work simultaneously on different books; therefore, at the time of preparing the trial balance the errors can be located easily and quickly.
- 8. Easy reference: as the volume of each sub journal becomes short, therefore, it is easy to make any reference for the purpose of use.

6.4 DIFFERENCE BETWEEN SUBSIDIARY BOOKS AND LEDGER

The differences between subsidiary books and ledger can be presented in the summarized form in the following tabular column:

| Basis of Distinction | Subsidiary Books | Ledger |

| 1. Caption of the book | These are books of Original Entry (or) Books of Prime Entry. | This is a book of Secondary Entry (or) Book of Final Entry. |
| 2. Basis of recording | These are recorded on the basis of source documents. | These are recorded on the basis of the books of Prime Entry. |
| 3. Order of recording | Transactions are recorded in order of their occurrence. | Transactions are recorded from subsidiary books irrespective of the date of their occurrence. |

6.5 PURCHASE BOOK

In purchase book the transactions relating to credit purchase of goods are recorded. The term goods mean all the commodities and services in which the company deals in day to day activities. But cash purchases and purchase of fixed assets are not recorded in this book. This book is also known as Purchase Journal or Bought Day Book. At the end of a certain period, the total of Purchase Book is posted to the debit side of Purchase Account and the suppliers' accounts will be credited with the respective amounts in the ledger book.

Cash purchases of the goods are recorded in cash book and not in the purchase book. For recording purposes, the following points should be considered:

- 1. Only credit purchases of goods is to be considered.
- 2. Cash purchases of goods is to be recorded in cash book.
- 3. Purchase of goods meant for resale are to be considered.
- 4. If a business purchases an item not for resale in the normal course of business then it will be treated as an asset and therefore not to be recorded in the purchases book i.e. asset shall be recorded in the journal proper.

6.6 SALES BOOK

This book is meant for recording credit sale of goods. Cash sale of goods and sale of articles other than goods are not recorded in this book. This book is also known as Sales Journal or Sold Day Book. When the trader sells goods on credit then he should keep record in sales book to know how much goods have been sold, when and to whom. At the end of a certain period, the total of Sales Book is posted to the credit side of Sales Account and the

customers' accounts will be debited with the respective amounts in the Ledger book. Two things are to be noted about this book:

- 1. Only credit sales are recorded in sales book. Cash sales of goods are recorded in the cash book.
- 2. The credit sale of only those goods is recorded in this book in which the firm is normally trading.

Following is the format of sales book:

6.7 PURCHASE RETURN BOOK

The book which is used for recording goods return to the seller is called "Purchase Return Book". The transactions relating to return of goods to the supplier which were purchased on credit are recorded in Purchase Return Book. The goods may be returned due to not confronting to the specifications or defective goods or for any other reason. It is also known as Returns Outward Book. The total of this book, after a certain period, is credited to Returns Outward Account and the suppliers' accounts, to which goods were returned, are debited with the respective amounts in the ledger book.

The format of the Purchase Return Book is given as:

DEBIT NOTE

It is the source of recording for Purchases Return book. A debit note is a document or statement sent by the firm to person to whom goods are returned or from whom an allowance is claimed. This statement is intimation to the supplier of goods that his account has been debited to the extent of value of goods returned or allowance claimed. It contains the description and details of goods returned, name and place of supplier to whom goods are returned and net value of goods with reason of return.

6.8 SALE RETURN BOOK

When goods sold on credit are returned by the customers, they are recorded in Sales Return Book or Returns Inward Book. At the end of a certain period, the total of this book is debited to Returns Inward Account and the customers' accounts, who have returned the goods, are credited with the respective amounts in the ledger book.

CREDIT NOTE

It is the source of recording for Sales Return book. A credit note is a document or statement sent by the firm to its customers who returned the goods or claimed allowance from the firm. This statement is an acknowledgement to the buyer who returned the goods along with a debit note. It contains the description and details of goods returned, name and place of customer returning such goods and net value of goods returned.

6.9 BILLS RECEIVABLE BOOK

This book is used to record all promissory notes given and Bills of Exchange accepted by customers for the amounts due from them. A promissory note contains an unconditional promise in writing, to pay a certain sum of money only to a certain person on a specific future date.

6.10 BILLS PAYABLE BOOK

This book is used to record all promissory notes given and Bills of Exchange accepted by the business for the amounts due to suppliers. A bill of exchange is an instrument in writing, containing an unconditional order to pay a certain sum of money only to a certain person on a specific future date.

The format of the Bill Payable book is given as:

6.11 JOURNAL PROPER

Journal proper is book of original entry (simple journal) in which miscellaneous credit transactions which do not fit in any other books are recorded. It is also called miscellaneous journal. The form and procedure for maintaining this journal is the same that of simple journal.

The use of journal proper is confined to record the following transactions:-

- 1. Opening entries
- 2. Closing entries
- 3. Transfer entries
- 4. Adjustment entries
- 5. Rectification entries

6. Entries for which there is no special journal

Opening Entries:

When a businessman wants to open the book for a new year, it is necessary to journalise the various assets and liabilities before the new accounts are opened in the ledger. The journal entries so passed are called "opening entries". Suppose a businessman opens a new set of books on January 1, 2014 with cash in hand Rs.100, debtors Rs.200, stock in trade Rs.320, machinery Rs.700, furniture Rs.150, bank loan Rs.300, capital Rs.1,070 the respective opening entry in the journal will be:

Closing Entries:

When the books are balanced at the close of the accounting period with a view to paper final accounts it is necessary that balance of all the income and expenses accounts must be transferred to trading and profit and loss account. The process of transferring balances to the trading and profit and loss account at the end of year is called closing the books and entries passed at that time are called closing entries. For example on 31st December, 1991 the balance in expenses accounts are: Salary Rs.500; rent Rs.200; Stationary Rs.50; legal charges Rs.100; and income accounts are: commission received Rs.50. These balance will be recorded in profit and loss account though the following closing entries:

Transfer Entries:

When accounts are transferred from one account to another for combination of allied items, it is necessary to pass transfer entry. For example, Drawings Rs.500 is transferred from the drawings account to the capital account to find out the net capital. The transfer entry will be passed as follows:

Adjusting Entries:

Modification of the accounts at the end of an accounting period is called adjustments. If there be any event affecting the related period of accounts but left out of the books, the same should be incorporated in the books before the preparation of the final accounts. This is done by means of adjusting entries through the journal proper. For example at the end of the year it is found that rent Rs.50 is outstanding. It is not recorded in the books. It will be taken into account by means of adjusting entry which is as follows:

Rectification Entries:

When an error is detected in the books, the same is rectified through an entry in the journal proper; thus is called rectification entry. For example, it was detected that an expenditure of Rs. 100 on repair to building was charged to building account. It is corrected through the following entry in the journal proper:

Entries of which there is no special journal

When a trader cannot record the entries in the above mentioned sub-journals, the same are entered in the journal proper. The common transactions which cannot be recorded in any of the book of original entry are:

- Distribution of goods as free sample.
- Distribution of goods as charity.
- Goods destroyed by fire.
- Goods stolen away by employees.
- Exchange of one asset for another asset etc.

Limitations

Following are the limitations of the subsidiary books

- 1. It violates the principle of double entry book keeping system because it does not record the two fold aspects of the transactions in the same book.
- 2. Large number of clerical staff is required to set up the system thus it is more expensive.
- 3. It is not suitable to small organization as it is more expensive.

6.12 LET US SUM UP

In this lesson we discussed the various subsidiary books. We have come to know that subsidiary books are the books of original entry that are maintained under the modern methods of book-keeping for recording the various transactions. There are various types of books are used under subsidiary books like Purchase book, Sales book, Purchase return book, Sales return book, Bills Payable book, Bills Receivable book, Journal Proper. These are maintained for the reasons that due to large number of transactions, it is not possible for a single person to record transactions in time. But if two or more persons are employed for the same purpose then it is possible only if the journals are divided. Writing journal in such organisations is time and labour consuming process and this is the logic behind writing subsidiary books.

7.0 OBJECTIVES

After studying this lesson you should be able to

- -understand the various methods of preparation of a trial balance
- -examine the various accounting errors that can be revealed or not revealed with the help of trial balance
- -understand the steps for location of accounting errors.

7.1. INTRODUCTION

In previous lessons we have studies how the accounting transactions are recorded in the books of original entry i.e. Journal and special journal. We also studies the posting aspect of accounting cycle i.e. ledger. After we prepare journal, subsidiary books and ledger the next step is the preparation of trial balance.

Till now we have understood that the fundamental principle of double entry system of accounting is that for every debit, there must be a corresponding credit i.e. the sum total of debit amounts must equal the credit amounts of the ledger at any date. If the debit side does not match the credit side it would lead to the arithmetically inaccuracy of the books of accounts. In order to check whether the debit is equal to the credit side, the trial balance is prepared. At the end of the financial year or at any other time, the

balances of all the ledger accounts are extracted and are recorded in a statement known as Trial Balance and finally totalled up to see whether the total of debit balances is equal to the total of credit balances.

This lesson focuses on the preparation of trial balance. It also discusses the errors that are revealed and not revealed by the trial balance.

7.2 MEANING AND DEFINITION OF TRIAL BALANCE

A Trial Balance is a two-column schedule listing the titles and balances of all the accounts in the order in which they appear in the ledger. The debit balances are listed in the left-hand column and the credit balances in the right-hand column. In the case of the General Ledger, the totals of the two columns should agree.

A Trial Balance may thus be defined as a statement of debit and credit totals or balances extracted from the various accounts in the ledger books with a view to test the arithmetical accuracy of the books. The agreement of the Trial Balance reveals that both the aspects of each transaction have been recorded and that the books are arithmetically accurate. If both the sides of Trial Balance do not agree to each other, it shows that there are some errors, which must be detected and rectified if the correct final accounts are to be prepared. Thus, Trial Balance forms a connecting link between the ledger accounts and the final accounts.

7.3 OBJECTIVES OF PREPARING TRIAL BALANCE

As we have understood that the basic purpose of preparation of trial balance is to check the arithmetical accuracy of the books. The following are the main objectives of preparing the trial balance:

- **(i)** To check the arithmetical accuracy of books of accounts: The basic principles of the double entry system of book-keeping states that every business transaction has two aspects, debit and credit. Debits must be equal to credits. It means that if debits are equal to the credits then the books of accounts are arithmetically accurate. Trial balance helps in tallying the debits and credits. However, tallying of the trial balance is not a conclusive proof of the accuracy of the accounts. It only ensures that all debits and the corresponding credits have been properly recorded in the ledger.
- **(ii) Helpful in preparing final accounts**: Trial balance helps in the preparation of the trial balance as it records the balances of all the ledger accounts at one place. But, unless the trial balance agrees, i.e. the total of debits is equal to the total of credits, the final accounts cannot be prepared. If the trial balance does not agree, errors are located and necessary corrections are made at the earliest, so that there may not be unnecessary delay in the preparation of the final accounts.
- **(iii) Helps in locating errors:** As discussed in above point if total of two columns of the trial balance agrees it is a proof of arithmetical accuracy in the ledger posting. However,

if the totals of the two columns do not tally it indicates that there is some mistake in the ledger accounts. This prompts the accountant to find out the errors.

- **(iv) Helps in Comparison:** By comparing the trial balances of different years changes in figures of certain important items such as purchases, sales, debtors etc. are ascertained and their analysis is made for taking managerial decisions. So, it serves as an aid to the management.
- **(v) Helps in making adjustments:** While making financial statements adjustments regarding closing stock, prepaid expenses, outstanding expenses etc are to be made. Trial balance helps in identifying the items requiring adjustments in preparing the financial statements.

7.4 METHODS OF PREPARATION OF TRIAL BALANCE

We must remember one thing that the Trial Balance is not an account. It is only a list or schedule of balances of ledger accounts including cash and bank balances. It is prepared on a particular date. The accounts having a debit balance are entered in the debit amount column and credit balance accounts are entered in the credit amount column. The totals of the two sides of the accounts may also be used to prepare trial balance. The sum of each column should be equal. A trial balance can be prepared by the following three methods:

1. Total method: In this method, the debit and credit totals of each account are shown in the two amount columns (one for the debit total and the other for the credit total).

Following is the format for trial balance under total method:

2. Balance Method: In this method, the difference of each amount is extracted. If debit side of an account is bigger in amount than the credit side, the difference is put in the debit column of the Trial Balance and if the credit side is bigger, the difference is written in the credit column of the Trial Balance.

This is the most widely used method in practice. The account balances are used because the balance summarises the net effect of all transactions relating to an account and helps in preparing the financial statements. It may be noted that in trial balance, normally in place of balances in individual accounts of the debtors, a figure of sundry debtors is shown, and in place of individual accounts of creditors, a figure of sundry creditors is shown.

7.5 LIMITATIONS OF TRIAL BALANCE

The following are the main limitations of the Trial Balance:

- (i) Trial Balance can be prepared only in those concerns where double entry system of accounting is adopted.
- (ii) Though trial balance gives arithmetic accuracy of the books of accounts but there are certain errors, which are not disclosed by the trial balance. That is why it is said that trial balance is not a conclusive proof of the accuracy of the books of accounts.
- (iii) If trial balance is not prepared correctly then the final accounts prepared will not reflect the true and fair view of the state of affairs of the business. Whatever conclusions and decisions are made by the various groups of persons will not be correct and will mislead such persons.

7.6 ERRORS

It is important for an accountant that the trial balance should tally. Normally when a trial balance tallies it means that both the debit and the credit entries have been made correctly for each transaction and it becomes a prima facie evidence of the arithmetical accuracy of the entries made in the Ledger. But even if the trial balance agrees, it does not necessarily mean that the accounting records are free from all errors, because there are certain types of errors, which are not revealed by a Trial Balance. Therefore a Trial

Balance should not be regarded as a conclusive proof of accuracy of accounts. There can be errors, which affect the equality of debits and credits, and there can be errors, which do not affect the equality of debits and credits. Some common errors are as follows:

- Error in totalling of the debit and credit sides in the trial balance.
- Error in totalling of subsidiary books.
- Error in posting of the total of subsidiary books.
- Error in account balances in wrong side or with wrong amount.
- Omission in showing an account balance in the trial balance.
- Error in the calculation of a ledger account balance.
- Error while posting a journal entry either on wrong side or with wrong amount in the ledger.
- Error in recording a transaction in subsidiary book with wrong name or wrong amount.

These errors may affect the arithmetical accuracy of the trial balance or may defeat the very purpose of accounting. There are two types of errors:

- (a) errors which are not revealed by the trial balance, and
- (b) errors which are revealed by the trial balance.

Errors may happen at any of the following stages of the accounting cycle.

A. At Recording Stage

- 1. Errors of principle
- 2. Errors of omission
- 3. Errors of commission

B. At Posting Stage

- 1. Error of omission
- i. Complete
- ii. Partial
- 2. Error of commission
- i. Posting to wrong account
- ii. Posting on the wrong side
- iii. Posting of wrong amount

C. At Balancing Stage

- 1. Wrong totaling
- 2. Wrong balancing
- **D.** Preparation of Trial Balance
- 1. Error of Omission

- 2. Error of Commission
- i. Taking wrong amount
- ii. Taking wrong account
- iii. Taking to the wrong side

From the point of view of rectification, errors are classified into two categories:

- Errors which affect the trial balance; and
- Errors which do not affect the trial balance.

Errors which Affect the Agreement of Trial Balance

These errors are due to the mistake having being committed on the one side of the account. They may happen at any of the stages of the accounting process, like recording, posting, balancing, etc. such errors can be rectified by giving an explanatory note or by passing a journal entry with the help of a special account called suspense account. This is discussed in the lesson of ratification of errors. Examples of this group of errors are: errors of partial omission; error of casting (totalling); error of carrying forward; error of balancing; error of posting to the correct account but with wrong amount; error of posting to the correct account but on the wrong side; posting to the wrong side with the wrong amount and omitting to show an account in the trial balance.

Errors which do not affect the trial balance

Errors which do not affect the trial balance are committed in two or more accounts. They can be rectified by passing a journal entry giving the correct debit and credit to the concerned accounts. These correcting entries can be recorded in the journal proper. Examples of these errors are: omission to pass an entry in the books of original entry; wrong amount of transaction recorded in the journal, complete omission of the posting of accounts in the ledger.

On the basis of their nature, errors can be classified into the following categories

- 1. Clerical errors
- 2. Errors of Principle

A brief description of the above errors is given below:

(a) Clerical errors

Clerical errors are those errors, which are committed by the clerical staff during the process of recording business transactions in the books of accounts. These errors are:

- 1. Errors of omission
- 2. Errors of commission
- 3. Compensating errors
- 4. Errors of duplication

Errors of omission: When business transaction is either completely or partly omitted to be recorded in the books of prime entry it is called an 'error of omission'.

These can be of two types:

- (i) Error of complete omission
- (ii) Error of partial omission

When a transaction is completely omitted from recording in the books of original record, it is an error of complete omission. For example, purchase of office stationary not entered in books of accounts. It will not affect the trial balance.

When the recording of transaction is partly omitted from the books, it is an error of partial omission. For example purchase of office stationery recorded in the recorded in cash book but not recorded in the stationery account. It would be an error of partial omission. It will affect the agreement of trial balance.

Error of commission: These errors may be due to wrong posting of a business transaction either to a wrong account or on the wrong side of an account, or due to wrong casting (addition) i.e. over-casting or under-casting or due to wrong balancing of the accounts in the ledger.

For example: Office stationary was purchased for Rs.10,000. This transaction was correctly recorded in the cashbook. But while posting to the ledger, stationary account was debited with Rs, 1000 only. This constitutes an error of commission.

Most of the errors of commission affect in the trial balance. Such errors are generally committed by the clerical staff due to their negligence during the course of recording business transactions in the books of accounts. Though, the rules of debit and credit are followed properly yet some mistakes are committed.

Compensating errors: Compensating errors are those errors, which cancel or compensate themselves. When two or more errors are committed in such a way that the net effect of these errors on the debits and credits of accounts is nil, such errors are called compensating errors. Such errors do not affect the tallying of the trial balance.

For example, if stationary account has been overcast by Rs. 10,000 resulting in excess debit of Rs. 10,000 in purchases account and sales returns book is undercast by Rs. 10,000 resulting in short debit to sales returns account is a case of two errors compensation each other.

These errors arise when an error is either compensated or counter-balanced by another error or errors so that of the other on the debit or credit side neutralizes the adverse effect of one on credit side or debit side.

Errors of duplication: When a business transaction is recorded two times in the prime books and posted in the Ledger in the respective accounts twice, the error is known as the 'Error of Duplication'. These errors do not affect the trial balance.

(b) Errors of principle

When a business transaction is recorded in the books of original entries by violating the basic/fundamental principles of accountancy it is called an error of principle. Some examples of these errors are:

- (i) When revenue expenditure is treated as capital expenditure or vice-versa, e.g. Furniture purchased is debited to the purchase account instead of the furniture account.
- (ii) Revenue expenses debited to the personal account instead of the expenses account, e.g. salary paid to Siyaram debited to Siyaram's account rather than salary account.

These errors do not affect the Trial Balance.

The disagreement of the Trial Balance will disclose the following errors:

- (i) An item omitted to be posted from a subsidiary book into the Ledger i.e. a purchase of Rs. 12,000 from Hiralal omitted to be credited to his account. As a result of this error, the figure of sundry creditors to be shown in the Trial Balance will reduce by Rs. 12,000 and the total of the credit side of the Trial Balance will be Rs. 12,000 less as compared to the debit side of the Trial Balance.
- (ii) Posting of wrong amount to a ledger account i.e. credit sale of Rs. 20,000 to Narayan wrongly posted to his account as Rs. 2,000. The effect of this error will be that the figure of sundry debtors will reduce by Rs. 18000 and the total of the debit side of the Trial Balance will be Rs. 18000 less than the total of the credit side of the Trial Balance.
- (iii) Posting an amount to the wrong side of the ledger account i.e. Rs. 1500 salary paid to the employee wrongly posted to the credit instead of the debit of the salary account. As a result of this error, the credit side of the Trial Balance will exceed by Rs. 3000 (double the amount of the error).
- (iv) Wrong additions or balancing of ledger account, i.e. while balancing Capital Account at the end of the financial year, credit balance of Rs. 18000 wrongly taken as Rs. 10000. As a result of this error, the credit total of the Trial Balance will be short by Rs. 8,000.
- (v) Wrong totalling of subsidiary books, i.e. Sales Book is overcast by Rs. 10,000. As a result of this error, Credit side of the Trial Balance will be excess by Rs. 10,000 because Sales Account will appear at a higher figure on the credit side of the Trial Balance.
- (vi) An item in the subsidiary book posted twice to a ledger account, i.e. a rent paid posted twice in rent account.
- (vii) Omission of a balance of an account in the Trial Balance, i.e. cash and bank balances may have been omitted to be included in the Trial Balance.
- (viii) Balance of some account wrongly entered in the Trial Balance i.e. a balance of Rs. 479 in expense Account wrongly entered as Rs. 749 in the Trial Balance.
- (ix) Balance of some account written to the wrong side of the Trial Balance, i.e., balance of discount allowed wrongly shown to the credit side instead of the debit side of the Trial Balance.

| STEPS FOR LOCATION OF ERRORS |
| If the trial balance does not tally, it is a clear indication that at least one error has occurred. The error (or errors) needs to be located and corrected before preparing the financial statements. If the trial balance does not tally, the accountant should take the following steps to detect and locate the errors: |

(x) An error in the totalling of the Trial Balance will bring the disagreement of the Trial

1. Recheck the total of the Trial Balance and ascertain the exact amount difference in the

Trial Balance.

2. Divide the difference of the Trial Balance by two and find out if there is any balance of the same amount in the Trial Balance. It may be that such a balance might have been

recorded on the wrong side of the Trial Balance, thus causing a difference of double the amount.

- 3. If the mistake is not located by the above steps, the difference in the Trial Balance should be divided by 9. If the difference is evenly divisible by 9, the error may be due to transposition or transplacement of figures. A transposition occurs when 57 is written as 75, 197 as 791 and so on. A transplacement takes place when the digits of the numbers are moved to the left or right e.g. when Rs. 5,694 is written as Rs. 56.94 or s. 569.40. If there is a transposition or transplacement of figures, the search can be narrowed down to numbers where these errors might have been made.
- 4. See that the balances of all accounts including cash and bank balances have been included in the Trial Balance.
- 5. See that the opening balances have been correctly brought forward in the current year's books.
- 6. If the difference is of a large amount, compare the Trial Balance of the current year with that of the previous year and see that the figures under similar head of account are approximately the same as those of the previous year and whether their balances fall on the same side of the Trial Balance. If the difference between the previous year figures and the current year figures is large one, establish the causes of difference.
- 7. If the above listed steps fail to detect the errors, check your work as follows:
- (i) Check the totals of the subsidiary books paying particular attention to carry forwards.
- (ii) Check the posting made from the Journal or subsidiary books in the ledger.
- (iii) Re-check the balances extracted from ledger.
- (iv) Re-cast the list of balances.

If all the efforts fail to locate the errors, all the books of primary entry (subsidiary books) must be cast, and, if necessary, the postings to the ledger should be re-checked.

7.7 LET US SUM UP

After the transactions are recorded and summarised in the ledger accounts it is very important to prepare trial balance to check whether the transactions are recorded accurately. Trial Balance is indispensable to accounting. It serves as a lubricant for the smooth movement and completion of the accounting cycle. Moreover, it forms a useful connecting link between ledger accounts and final accounts. The agreement of a Trial Balance is not a conclusive proof as to the absolute accuracy of the books. It only gives an indication of the arithmetical accuracy. Even if both the sides of trial Balance agree to each other yet there may be some errors in the books of accounts. Once it is detected that the trial balance does not tally then the accountants take some steps for the identification of the errors. These errors once identified can be ratified by passing on the ratified entries.

7.8 KEYWORDS

Trial Balance: A Trial Balance is a statement of debit and credit balances extracted from all the ledgers with a view to ascertain arithmetical accuracy of posting of all transactions into the respective ledgers.

Clerical Errors: Those errors which are committed by the clerical staff during the course of recording business transactions in the books of accounts is known as clerical errors.

Compensating Errors: Compensating errors are those errors which compensate themselves.

Errors of Principle: When a transaction is recorded in the books of accounts by violating the basic principle of accounting, it is called an error of principle.

Rectification of errors: Errors affecting only one account can be rectified by giving an explanatory note or by passing a journal entry. Errors which affect two or more accounts are rectified by passing a journal entry.

Meaning and utility of suspense account: An account in which the difference in the trial balance is put till such time that errors are located and rectified. It facilitates the preparation of financial statements even when the trial balance does not tally

8.0 OBJECTIVES

After studying this lesson, you should be able to understand

8.1 Introduction

An accountant tries his best to follow the basic principles of accounting which states that for every debit there will be an equal credit. It implies that if the sum of all debits equals the sum of all credits, it is presumed that the posting to the ledger in terms of debit and credit amounts is accurate. But being a human accountant can also commit errors while recording business transaction in the books of accounts while posting or while balancing. In the last lesson we have seen that the trial balance is a tool for verifying the correctness of and credit amounts. It is an arithmetical check under the double entry system which verifies that both aspects of every transaction have been recorded accurately.

The errors committed by accountants should be located and corrected as soon as possible so that accounts give true and fair results of the operations of the business enterprise. In the previous lesson we have also understood the errors that arise in the trial balance. This lesson explains the meaning and types of errors from the rectification point of view. It also discusses how these errors can be rectified.

8.2 Errors

As stated in the previous lesson, accounting errors are the errors committed by persons responsible for recording and maintaining accounts of a business firm in the course of accounting process. These errors may be in the form of omitting the transactions to record, recording in wrong books, or wrong account or wrong totalling and so on. Accounting errors are those mistakes which occur in the book keeping or accounting, relating to a routine activity or relating to the principle of accounting. The Accounting errors happen in entering the transactions in journal or subsidiary books or at the time of posting of entries in to the ledger. The accounting errors may happen because of the omission, commission, principle or as a compensating of errors.

Few examples of accounting errors are as follows:

- Omission of recording a business transaction in the Journal or Special purpose Books
- Not posting the recorded transactions in various books of accounts to the respective accounts in ledger
- Mistakes in totalling or in carrying forward the totals to the next page
- Mistake in recording amount wrongly, writing it in a wrong account or on the wrong side of the account.

From the point of view of rectification, the errors may be classified into the following two categories:

- (a) errors which do not affect the trial balance.
- (b) errors which affect the trial balance.

The errors which do not affect the trial balance usually take place in two accounts in such a manner that it can be easily rectified through a journal entry whereas the errors which affect the trial balance usually affect one account and a journal entry is not possible for rectification unless a suspense account has been opened. Such errors are rectified by passing a nullifying entry in the respective account

Objectives behind rectification of errors

* There are some errors that affect nominal accounts which result in either increase or decrease in the business. These errors need to be rectified in order to ascertain true profits of the business.

* Certain errors affect personal accounts, real accounts and profits of the business will result in either increase or decrease in assets or liabilities of the business. Thus, there rectification is necessary.

*These errors need to be rectified well in time and with accuracy. If this is not done there are fair chances of problems and confusions in running the business.

8.3 RECTIFICATION OF ERRORS WHICH DO NOT AFFECT THE TRIAL BALANCE

These errors are committed in two or more accounts. Such errors are also known as two sided errors. They can be rectified by recording a journal entry giving the correct debit and credit to the concerned accounts.

Examples of such errors are – complete omission to record an entry in the books of original entry; wrong recording of transactions in the book of accounts; complete omission of posting to the wrong account on the correct side, and errors of principle.

The rectification process essentially involves:

- Cancelling the effect of wrong debit or credit by reversing it; and
- Restoring the effect of correct debit or credit.

For this purpose, we need to analyse the error in terms of its effect on the accounts involved which may be:

- (i) Short debit or credit in an account; and/or
- (ii) Excess debit or credit in an account.

Therefore, rectification entry can be done by:

- (i) debiting the account with short debit or with excess credit,
- (ii) crediting the account with excess debit or with short credit.

Illustration 1: Credit sales to Raheem Rs. 50,000 were not recorded in the sales book. This is an error of complete omission. Its affect is that Raheem's account has not been debited and Sales account has not been credited. Accordingly, recording usual entry for credit sales will rectify the error. The rectification entry will be:

Raheem A/c ------ 50, 000 To Sales A/c 50,000

Let us take few more examples:

Illustration 2

1. Carriage paid for machinery but wrongly debited to Carriage Inward A/c *In this case the wrong entry made is:*

| Advertisement A/c Dr. |
| To Purchases A/c |
| The correct entry should be: |
| Drawings A/c Dr. |
| To Purchases A/c |
| Now the rectification entry needs to be passed is: |
| Drawings A/cDr. |
| To Advertisement A/c |

(For rectification: Advertisement A/c wrongly debited, it is now credited. Drawings A/c should have been debited but not debited, now it is debited).

4. Sold goods to Shivani Associates for Rs.500, but recorded in the books as goods purchased from Shivani Associates for Rs.500

In this case the wrong entry made is:

Purchases A/c----- Dr.

To Shivani Associates A/c

The correct entry should be:

Shivani Associates A/c ----- Dr.

To Sales A/c

Now the rectification entry needs to be passed is:

Shivani Associates A/c----Dr. 1800

To Purchases A/c 900

To Sales Ac 900

(For rectification: Purchases A/c wrongly debited, it is now credited. Sales A/c should have been credited and now it is credited. Shivani Associates A/c was wrongly credited which was supposed to be debited, now it is debited with double amount).

8.4 RECTIFICATION OF ERRORS AFFECTING TRIAL BALANCE

The errors which affect only one account can be rectified by giving an explanatory note in the account affected or by recording a journal entry with the help of the Suspense Account. Examples of such errors are error of casting; error of carrying forward; error of balancing; error of posting to correct account but with wrong amount; error of posting to the correct account but on the wrong side; posting to the wrong side with the wrong amount; omitting to show an account in the trial balance.

An error in the books of original entry, if discovered before it is posted to the ledger, may be corrected by crossing out the wrong amount by a single line and writing the correct amount above the crossed amount and initialling it. An error in an amount posted to the correct ledger account may also be corrected in a similar way, or by making an additional posting for the difference in amount and giving an explanatory note in the particulars column. But errors should never be corrected by erasing or overwriting reduces the authenticity of accounting records and give an impression that something is being concealed.

Let us take few examples to understand the rectifications of such errors:

Illustration 3

1. Sales day book overcast for the month of March by Rs.1000

- 2. The purchase day book undercast for the month of March by Rs.2000
- 3. The sales day book on a folio was carried forward to the next page as Rs. 240 instead of Rs.420.
- 4. Depreciation charged to Machiney, but not posted to the Depreciation on Machinery $A/c\ Rs.9000$
- 5. Cash received from Mira Nair A/c Rs.5000 posted to the debit of Mira A/c
- 6. Interest received on the bank balance Rs.500 has been duly shown in the cash book but not posted in the Interest Received A/c.

Solution:

1. This entry will be rectified by sales A/c by writing the following line:

"To overcasting of Sales Day Book for the month of March Rs. 1000

2. Undercast of the Purchases A/c will be rectified bypassing the following line:

"To Undercast of Purchases Day Book for the month of March Rs.2000.

3. Sales are shown short by Rs. 180 (420-240) and needs to be rectified. Sales A/c will be credited by writing the following line:

"By mistake in posting the wrong amount in the Sales Day Book Rs.180."

4. Here, the amount has not been posted to the Depreciation on Machinery A/c. Hence, it needs rectification by debiting Depreciation A/c

"To omission of posting depreciation Rs.9000."

5. Here, Mira Nair A/c is debited by Rs.5000 but it should have been credited with Rs.5000. Thus, it will be rectified by double of the amount i.e. Rs.10,000 by passing following line of rectification

"By wrong posting adjusted Rs.10,000.

6. Here, the Interest received on the bank balance has not been credited to Interest Received A/c by Rs.500. So, it will be rectified by passing the following line:

"By omission of posting Rs.500."

Suspense Account: We all know that after the preparation of a trial balance, the final accounts are prepared. Generally, when the accountant prepares trial balance and the trial balance is not agreeing then he makes rechecking of accounts because when a trial balance disagrees, it may delay the preparation of the final accounts. In order to avoid the delays in the preparation of the final accounts, the difference in the trial balance is replaced by a new account known as suspense account.

If the credit side of the trial balance exceeds the debit side, the difference is put on the debit side of the trial balance and suspense account will show a debit balance. If the

debit side of the trial balance exceeds the credit side, the difference is put on the credit side of the trial balance and suspense account will show a credit balance. For preparing final accounts, debit balance of suspense account is written in asset side and credit balance of suspense is written in liability side of the balance sheet. Thereafter, when all the errors are rectified, the suspense account automatically closes.

Following are the reasons why suspense account will be opened:

- 1. A bookkeeper is unsure where to post an item and enters it to a suspense account pending instructions.
- 2. There is a difference in a trial balance and a suspense account is opened with the amount of the difference so that the trial balance agrees (pending the discovery and correction of the errors causing the difference). This is the only time an entry is made in the records without a corresponding entry elsewhere.

Let us consider following example to understand the usage of suspense account:

Illustration 4

Rectify the following accounting errors through Suspense Account:

- 1. Goods purchased from Rohit for Rs 10000 was entered in the Sales Book, however Rohit's Account was correctly credited.
- 2. Cash received from Rekha a debtor Rs 13200 was correctly entered in the Cash Book but was omitted to be posted to her account.
- 3. Sales Book was overcast by Rs 5000.
- 4. Cash of Rs. 5000 paid to Suresh was credited to Rakesh A/c as Rs 500.
- 5. The total of Purchase Returns Book of Rs3150 was carried forward as Rs1530.
- 6. Naresh was paid cash Rs 9500 but Sunil was debited by Rs 9000 Solution

8.5 RECTIFICATION OF ERRORS IN THE NEXT ACCOUNTING YEAR

If some errors committed during an accounting year are not located and rectified before the finalisation of financial statements, suspense account cannot be closed and its balance will be carried forward to the next accounting period. When the errors committed in one accounting year are located and rectified in the next accounting year, profit and loss adjustment account is debited or credited in place of accounts of expenses/losses and incomes/ gains in order to avoid impact on the income statement of next accounting period.

8.6 GUIDING PRINCIPLES OF RECTIFICATION OF ERRORS

- 1. If error is committed in books of original entry then assume all postings are done accordingly.
- 2. If error is at the posting stage then assume that recording in the subsidiary books has been correctly done.
- 3. If error is in posting to a wrong account (without mentioning side and amount of posting) then assume that posting has been done on the right side and with the right amount.
- 4. If posting is done to a correct account but with wrong amount (without mentioning side of posting) then assume that posting has been done on the correct side.
- 5. If error is posting to a wrong account on the wrong side (without mentioning amount of posting) then assume that posting has been done with the amount as per the original recording of the transaction.
- 6. If error is of posting to a wrong account with wrong amount (without mentioning the side of posting) then assume that posting has been done on the right side.

- 7. If posting is done to a correct account on the wrong side (without mentioning amount of posting) then assume that posting has been done with correct amount as per original recording.
- 8. Any error in posting of individual transactions in subsidiaries books relates to individual account only, the sales account, purchase account, sales return account or purchases return account are not involved. 9. If a transaction is recorded in cash book, then the error in posting relates to the other affected account, not to cash account/bank account
- 10. If a transaction is recorded through journal proper, then the phrase 'transaction was not posted' indicates error in both the accounts involved, unless stated otherwise.
- 11. Error in casting of subsidiary books will affect only that account where total of the particular book is posted leaving the individual personal accounts unaffected.

8.8 LET US SUM UP

Rectification of error is very necessary after their detection. Many times errors are rectified by erasing or cutting. Errors should not be rectified in this way since it raises questions about integrity of accountant and also authenticity of the accounting books. Errors should be rectified by passing a rectification entry in the journal or ledger. Entries which are passed for rectification of errors are called rectifying errors. These errors can be classified as one-sided errors and two-sided errors.

Suspense account is an imaginary account which is opened for agreeing the trial balance. Later as and when the errors are located, these are rectified with the help of suspense account. Thus when all the errors are rectified, the suspense account will automatically stand closed. But, if the suspense account still shows a balance, it will indicate the errors that are still to be discovered. But one thing is to be kept in mind that only one sided errors are rectified with the help of suspense account.

8.9 KEY WORDS

Errors of Commission: Errors caused due to wrong recording of a transaction, wrong totalling, wrong casting, wrong balancing, etc.

Errors of Omission: Errors caused due to omission of recording a transaction entirely or party in the books of account.

Errors of Principle: Errors arising due to wrong classificatrion of receipts and payments between revenue and capital receipts and revenue and capital expenditure.

Compensating Errors: Two or more errors committed in such a way that they nullify the effect of each other on the debits and credits.

Rectification of errors: Errors affecting only one account can be rectified by giving an explanatory note or by passing a journal entry. Errors which affect two or more accounts are rectified by passing a journal entry.

Suspense account: An account in which the difference in the trial balance is put till such time that errors are located and rectified. It facilitates the preparation of financial statements even when the trial balance does not tally. When all the errors are located and rectified the suspense account stands disposed off.

8.1. INTRODUCTION

Every businessman keeps a check on the cash & bank balance available to him for meeting his expenses and liabilities and to know the receipts and payments of a particular period. He ensures that payments are of reasonable amount and expenses are not unreasonably high. Due to many causes, pass book issued by bank and cash book prepared by businessman never match with each other. To uncover any possible discrepancies, the two statements must be compared. This lesson is devoted to the preparations of these comparative statements.

8.2 CONCEPT AND MEANING OF BANK RECONCILIATION STATEMENT

On having a look to a cash book containing bank columns, it is found that bank column represent the "Bank Account" which is a personal account. The bank column of cash book is debited whenever we deposit cheques, cash, etc., into our bank account. On the other hand the bank will give a credit for the same amount in our account with them. Similarly, we credit the bank column of our cash book whenever we issue cheques,

withdraw cash, etc. from our bank, for which the bank will debit our account with them. In other words, all entries which appear on the debit side of the bank column of our cash book shall appear on the debit side of our account in the books of the bank. Therefore, in the bank column of our cash book, if the total debits (deposits) exceed total credits (withdrawals) there will be debit balance. Accordingly, as per the bank's records there will be a credit balance. In reality, our record in the bank columns in cash book and the record in our account with the bank become counterparts of each other.

A bank issues to every account-holder a copy of his account with them. This is known as the Bank Statement of Account or the Bank Pass Book. This enables the account-holder to check entries in bank column of his cash book with entries recorded in the pass book, as and when he desires to find out the exact position. The specimen ruling of a pass book is given below

In the above example when Suresh deposits cash, he becomes creditor of the bank because bank owes this amount of Suresh. But when he withdraws money, he becomes a debtor of the bank for that transaction because he is receiving the money from the bank. Also he becomes a creditor for depositing a cheque in the bank and a debtor for drawing a cheque on the bank.

Transactions given in the above example will be recorded in the Bank Column of the Triple Column Cash book (maintained by Suresh) as below:

From the Pass Book and Cash Book given above, we find the same balance, the only difference is that in Cash Book there is a debit balance whereas the same amount appears as a credit balance in the Pass Book. From the view point of the bank, Suresh is a creditor in its books because he is to receive the amount from the bank. It means that

the balance as per Pass Book. If all entries are correctly recorded in the two books, the balance should always be equal in the two books but usually it is not the case due to omission of some entries or due to incorrect recording of a few entries in any of the two books.

It is proper, therefore, for the account holder to check from time to time the entries in the Pass Book with the entries in the Bank Column of the Cash Book or the Bank Account in the ledger and point out to his bankers, the errors or omissions if any so found so that these may be rectified.

Periodically, a statement is prepared to check that there is no error in the Pass Book or Cash Book; the statement is called Bank Reconciliation Statement. It is prepared with a view to reconciling the two balances shown by Cash Book and Pass Book and locating the mistakes which have been responsible for the disagreement of the two balances on a given date. It must be kept in mind that it is statement and not an account.

However, there are some differences between the pass book and the statement of account which may be stated as under: -

8.3 CAUSES OF DIFFERENCE BETWEEN CASH BOOK AND PASS BOOK

The main reasons for difference between the balances shown by the Cash Book and the Pass Book are as given below:-

1. Cheques issued but not yet presented for payment: When a cheque is issued by a businessman in favour of his creditor, an entry is made on the payment side of the bank column of the Cash Book. The bank shall pass entry in its books only when it is presented to the bank for payment. If the cheque has not been presented for payment upto the date of the preparation of the Bank Reconciliation Statement, the balance as per Cash Book will be smaller than the balance shown by the pass book by the amount of that cheque.

- 2. Cheques paid into bank but not yet collected or credited by the Bank: When a businessman receives cheques from his customers, he submits them into the bank for collection and debits the bank column in his Cash Book on the same day, thus increasing his balance with the bank. But the bank will not give credit in the Pass Book on the same date when cheques are deposited into the bank by the businessman. Bank gives credit only when it receives the amount of these cheques from the banks upon which these are drawn. It takes time to collect them. Due to this time gap, there will be no entry in the Pass Book and the balance as per Cash Book will be more as compared with the Pass Book balance because it had been increased when the cheque was paid into bank.
- 3. **Direct payments into the Bank:** Sometimes, the debtors of the businessman directly deposit the amount due from them in his bank account. Due to this, the bank balance of the businessman shall increase by the amount of direct payments by the debtors because these payments as received by the Bank will be entered on the credit side of the account of the firm. On the other hand there will be no entry in the Cash Book up to the date of reconciliation. As a result, the Pass Book balance will be higher as compared to Cash Book Balance.
- 4. **Interest Credited by the bank on Current Account:** Some banks give interest on current account to their customers if they keep a certain minimum credit balance in their current account. When the interest is credited by the bank in Pass Book, the pass book balance is increased, while there will be no entry for this in the Cash Book due to lack of information. Hence, the balance as per Pass Book shall be more as compared to the balance as per Cash Book.
- 5. **Interest and Bank Charges by the Bank:** The banks usually debit the account of the businessman with commission, bank charges and interest on overdraft. Bank charges may be charged for the collection of outstation cheques and for the various services provided by the bank to the businessman. The balance as per Pass Book will be reduced by the amount of such transactions whereas balance as per Cash Book will not be reduced because no entry has been passed in cash Book due to lack of information.
- 6. **Interest or dividends on investments and rents collected by the Bank:** A businessman may authorize his bank to collect interest or dividends on investments or rents on property on his behalf. When the bank receives such amounts, bank credits the customer account with that amount, whereas, there may not be any entry in the Cash Book for such items due to lack of information. Therefore, Pass Book will show higher balance on this account.
- 7. **Payments made by the bank on behalf of Customers:** The businessman may give standing instructions to his banker to make payment for insurance premium, subscription to periodicals, licence fee, rent etc., on his behalf on the due dates. Whenever the bank makes such payments, the bank will debit the account of the businessman and reduce his bank balance as per pass book, whereas there will be no reduction in the balance as per cash book due to the omission of this entry in the Cash Book.

- 8. **Bills collected by the Bank on behalf of the customer:** Banks may be authorized to collect the amount due to certain bills of exchange from the acceptors. If the acceptor honours a bill on its due date the bank will credit the account of the trader. As a result the balance as per pass Book will be higher as compared to the Cash Book balance until the necessary entries are passed in cash book.
- 9. **Cheques or Bills of Exchange dishonoured:** A firm may receive a number of cheques and bills of exchange from its customers. Some of the cheques deposited by the firm into the bank for collection may be dishonoured. When a trader deposits a cheque in a bank, he debits bank column in his Cash Book, which increases his balance. But the bank gives credit only when a cheque is collected. If any cheque dishonoured, there will be no entry in Pass Book. Thus, there will arise a difference between the balances as shown by Cash Book and as shown by Pass Book.

Also a firm may receive acceptances from its Customers and may get them discounted with the bank. The firm will give debit to Bank Account for the amount of these bills less discount charged by the bank, therefore balance in Cash Book is increased. These bills may be dishonoured and its charges, if any. The firm will not record it unless it receives information for dishonour of bill up to the date of preparation of reconciliation statement. The Pass Book balance shall be less as compared to the Cash Book balance because the entry for dishonour of the bill has not yet been recorded in the Cash Book.

- 10. **Cheques received but omitted to be banked:** Whenever businessman receives a cheque from any customer, it might have been entered on the debit side of Cash Book but the same might not have been sent to the bank for collection up to the date of reconciliation. This omission will not increase the Pass Book balance. Thus, Cash Book will show more balance than Pass Book.
- 11. **Wrong debit or credit given by the Bank:** If an entry is recorded on the wrong side of the Pass Book by the bank, it shall cause a difference of twice the amount of item which is written on the wrong side of the Pass Book. For example, a sum of Rs. 4, 000 is collected by the bank as dividend on shares. Instead of crediting the account of the firm, the bank debits it by Rs. 4, 000. As a result of this Pass Book balance will be shorter by Rs. 8,000 as compared to Cash Book balance.
- 12. **Errors in Cash Book:** The Cash Book of a firm may have certain errors. The examples of such errors are:-
- (a) Over casting or undercasting of debit side of bank column of Cash Book. The balance as per
 - Cash Book will increase in case of overcasting and decrease in case of undercasting the debit side of bank column Cash Book.
- (b) Over casting or undercasting of credit side of bank column of Cash Book. The balance as per Cash Book will decrease in case of overcasting and increase in case of undercasting of the credit side of cash book.

(c) There might be an entry on the wrong side or with wrong amount in the Cash Book for interest allowed or charged by the bank or dividend or interest on investments collected by the bank. Therefore the balance as shown by Cash Book and Pass Book will differ.

Until both the books are reconciled, the Cash Book and Pass Book balances rarely tally at any given date. Accordingly, a statement is drawn up to adjust the differences arising from any of these causes. Such a statement is termed as 'Bank Reconciliation Statement'.

A Bank Reconciliation Statement is therefore, a statement, prepared periodically with a view to showing the reasons for disagreement between the balances as shown by the Pass Book and Cash Book (Bank Column) or Bank Account in the ledger on a particular date. Practically when a Bank Reconciliation Statement is to be prepared we should select a date on which we wish to prepare it. We should make a comparison of bank column of Cash Book with Bank Pass Book and tick mark the common items of Cash Book and Pass Book for a given period up to the selected date and sort out the unticked items. Thereafter, by taking balance as per bank column of Cash Book or as per Bank Pass Book as the starting point, reconciliation of the two sets of record can be made.

These differences are summarised in the form of table given below:

8.4 RULES FOR PREPARATION OF BANK RECONCILIATION STATEMENT

- **1.** If reconciliation statement is to be prepared from the Bank Balance (or Debit Balance) as per Cash Book:
 - (a) Add to the Cash Book balance such items which have increased the pass book balance or have decreased Cash Book balance e.g., cheques issued but not yet presented for payment, direct payments by the debtors into the bank or dividend, interest on investments collected by the bank etc.
 - (b) Deduct from the balance so selected such items which have increased the Pass Book balance or increased the Cash Book balance e.g., cheques deposited but not yet credited by the bank, payments made by bank on behalf of the firm, bank charges and commission charged by the bank etc.
 - In case we start with a Bank overdraft (or Credit Balance) as per Cash Book, the above procedure should be reversed.
- **2.** If the starting point is Bank Balance (or Credit Balance) as per Pass Book:
- (a) Add the items given in 1(b) above and
- (b) Deduct the items given in 1 (a) above.

In case of Bank overdraft (or Debit Balance) as per Pass Book the above procedure should be reversed.

It may be noted that if the total of items under 'less' heading exceeds the total of all add items plus the balance as per cash book, the difference will be bank overdraft as per Pass Book or debit balance as per Pass Book.

In case the reconciliation statement is started with the Bank Balance as per Pass Book (or Credit balance as per Pass Book) all the above items under *Add* heading shall be entered under *Less* and the items under Less will be entered under *Add* heading. It means the treatment is exactly the opposite. The difference will be Debit Bank balance as per Cash Book or Overdraft as per Cash Book depending upon the total of *Add* and *Less* items.

It may be noted that if the total of items under less exceeds the total of all add items plus the overdraft as per Cash Book, the resulting figure will be favourable balance as per pass book or credit balance as per Pass Book.

In case the statement is started with Bank overdraft as per Pass Book, all items under Add heading above shall be entered under less and the items under less will be entered under add heading. It means the treatment is exactly the reverse. The resulting figure shall be Bank overdraft or favourable Bank Balance as per Cash book, depending upon the total of Add and less items.

Following are the differences between bank statement and bank reconciliation statement:

9.3 NEED AND IMPORTANCE OF BANK RECONCILIATION STATEMENT

The need and importance of the bank reconciliation statement may be given as follows:

- 1. It helps in bringing out the errors committed either in cash Book or bank statement.
- 2. The reconciliation statement may also show any undue delay in the clearance of cheques.
- 3. It helps in keeping check on the misappropriations that can be made by the cashier. Sometimes the cashier may have the tendency of cheating like he may made entries in the Cash Book only but never deposit the cash into bank. So this way bank reconciliation statement acts as a control technique too.
- 4. It explains the reasons for differences between the bank balance as per cash book and the bank balance as per pass book. So, it helps in making necessary adjustments or corrections at the earlier stage.

Adjustment of cash book

In order to reconcile cash book and pass book balances at the accounting date, pass book should be called for immediately and entries for interest allowed by the bank, interest charged on overdraft, commission and bank charges, dividend and interest collected by the bank, insurance premium paid by bank etc. should be ascertained and must be recorded in the cash book (bank column only). He must also rectify the errors, if any, committed in the cash book. Otherwise, due to lack of information, posting of these items will not be made and as a result, Profit and Loss Account will not show the true profit. If cash book is already balanced, a revised or adjusted or amended cash book (bank column only) should be prepared to record the items shown in the pass book but omitted to be recorded in the cash book. After these adjustments, the reconciliation is restricted to the (i) Pass Book errors, if any, (ii) cheques issued but not yet presented, and (iii) cheques paid into the bank but not yet cleared or credited.

Illustration 8: - Keshav's cash book showed a bank overdraft of Rs. 8,000 on $31^{\rm st}$ March, 2011. On comparison of the Cash Book entries with the Pass Book, the following differences were noted down:

- 1. Cheques issued and entered in Cash Book for Rs. 9,000 had not yet been presentd at the Bank.
- 2. The Pass Book showed an item of interest on overdraft Rs. 300 not entered in the Cash Book.
- 3. An out-station cheque of Rs. 5500 lodged on 29the March, 2011 did not appear in the Pass Book.

8.6 LET US SUM UP

The reconciliation process helps in identifying the discrepancies that exist between bank pass book and bank column of cash book and gives correct cash and bank position to the businessman. A businessman would never face problems like cash crisis, dishonour of cheques, misappropriation of cash, etc, if he keeps a regular check on his cash & bank balances.

8.7 KEY WORDS

Cash Book: Cash book is a subsidiary book which records the receipts and payments of cash. With the help of cash book, cash and bank balance can be checked at my point of time.

Pass Book: Pass Book is a book issued by Bank to an accountholder. It is almost a copy of the account of the customer in the books of bank. The bank keeps the customer

informed of the entries made in his account through Pass Book. It is the customer's duty to check the entries and immediately inform the bank of any error that he may have noticed.

Statement of Account: A statement of Account is similar to a Pass Book but it is prepared on loose sheets by the bank. It is also a copy of Customer's Account in the books of the Bank. It is periodically prepared by the bank and is sent to the customer for his examination and comparison with his own Cash Book.

Q 1. On 31st March 2010, the cash book of Rich showed a balance of Rs. 4,760 at bank. They had sent cheques amounting to Rs. 45,000 to the bank before 31st march, but it appears from the pass book that cheques worth only Rs. 64,000 had been credited before that date. Similarly, out of cheques for Rs. 65,000 issued during the month of March, cheques for Rs. 2,750 were presented in April, the remaining having been paid in March itself.

9.0 OBJECTIVES

After studying this unit you should be able to

9.1 INTRODUCTION

The proper distinction between capital and revenue as regard to expenditure, payments, profits, receipts and losses is one of the fundamental principles of correct accounting. It is very essential that in all cases this distinction should be rigidly observed and amounts

rightly allocated between capital and revenue. Failure or neglect to discriminate between the two will falsify the whole of the results of accounting. For example,

- 1. Building may be purchased and debited to purchases account;
- 2. Additions to be made the premises and debited to Repairs Account;
- 3. Some of the fixed assets may be sold and the proceeds treated as profit.

In each case both the profit and loss accounts and balance sheet would be inaccurate and misleading. These and similar mistakes are very easily made and if un-detected would soon render the accounting useless as a record of financial results. As all revenue items to balance sheet, it is necessary that proper distinction should be made between capital and revenue while preparing the final accounts if a business at the end of trading period.


9.2 NEED TO DISTINGUISH BETWEEN CAPITAL AND REVENUE

Meaning and Features

In order to ascertain the true and fair results and financial position of a concern for a year the nature of transaction taking place during the year are to be analyzed for example:

- (a) Transactions having a long term effect are known as capital transaction
- (b) Transactions having short term effect are revenue transaction.
- (c) Transaction, the effect of which is not exhausted within the current year and which can be enjoyed in future year or years also are called capital transactions
- (d) Transaction, the effect of which is exhausted within the current year, is known as revenue transactions.

The Mechanism of capital and revenue can be studied with the help of following chart:-



The proper distinction of capital and revenue must be based upon sound accounting practices so as to get fair information about the business for a stipulated period. The following are different objects of differentiating between these items:-

- **1. To Ascertain true and fair Net Profit:** The main motive of a business entity is to find out net profit or loss at the end of accounting period. Proper measurement of business income can be made if revenue items are included only in income statement while capital items should form part of the balance sheet figures only.
- **2. To Meet Requirement of income tax Provision:** The distinction between Capital and revenue is important for the purpose of payments of Income Tax also. It will be difficult to calculate income liable to Tax. Only revenue receipts and not the capital receipts, that are put to tax, Similarly only revenue expenses are allowed to be detected while finding out income whereas the amount spent On purchase/acquisition of capital assets are ignored altogether.
- **3.** To allocate the Depreciation at the end of accounting period: Depreciation is charged against profit. As the end of year a part of fixed assets consumed during the year is debited in profit and loss accounts. Similarly some expenses such as installation charges may be debited to cost of fixed assets. Therefore a proper identification of these two items is much before final statement of a business are prepared, otherwise the statement present unfair and untrue position.
- **4. To Maintain Record on scientific lines:** In accounting theory and practice, all capital transaction should form a part of the position statement and all revenue items be included in the income statement of every business. This is because accounting is the scientific body of knowledge and all business transactions should fall in the relevant financial statements.

9.3 CAPITAL EXPENDITURE AND CAPITAL RECEIPTS CAPITAL EXPENDITURE

A Capital expenditure_is an amount spent to acquire or improve a long-term asset such as equipment or buildings. Usually the cost is recorded in an account classified as Property, Plant and Equipment. The cost (except for the cost of land) will then be charged to depreciation expense over the useful life of the asset. Any expenditure incurred for the following purposes is **capital expenditure**:

1. For acquiring fixed assets such as land, building, plant and machinery, furniture and fitting and motor vehicles. These assets should not be acquired with a view to resell them at a profit but to retain in the business. The cost of fixed asset would include all expenditure up to the asset becomes ready for use.

- 2. For making improvement and extensions to the fixed asset e.g., additions to buildings.
- 3. For increasing the earning capacity of a business or for reducing the cost of manufacture, administration or distribution in a business e.g., expenditure incurred in removing the business to a central locality or compensation paid to retrenched employee.
- 4. For raising capital monies for the business such as brokerage paid for arranging loans, discount on issue of shares and debentures, underwriting commission etc.

All capital expenditures represent either an asset or liability and are shown in the balance sheet. The following is a list of the usual items of **capital expenditures**:

- Cost of goodwill.
- Cost of freehold land and building and the legal charges incurred in this connection.
- Cost of lease.
- Cost of machineries, plants, tools, fixtures, etc.
- Cost of trademarks, patents, copy rights, designs, etc.
- Cost of car, lorry etc.
- Cost of installation of lights and fans.
- Cost of any other assets acquired by way of equipment.
- Erection cost of plant and machinery.
- Cost of addition to existing assets.
- Structural improvements and alteration in the existing assets.
- Expenses for developments in case of mines and plantations.
- Expenses for administration incurred during construction and equipment of any industrial enterprise.
- Expenses incurred in experimenting which finally result in the acquisition of patent or other rights.

Definition

Kohler defined capital expenditure as "Money spent to acquire or upgrade physical assets such as buildings and machinery also called capital spending or capital expense". Kohler talked about the amount spent on acquisition and upgradation. Carter considered the benefits derived from an asset over a period of time. According to Carter, "Capital items are those, the benefits of which is received over a number a accounting periods and revenue items are those, the full benefits of which is received in the current accounting period".

Following are the features of capital expenditure:

- 1. Capital expenditure is made for acquiring fixed assets.
- 2. These expenditure increases the value of assets.
- 3. This expenditure also increases the profit earning capacity of business.
- **4.** These expenditures are casually incurred.

As capital expenditure results in increase in the fixed asset of the entity, the accounting entry is as follows:-

Fixed assets A/c ----- Dr.

To cash/payables A/c

Capital Receipts

An amount received in the form of capital from the owner and as loan from outsiders is known as capital receipts. Besides, cash received by selling shares, debentures and permanent assets is also capital receipt. Capital receipts can be defined as the proceeds from the sale of capital assets. They may be used to finance new capital expenditure or repay existing loan debt. Receipts available to finance capital expenditure in future years are normally held in the usable capital receipts reserve. It is of non-recurring type of receipt. It is treated as obligation of the business and shown on liabilities side of the balance sheet.

Items relating to capital receipts are as follows:

- * Amount received from the owner as capital.
- * Amount received through the sale of shares and debentures.
- * Amount of loan received
- * Amount received from the sale of old assets.
- * Other receipts of non-recurring nature.

9.4 REVENUE EXPENDITURE AND REVENUE RECEIPTS

REVENUE EXPENDITURE

Revenue expenditure refers to the cost that you charge to expense as soon as you incur it. William Pickles defines revenue expenditure as "Revenue expenditure refers to expenditure concerned with the costs of doing business on a day to day basis. When

companies make revenue expenditure, the expense offers immediate benefits, rather than long term ones. This is differentiated with capital expenditures, which are long term investments to help a business grow and thrive".

In other words, it is expenditure that is concerned with the costs of doing business on a day to day basis. Certain revenue expenditures may be deductible for tax purposes. As revenue costs do not form part of the fixed asset cost, they are expensed in the income statement in the period in which they are incurred.

The accounting entry to record revenue expenditure is therefore as follows

Revenue Expenditure A/c -----Dr.

To Cash/Payable

Characteristics of Revenue Expenditure:-

Following are the essential characteristics of revenue expenditure

- (a) It is Expenditure incurred on day to day conduct of the business
- (b) Its periodicity is generally one accounting year
- (c) It is expenditure on consumable items, on goods and services for resale, either in original or improved form
- (d) It is incurred on maintaining the fixed assets in working order i.e. repairs, renewals and depreciation
- (e) It is of recurring or repetitive nature
- (f) It is incurred to maintain the earning capacity of the business
- (g) It is by nature a short period expenditure

REVENUE RECEIPTS

"Revenue receipts" refer to all money the business makes through its operations. This is a type of recurring profit that comes from repeat transactions with customers, which the business needs to survive. The business makes these repeat transactions to generate enough revenue to continue operations. Without revenue receipts, businesses fail".

Revenue receipts are called a "collection of receipts" because each business transaction generates revenue that the business is owed, or revenue filed under accounts receivable until customers pay it. Manufacturers create revenue receipts when they sell products. Financial companies create them when they sell services. Banks earn receipts through interest when they make loans. The method of earning this revenue varies by industry.

Discounts and other special deals may lower revenue receipts from their customary amounts.

9.5 DIFFERENCES BETWEEN CAPITAL RECEIPTS AND REVENUE RECEIPTS

From the income tax point of view it is necessary to know the difference between capital and revenue receipts. Because only revenue receipts are taxed according to income tax ordinance. While capital receipts are not taxed. When it become very difficult for the assessee to differentiate the capital and revenue receipts. These are brought into the courts. However following tests may be used to distinguish between capital and revenue receipts.

(1). Sale on Asset: Any amount which is received by selling the fixed asset like building, land machinery etc. and kept to earn profit. It will be called the capital receipt on the other hand if floating asset like stock in trade is sold, such receipt will be called revenue receipt.

Example: Suppose a company sells the building, the amount received will be called capital receipts. If a company sells the stock in trade, the amount received will be called revenue receipts.

(2). Substitution Source of Income: Income received by the assessee from the employer is called revenue receipt. While the amount from the new or substituted source is called capital receipt.

Example: Mr. Alfa is manager in the factory. He receives Ten thousand Rupees as a salary. It is a revenue receipt. Mr. Alfa has been retired by the company. The company had also paid him 1 million Rupees to establish a new source. It is capital receipt.

(3). Sale of Right: If any person surrenders his right permanently the amount he receives will be treated as capital receipt. On the other hand if any person surrenders his right for the particular period the amount he receives will be called revenue receipt.

Example: Poet Gulzar has written the book. He surrenders his right of publishing in favor of the publisher permanently and receives 1 million Rupees. Such amount will be treated as capital receipt on the other hand if he surrenders his right only one edition and receives 1 Lakh rupees. It will be a revenue receipt.

(4). Test Motive Behind: The motive behind the transaction must be tested while distinguish the capital and revenue receipt. Motive will declare that amount is a capital receipt or revenue receipt.

Example: Mr. Saif purchases the shares of a company to resell at profit. The amount received by the sale is a revenue receipt. If Mr. Saif purchases the shares to earn profit but after some time he is in need of money. So he sells the shares fulfill the need the amount received by him will be treated as capital receipt.

(5). Period of Receipt: Period of receipt is not considered while distinguishing the capital and revenue receipts.

Example: Mr. Vikram sold his land on installments. The amount received monthly or annually will be also treated as capital receipt. Because he has completely surrendered his right. Mr. Shukla received 2 years advance salary in lump sum. It is revenue receipt.

(6). Receipt Judgment: While making the judgment of receipt one should know that payment is made due to the services of recipient for the employer. If so, then it should be considered as revenue receipt.

Example 1: Mr. Shan received a fee and drafted a business deal. His income will be a revenue receipt. If any person receives bonus from his employer, it is also a revenue receipt.

9.6 ACCOUNTING TREATMENT OF CAPITAL AND REVENUE EXPENDITURE:

The accounting treatment of capital and revenue expenditure is as under

- (a) Revenue expenditure is treated as an expenses and therefore, charged as such against profit in the year they are incurred and recognized
- (b) Capital expenditure is capitalized and therefore, added to an asset account and is shown in the balance sheet on the asset side of an enterprise

9.7 DIFFERENCE BETWEEN CAPITAL EXPENDITURE AND REVENUE EXPENDITURE

Following is the difference between capital and revenue expenditures.

9.8 REVENUE EXPENDITURE BECOMING CAPITAL EXPENDITURE:-

The following are some of examples of revenue expenditure becoming capital expenditure.

- **1. Interest on capital:** Such interest, if paid during the information of company is treated as capital expenditure
- **2. Development Expenses:** Some concerns such as tea and rubber plantations, horticulture and collieries etc requires a very long period od development before they begin to earn any income .all such expenditure incurred during the period of such development is called development expenditure and is treated as a capital expenditure.
- **3. Repairs:** These are usually a revenue charge, but the purchase of second hand plant and payments for immediate repairs necessary to make it efficient for business purpose. Such repairs are treated as capital expenditure and are added to the plant as part of its cost
- **4. Advertising:** The cost of special advertisement campaign for the purpose of introducing a new line of good may be treated as capital expenditure, as the benefit of such advertising will be available in future year also
- **5. Transport expenses:** They are usually a revenue charge but payments made for transporting any plant or machinery are taken as capital expenditure and added to the cost of asset.
- **6. Legal expenses:** These expenses are revenue charge, but the legal expenses are incurred in connection with purchase of fixed assets must be treated as part of cost of capital.

- **7. Wages:** There are revenue items, but wages paid to workman to react new machinery, the firm has bought, must be considered as an addition to the cost of machinery. Similarly wages of workmen employed in the construction of any fixed asset are capital expenditure and must be treated as part of profit
- **8. Carriage and Freight:** Such expenses in connection with the acquisition of fixed assets are capital expenditure
- **9. Raw material and stores:** These are normally a revenue charge but in consumed in making a fixed assets, must be treated as part of cost of assets.

Illustration 1

State the reasons whether following items of expenditure are capital and revenue:

- (1) A second hand motor car was brought for Rs.7000 and Rs 3000 were spent for repairs to put it in order.
- (2) The club building was white washed at the cost of Rs.500.
- (3) A new machinery was purchased for Rs.8000and sum of Rs.750 was spent on its installation.
- (4) Books were purchased for Rs5000 and Rs.100 was paid for carrying the books to library.
- (5) Rs.500 was paid for legal expenses in connection with purchase of a plot of land of land.
- (6)Rs.1200 was paid for custom duty and freight on machinery imported from England.
- (7) Obtained 5 bighas of land for playground at a rent of Rs.500 per month.
- (8) Old furniture was replaced at a cost of Rs.700.
- (9) An additional classroom was constructed at a cost of Rs.3500.
- (10) A large sum of Rs.5000 was spent on advertising for the introduction of a new product.

SOLUTION:

- (1) The cost of second hand car, as well as repair expenses incurred on the same is a capital expenditure. Because a fixed asset i.e. motor car has been acquired. Thus Rs.7000 is capital expenditure Rs.3000 spent on its immediate repairs has increased its serviceability thus this amount should also be capitalized.
- (2) Rs.500 spent on white washing of building has not increased the value of building in anyway. It is maintenance expenditure. Thus it is revenue expenditure
- (3) Rs.8000 spent on purchase on new machinery is a capital expenditure as a fixed assets have increased which will result in increased earning of business Rs.750 paid for installation of the said machine is also a capital expenditure because any expenditure related to an asset until it is ready to use is a capital expenditure

- (4) Rs.5000 being cost of books purchased for library is a capital expenditure as a new asset has been acquired and it will increase the utility of library. The amount of 100 paid for carriage too is a capital expenditure as any expenditure relating to any asset until it is actually put to use is capital expenditure
- (5) Rs.500 paid as legal expenses on connection with purchase of land is a capital expenditure, being part of cost of land .All expenses connected with acquisition of a fixed asset are regarded as a part of purchase consideration.
- (6) Custom duty and freight on machinery imported from England is a capital expenditure because machinery is fixed asset. All Expenses connected with import from England are regarded as part of purchase consideration.
- (7) Rs.500 per month paid as rent for playground is a revenue expenditure. Because rent of land is a recurring expenditure-it does not increase the value of land.
- (8) Rs.700 paid as a cost of repairs of old furniture is revenue expenditure as it does not increase the value of furniture
- (9) Rs.3500 paid for addition to existing building is a capital expenditure because the expenditure has resulted in the increase in the value of building.
- (10) Rs.5000 spent on the advertisement campaign for launching a new product is deferred revenue expenditure because its benefit is likely to be received in future period also.

Illustration 2

- (2) State which of the following expenses, would be charged to capital and which to the revenue:
- 1. Rs.1000 were spend on machine out of which Rs.100 for repairs; Rs.200 for replacement of defective parts and Rs.700 for the improvements of the machinery. As a result of improvements the production capacity of the machine doubled.
- 2.A company removed their factory to more suitable premises and incurred the following expenditure: (1)cost of dismantling, removing and re-installing plant Rs.5160;(ii)Old plant book value Rs.2250 was sold for Rs.800 and replaced by new plant cost Rs.4800.

SOLUTION

- 1. Expenditure of Rs.100 for repairs and Rs.200 for replacement of defective parts are revenue, being necessary to keep the assets in efficient running order. This expenditure does not result in the improved of the machinery. Whereas the amount of Rs.700 spent on improvement is a capital because it increases the earning capacity of the asset.
- 2. (i) Cost of dismantling, removing and reinstallation of plant is revenue expenditure.
- (ii)Loss of Rs.1450 (2250-800) on the sale of old plant, though arising out of fixed assets should be treated as revenue expenditure. It should be debited to profit and loss account. Cost of new plant Rs.4800 is capital expenditure because it relates to acquisition of fixed asset
- 3. Fire insurance premium Rs.150 representing premium for the period 1st October to 31 December is revenue expenditure and Rs.450 paid for the period from January 1 to September 30 of the next year is pre-paid to be carried forward to the next year as an asset.
- 4. Temporary cottages costing Rs.600 should be added to the cost of construction of the factory i.e. capital expenditure as the expenditure is connected with the fixed asset viz, factory.
- 5. Expenditure of Rs.8400 representing improvement and re-furnishing is capital expenditure. However, if the profits are inadequate to absorb Rs.16000 revenue expenditure, it may be spread over number of year for writing off.

Illustration 3

How would with following items as capital or revenue? Also state reasons.

SOLUTION:

- (i) Profit on sale of machine Rs. (70000 -60000) should be treated as capital profit.
- (ii) Excess amount realized from insurance company over the book value of plant accounting to Rs. 2000 (Rs. 10000-8000) is a capital profit since the plant is an item of fixed

asset while excess amount which is realized from insurance company over the value of stock amounting to Rs, 1000(5000-4000) is a revenue profit since the stock is an current asset, which is meant for re-sale.

- (iii) Rs.180000 (Rs.200000-20000) received from issue of shares will be treated as 'capital receipt' and premium of Rs.20000 should be treated as capital profit. However these should be shown in liabilities side of balance sheet.
- (iv) The loss on sale of old machine amounting to Rs.6400 (14400-8000) is a revenue loss since it represent under provision of depreciation already made in earlier years and the selling price amounting to Rs.8000 is capital receipts as it shows proceeds of the sale of fixed assets.
- (v) The amount realized as sale proceed of worn out vehicles is a capital receipts, being the scrap value after charging appropriate amount of depreciation.
- (vi) The amount received as rent, by subletting apart of building is revenue income to be credited in profit and loss account.

9.9 DEFERRED REVENUE EXPENDITURE

Deferred Revenue

Deferred revenue is an advance payments or unearned revenue, recorded on the recipient's balance sheet as a liability, until the services have been rendered or products have been delivered. It is a liability because it refers to revenue that has not yet been earned, but represents products or services that are owed to the customer. As the product or service is delivered over time, it is recognized as revenue on the income statement. **For example**, a company that receives an advance payment of Rs. 100,000 for delivery of a product would book it as deferred revenue on its balance sheet. Once it delivers the product to the customer, the company would transfer the Rs. 100,000 from the deferred revenue account to regular revenue on its income statement.

Deferred Revenue expenditure

Deferred revenue expenditure is that expenditure for which payment has been made or a liability incurred but which is carried forward on the presumption that it will be of benefit over a subsequent period or periods. In short, it refers to that expenditure that is, for the time being, deferred from being charged against income. Such suspension of 'charging of' operation may be due to the nature of expenses and the benefits expected there from. So, long as deferred revenue expenditure is not written off, this is shown on the assets side of the balance sheet under the head "Miscellaneous Expenditure."

Deferred revenue expenditure should be revenue expenditure by nature in the first instance, for example, advertisement. But its matching with revenue may be deferred considering the benefits to be accrued in future.

Difference between capital expenditure, Revenue expenditure and Deferred Revenue expenditure

Following table shows the difference between capital expenditure, revenue expenditure and deferred revenue expenditure

9.10 LET US SUM UP

To sum up, one can say that the difference between capital and revenue expenditures lies between the duration of the benefit that accrues from such expenditure. The benefit of the revenue expenditure accrues in the year in which it is incurred while the capital expenditures' benefit is received over a number of years i.e. a long period of time. Hence the revenue expenditures are given treatment in the accounts of the same year in which they are incurred while in case of capital expenditures only a part of these are given treatment in a particular year and the rest is shown in the balance sheet as an asset till the full amount gets amortized over a fixed number of years.

10.0 OBJECTIVES

10.1 INTRODUCTION

Fixed assets purchased and owned by every business concern such as plant, machinery, tools, buildings, leasehold, furniture etc. gradually diminish in value as they get old and become worn out by constant use in the business. Except in a few cases (e.g. land, antiques etc.) all assets depreciate. Though current assets may also lose value, the term depreciation is used only in respect of fixed assets.

According to the Matching principle, the revenue of a given period is matched against the expenses for the same period. This ensures calculation of the correct amount of profit or loss. If some cost is incurred whose benefits extend for more than one accounting period then it is not justified to charge the entire cost as expense in the year in which it is incurred. Rather such a cost must be spread over the periods in which it provides benefits. Depreciation also deals with such a situation.

Further, it may not always be possible to ascertain with certainty the amount of some particular expense. The principle of conservatism (prudence) requires that instead of ignoring such items of expenses, adequate provision must be made and charged against profits of the current period. Moreover, a part of profit may be retained in the business in the form of reserves to provide for growth, expansion or meeting certain specific needs of the business in future.

10.2 MEANING AND DEFINITION

The term depreciation has been derived from the Latin words 'de' (which denotes down) and 'pretium' (which denotes price). In common use depreciation means fall in the quality, quantity or value of an asset due to wear the tear, passage of time, obsolescence, etc. The net result of an asset's depreciation is that sooner or later the asset will become useless.

It is not easy to give a comprehensive definition to the term depreciation because under different situations it is treated differently and whatever seems to be correct in one situation may not be proper in other.

But even then some definitions are worth mentioning.

- 1. "Depreciation is the gradual and permanent decrease in the value of an asset from any cause".-R. N. Carter
- 2. "Depreciation refers to the process of estimating and recording the periodic charges to expense due to the expiration of the usefulness of a capital asset". Malchman and Salvin
- 3. "Depreciation is a permanent, continuing and gradual shrinkage in the value of a fixed asset". A. N. Aggarwal
- 4. "Depreciation means, "A permanent and continuing elimination in the quantity, quality or value of an asset".- William Pickles
- 5. "Depreciation represents loss or diminution in the value of an asset consequent upon wear and tear, obsolescence, effluxion of time, or fall in the market value". J. R. Batliboi
 - From the above definitions it is clear that depreciation is the gradual, continuing and permanent fall in the quality, quantity or value of an asset.

10.3 CAUSES OF DEPRECIATION

The causes which necessitate the provision of depreciation are given below:-

- I. **Usage of asset:** The main cause of depreciation is the wear and tear of assets as they are put to use in an organisation. It results in reduction of the future earning power as well as technical capacity of the asset due to which its value gets reduced.
- II. **Losses:** Another important factor contributing to depreciation is accidents such as plant break-down, loss by fire etc.

- III. **Obsolescence:** Due to technological developments, the asset in use may become out-dated and loose a large part of its value. This fall may also be due to changes in the supply and location of material resources, etc.
- IV. **Depletion:** Where the asset is of wasting character such as mine, quarry or oil-well etc., the asset will be depleted due to the extraction of its contents.
- V. **Expiration of Certain Ledger Rights:** In case of patents, leases and licences depreciation is a time function as by the expiration of time for which the legal right to use is created lapses.
- VI. **Physical factors:** these include cases like Evaporation of liquid, loss of potency of chemicals and erosion.

10.4 FACTORS DETERMINING DEPRICIATION:

The following factors must be kept in mind while determining the amount of depreciation

- (a) The original cost of the asset, which includes the purchase price of the asset, freight, installation charges, cost of subsequent improvements in the asset etc.
- (b) The probable working life of the asset in terms of time(years or months or hours)or output (units, mileage etc.).
- (c) The estimated break-up, or residual value or scrap value i.e. what the asset will fetch when condemned or discarded.
- (d) The amount likely to be spent on repairs and renewals to keep the fixed asset in proper working condition.
- (e) The possibility of the asset becoming obsolete due to new inventions, improvements, loss of demand due to change in fashion etc.
- (f) The statuary provisions of the Indian Companies Act, and the Indian Income Tax,1961 must be kept in mind while determining the amount of annual depreciation.

10.5 1.5 REASONS FOR PROVIDING DEPRECIATION:

The need for providing depreciation arises due to the following reasons:-

- **1. Ascertaining true profit or loss:** The true profit of an enterprise can be ascertained when all costs incurred for the purpose of earning revenues have been debited to the profit and loss account. Fall in the value of assets used in business operations is a part of the cost and should be shown in the profit and loss account of concerned accounting period. Keeping this in view, depreciation must be debited to profit & loss account, since loss in value of fixed assets is also an expense like other expenses.
- **2. Presentation of True and Fair value of assets :** If depreciation is not provided, the value of assets shown in Balance sheet will not present the true and fair value of assets

because assets are shown at the cost price but actual value is less than cost price of the assets.

- **3. To ascertain the accurate cost of the production :** Depreciation is an item of expense, the correct cost of production cannot be calculated unless it is also taken into consideration. Hence, depreciation must be provided to ascertain the correct cost of production.
- **4. Computation of correct income tax :** Income tax of an enterprise is determined after charging all the costs of production. If depreciation is not charged, the profits will be higher and the income tax will also be higher. If depreciation is charged, Tax liability is reduced.
- **5. Provision of funds and replacement of assets:** Deprecation is a non cash expense. So that amount of depreciation charged to profit and loss accounts is retained in business every year. These funds are available for replacement of the assets when its useful life is over.
- **6. To keep the capital intact:** The downfall in the value of fixed assets due to passage of time and wear and tear must be charged to profits before they are distributed, otherwise the distributed profits may have a portion of capital in it.

10.6 ACCOUNTING ENTRIES

Under this method, the Asset Account is not credited with the amount of depreciation, instead provision for depreciation account is credited. The asset appears in the balance sheet at its original cost and it changes only on its sale, addition or when discarded. Provision for Depreciation Account which reflects accumulated depreciation to date is either shown on the liabilities side of the balance sheet or is deducted from the value of asset in the balance sheet.

When an Asset is sold, the depreciation to the date of sale is transferred from provision for Depreciation Account to the Asset Account, as a result of which the fixed asset is brought down to its written down value.

Provision for Depreciation Account Dr

To Asset Account

The difference between the sale price and the written down value of the asset is profit or loss on sale. In case the sale price exceeds the written down value of the asset, there shall be a profit on sale.

11.6 METHODS OF PROVIDING DEPRECIATION: The method of depreciation to be used for a particular asset depends upon the nature of business, nature of fixed assets, policy of the management and the various laws affecting the depreciation. The following are some of the important methods of providing depreciation on fixed assets:

- 1. Fixed Instalment Method.
- 2. Reducing Balance Method.
- 3. Annuity Method.
- 4. Sum of the (years) Digits Method.
- 5. Depreciation Fund Method.
- 6. Insurance Policy Method.
- 7. Revaluation Method.
- 8. Machine Hour Rate Method.
- 9. Mileage Method.
- 10. Depletion Method.

1. FIXED INSTALLMENT METHOD/ STRAIGHT LINE METHOD

This method is also known as 'Original cost method' or 'Constant Charge Method'. Under this method, depreciation is charged at fixed percentage on the original cost of the asset, throughout its estimated life. The amount of depreciation is uniform from year to year. That is why this method is also known as 'Fixed Installment Method' or 'Equal Installment method'. The annual amount of depreciation can be easily calculated by the following formula:

Annual Depreciation = <u>Original cost - Estimated scrap value</u>
Estimated life

Advantages:

- 1. It makes calculation of depreciation simple.
- 2. It can write down the asset to zero at the end of its working life.
- 3. It equalizes the burden of depreciation over different years.
- 4. The fixed assets are shown at their true worth in the Balance Sheet as the amount of depreciation is generally deducted from fixed assets.

Disadvantages:

- 1. It reduces the book value of an asset to zero although the asset may still be in existence.
- 2. It does not take into account the interest on the investment in fixed assets.
- 3. While the charge for depreciation remains constant year after year, the expenses on repair and renewals become larger as the assets grow old, due to which the profit and loss account, in the later years, bears more than its due share of burden
- 4. The annual charge for depreciation remains the same, irrespective of the use of fixed assets.

This method, however, is suitable for depreciating assets like, short leases, patents, furniture and fixtures, plant and machinery, building etc.

ILLUSTRATION-1

From the following information you are required to calculate depreciation rate:

Cost of the Machine Rs.60,000 Erection Charges Rs.6,000 Estimated useful life 10 years Estimated Scarp Value Rs. 6,000

Solution:

Calculation of depreciation rate for every year:

Depreciation = <u>Original Cost of Asset - Scrap Value</u> Estimated Life of an Asset

Thus, the amount of depreciation would be Rs. 6,000 for every year.

ILLUSTRATION-2

A machine costing Rs. 40,000 was purchased on 1st April, 2011. Its estimated working life is four years while its scrap value is estimated at Rs. 8,000. Show Machinery account for four years.

The annual amount of depreciation is 8,000.

Amount of Depreciation=original cost of asset-scrap value/estimated working life of the asset

=40,000-8,000/4=Rs. 8,000

Alternatively

The amount of annual depreciation may be calculated as a fixed percentage on the original cost of the asset less scrap value. The rate of depreciation may be computed by the following formula

R=D/C X100

Here, R stands for percentage rate of depreciation.

D stands for annual depreciation. And C stands for original cost of the asset.

Illustration -3

A company, whose accounting year is the calendar year purchased on 1st April, 2011 machinery costing Rs. 30,000. It purchased further machinery on 1st October, 2011 costing Rs. 20, 000 and on 1st July, 2012 costing Rs. 10,000.

On $1^{\rm st}$ January, 2013 one third of the machinery installed on $1^{\rm st}$ April, 2011 became obsolete and was sold for Rs. 3,000. Show how Machinery Account would appear in the books of the company, it being given that machinery was depreciated by fixed installment method at 10% per anum. What would be the balance of machinery account on $1^{\rm st}$ January, 2014.

2. DIMINISHING BALANCE METHOD

This method is also known as Fixed Percentage on Declining Base Method (or) Reducing Installment Method. Under this method depreciation is charged at fixed rate on the reducing balance (i.e., Cost less depreciation) every year. Accordingly the amount of depreciation gradually reduces every year. The depreciation charge in the initial period is high and negligible amount in the later period of the asset. The following formula used for computing depreciation rate under Written-Down Value Method.

$$R = 1 - (\underline{S})$$

Where R = Rate of Depreciation

S = Estimated Scrap Value

N = Estimated Life of the Asset

C = Original Cost of the Machine or Asset

Advantages:

- **a.** It is simple to understand and easy to use.
- **b.** It provides for constant burden on profit and loss account for depreciation and repair charges throughout the life of assets, because the high depreciation is balanced

by low repairs in the earlier years and low depreciation balances high repairs required as the asset goes older.

- **c.** Fresh calculation are not required if any additions are made in the subsequent year.
- **d.** It is recognized by Income Tax Authorities.

Disadvantages:

- a. Like the Original Cost Method, this method also ignores interest on capital invested in the asset.
- b. In the subsequent years, original cost of the asset is altogether lost sight of and the asset can never be reduced to zero under this method. Some balance, though insignificant, remains in the Asset Account at the end of asset life.
- c. It is rather difficult to identify the individual asset if there are frequent additions. This method is very useful for plant and machinery where additions and extensions take place very often. This method will not be used for those assets whose value is to be reduced to zero, i.e., patents, etc. The journal entries in this method are similar to those under the first method.

Illustration 5: A company bought Machinery for Rs. 20,000 including therein a boiler worth Rs. 2,000. The Machinery Account had been credited for depreciation on the diminishing balance method for the past four years at the rate of 10% per annum. In the beginning of the fifth year, the boiler became useless on account of damage to some of its vital parts. The damaged boiler is sold for Rs. 400 which was credited to Machinery Account. The Machinery Account is to be adjusted by taking into consideration the loss on account of the damaged boiler. Prepare the Machinery account.

3. ANNUITY METHOD

This method is most suitable for a firm where capital is invested in the least hold properties. Under this method, while calculating the amount of depreciation, a fixed amount of depreciation is charged for every year of the estimated useful life of the asset in such a way that at a fixed rate of interest is calculated on the same amount had been invested in some other form of capital investment. In other words, depreciation is charged for every year refers to interest losing or reduction in the original cost of the fixed assets. Under the annuity method where the loss of interest is due to the investment made in the form of an asset is considered while calculating the depreciation. The amount of depreciation is calculated with the help of an Annuity Table.

Advantages

- 1. It is a scientific method.
- 2. It treats the purchase of an asset as an investment in the business itself and charges interest on the same.

Disadvantages

- 1. Additions to the asset are sure to throw out the calculations already made.
- 2. No funds are available at the end for replacement of the asset.
- 3. The total charge of depreciation and repairs put together does not remain fairly uniform from year to year.
- 4. Rate of interest is arbitrary.

Suitability

This method is mainly used in case of costly leases of long periods and other assets to which additions are not usually made and as such, in case of machinery, this method is not found suitable.

4. THE SUM OF THE (YEARS) DIGITS METHOD

This method also termed as SYD Method. The Sum of years Digits Method is designed on the basis of Written-Down Value Method. Under this method the amount of depreciation to be charged to the Profit and Loss Account goes on decreasing every year throughout the life of the asset. The formula for calculating the amount of depreciation is as follows:

Remaining Life of the Asset (Including current year)

Rate of Depreciation =-----x Original Cost of the Asset

Sum of all the digits of the life of the assets in years

Illustration 8:-

5. DEPRECIATION FUND METHOD

It is also called Sinking Fund Method. Like the Annuity Method, the amount of depreciation is charged with the help of Sinking Fund Table. Under this method an amount equal to the amount written off as depreciation is invested in outside securities in order to facilitate to replace the asset at the expiry useful life of the asset. In other words, the amount of depreciation charged is debited to depreciation account and an equal amount is credited to Sinking Fund Account. At the estimated expiry useful life of the asset, the amount of depreciation each year is invested in easily realizable securities which can be readily available for the replacement of the asset.

| Depreciation on the plant for its whole life | <u>3,60,000</u> |

The amount charged to the Profit and Loss Account = 3,60,000 *0.317208 = Rs. 1,14,194.88

6. INSURANCE POLICY METHOD

Under this method an asset to be replaced by taking required amount of insurance policy from an Insurance Company. A fixed premium is paid which is equal to the amount of depreciation for every year. At the end of the agreed sum, i.e., on the maturity of the policy, the amount will be used for replacing the existing assets.

The most important feature of this method is that it endeavours the supply of required cash at the retirement of a specified asset and the asset is also insured. At maturity the insurance company pays the policy money which is normally sufficient to replace the old asset.

Advantages

- 1. The difficulty of purchasing investment and reinvesting the interest received is done away with, since it is a major problem with the Depreciation Fund Method.
- 2. There are no chances of a fall in the value of insurance policy at its maturity.

- 3. The asset is fully insured under this method.
- 4. It is simple to understand.

Disadvantages

- 1. There is an unbalanced burden on Profit & Loss Account of constant depreciation and increasing repairs year after year.
- 2. There are no chances of realizing additional amount of profit as it is in the case of Depreciation Fund Method when the investments are sold.

This method is adopted in those cases where Depreciation Fund Method can be used.



7. REVALUATION METHOD

This method is specially designed to revalue the assets whose life span cannot be estimated correctly like in the case of livestock, loose tools, patents, bottles, corks, packages, trademarks, cutlery, crockery etc. This method is also termed as Appraisal Method. The calculation of depreciation of these assets is valued at the end of the accounting year. The difference between the value as per the last balance sheet and the present estimated value represents depreciation. In case, the present estimated value of an asset is more than the value as per the last balance sheet, the difference would be treated as appreciation. The depreciation of assets revalued will be debited to Profit & Loss A/c and credited to Asset A/c. It is very simple method.

This method provides a different amount of depreciation chargeable to Profit & Loss A/c each year and moreover, the revaluation of assets is based on market value and not on the cost price which is against the basic principles of depreciation.

Illustration 12: A firm had purchased loose tools costing Rs. 62500 on 1st April, 2011. The tools were independently valued at the end of every year and the values placed on them were as under:-

8. MACHINE HOUR RATE METHOD

This method is similar to the Depletion Method but instead of taking estimated available quantities in advance, the working life of the machine is estimated in terms of hours. Hourly depreciation = Original cost of the machine – Scrap value

Estimated total hours of machine life

This is the charge for depreciation on that machine during the year. Special characteristic of this method is that the life of the machine is calculated in hours for which it will be used, not in years.

Illustration 14:

A machine was purchased on 1^{st} Jan. 2011 at a cost of Rs. 3,00,000, the cost of installation being Rs. 20,000. The estimated working life of the machine was 80,000 hours. During 2011 it was worked for 10,000 hours and during 2012 for 20,000 hours. You are required to prepare Machine Account for the above said years.

Solution:

Calculation of Machine Hour Rate:

Machine Hour Rate = Cost of the Machine
Estimated Total Hours of Life

= <u>Rs. 3,00,000 + Rs. 20,000</u> Rs.80,000 = <u>Rs. 3,20,000</u> Rs. 80,000

= Rs. 4 Per hour.

9. MILEAGE METHOD

This method is used only for those assets useful life of which depends upon the fact as to how many kiolmeters they have covered E.g. Trucks, Buses, Motor-cars etc. The depreciation of such assets depends upon the number of kilometres covered by them during a given period.

Original Cost of the asset

Depreciation per kilometre = _____

Estimated life of the vehicle in kilometres

The Depreciation for one kilometre is multiplied by the number of kilometres of one year for which the vehicle has been driven and thus depreciated for one year is computed. E.g. a truck costing rs. 60,000 was purchased and its useful life was estimated to be 2,40,000 kms.

The rate of depreciation = $\underline{\text{Rs. }60,000}$ = Re. 0.25 per km. 2.40.000 kms.

And suppose during the year it operates for 50,000 kms, the amount of depreciation for the year will be $50,000^*$ Re. 0.25 = Rs. 12,500.

10. DEPLETION METHOD

Depletion Method is mostly used for natural resources such as mines, quarries, oil and gas etc. from which certain quantity of the resources can be obtained on the basis of the

availability of minerals. The quantity of output exhaust to reaches a stage of depletion. Under this method, an estimate is made about the total quantity of the natural resources and then the depreciation is found in the following manner:

Dereciation = Original Cost * Output in tons of one year

Estimated life in terms of production units

The cost of natural resources is the price paid for its acquisition, plus price paid for development of such asset so that it is made suitable for production.

Illustration 15: Shikha bought a mine for Rs. 1,00,000. Its scrap value is Rs. 10,000 and its working life is 9 years. 1,80,000 units were expected to be produced during its working life. 10,000 units in the first, 25,000 units in the second and 50,000 units in the third year were produced. Find out the amount of depreciation for 1^{st} year, 2^{nd} year and 3^{rd} year.

Solution: -

Depreciation per unit = $\frac{1,00,000 - 10,000}{1,80,000}$ = Re. 0.50

Depreciation for different years: -

10.7 DEPRECIATION OF VARIOUS ASSETS

The following recommendations are made, in brief, for dealing with depreciation of various types of fixed assets: -

- (a) Goodwill: Generally, no depreciation arises unless the firm's profits are decreasing. Prudent firms try to write off goodwill over a number of years. The amount written off should be shown separately in the Profit & Loss A/c.
- (b) Freehold Land: In this case also no depreciation arises. Amounts written off should be shown separately.
- (c) Freehold Buildings, Plant & Machinery, Ships etc. Either of the straight line method and reducing installment method may be adopted as long as the asset is written off during its effective life.
- (d) Leasehold Lands and Buildings: The straight line method, to write off the asset together with its cost of dilapidation (if any) within its life, is the most suitable method to follow.
 - In case of (c) & (d) above, the depreciation method providing funds for replacement can be profitably used.
- (e) Loose Tools, Jigs and Patterns: Depreciation should be calculated by the Revaluation method.
- (f) Patents, trade Marks, etc.:- There is maximum legal life of such assets but the commercial life (during which such assets can be effectively exploited) may even be shorter. The asset should be depreciated by the straight line method so that it is written off within the legal or commercial life whichever is shorter.

(g) Mines, Oil wells, Quarries, etc.: - The depreciation should be calculated by the depletion method, though traditionally no depreciation is allowed on such assets by taxation authorities.

10.8 LET US SUM UP

The method of providing depreciation on a particular asset should be consistent from year to year. If no depreciation has been charged in a particular year, the fact should be stated in the Balance sheet and the Profit & Loss A/c. If the method of charging depreciation is changed, the fact should be disclosed, together with the amount of the depreciation that should have been charged, had the old system been followed. Further, if adjustment is made for previous years also, the amount involved should be debited or credited separately in the Profit and Loss A/c, preferably in the appropriation section.

10.9 KEY WORDS

Depreciation: Depreciation is the gradual and permanent decrease in the value of an asset from any cause.

Diminishing Balance Method: Under this method depreciation is charged at fixed rate on the reducing balance (i.e., Cost less depreciation) every year. Accordingly the amount of depreciation gradually reduces every year.

11.0 OBJECTIVES

11.1 INTRODUCTION

In the previous lesson we had discussed about depreciation accounting and this lesson deals with another very important concept i.e. Provisions and Reserves. Normally in business firms, many expected and unexpected eventualities occur, which are supposed to be taken care of well in time in order to conduct the business operations smoothly. Here comes the role of provisions and reserves. Provisions and reserves are created at the time of the preparation of financial statements.

Basically provision in accounting refers to money written off to cover possible depreciation of assets and other liabilities. Such write-offs also cover the expected losses and contingencies of a firm. On the other hand 'reserves' refers to the amount of

money that remains after provisions and other fees have been deducted from the budget. Such money typically belongs to the business owners.

11.2 INTRODUCTION TO PROVISION

The term 'provision' means an amount, which is: written off, or retained, by way of providing for depreciation, renewals, diminution in the value of assets; or retained by way of providing for any unknown future liability of which the amount cannot be determined with reasonable accuracy.

It becomes important to create provision of the expenses those which are not known with certainty. Many a times it happens that in normal business working, certain expenses/losses which are related to the current accounting period but amount of which is not known with certainty because they are not yet incurred. The provision is created so that true profits can be calculated.

For example, a trader who sells on credit basis knows that some of the debtors of the current period would default and would not pay or would pay only partially. It is necessary to take into account such an expected loss while calculating true and fair profit/loss according to the principle of Prudence or Conservatism. Therefore, the trader creates a Provision for Doubtful Debts to take care of expected loss at the time of realisation from debtors. Similarly when it is known that the assets which a business firm uses will be depreciated due to wear and tear or other reasons, a provision becomes a must so as to arrive at the true value of the asset as well as to calculate true profits, In a similar way, provision for repairs and renewals may also be created to provide for expected repair and renewal of the fixed assets.

Examples of provisions are:

- Provision for depreciation;
- Provision for bad and doubtful debts;
- Provision for taxation:
- Provision for discount on debtors; and
- Provision for repairs and renewals.

Creation of provision ensures proper matching of revenue and expenses and hence the calculation of true profits. Provisions are created by debiting the profit and loss account The amount of provision for expense and loss must be charged against the revenue of the respective current period only. In the balance sheet, the amount of provision may be shown either: (a) by way of deduction from the concerned asset on the assets side. For example, provision for doubtful debts is shown as deduction from the amount of sundry debtors and provision for depreciation as a deduction from the concerned fixed assets; or (b) On the liabilities side of the balance sheet along with current liabilities, for example provision for taxes and provision for repairs and renewals.

11.3 ACCOUNTING TREATMENT FOR PROVISION

As stated earlier the provision is to be charged in the books in the same year in which it is created. This section deals with the accounting treatment of the provisions.

The accounting treatment of all types of provisions is almost similar. Therefore, the accounting treatment is explained here taking up the case of provision for doubtful debts. As already stated that when business transaction takes place on credit basis, debtors account is created and its balance is shown on the asset-side of the balance sheet. These debtors may be of three types:

- Good Debtors are those from where collection of debt is certain.
- Bad Debts are those debtors from where collection of money is not possible and the amount of credit given is a certain loss.
- Doubtful Debts are those debtors who may pay but business firm is not sure about the collection of full amount from them. As a matter of business experience, some percentage of such debtors is not likely to pay, hence treated as doubtful debts. To consider this possible loss on account of non-payment by some debtors, it is a common practice (and necessary also) to make a suitable provision for doubtful debts at the time of ascertaining true profit or loss.

The provision for doubtful debts is usually calculated as a certain percentage of the total amount due from sundry debtors after deducting/writing-off all known bad debts. Provision for doubtful debts is also called 'Provision for bad and doubtful debts'. It is created by debiting the amount of required provision to the profit and loss account and crediting it to provision for doubtful debts account.

For creating a provision for doubtful debts the following journal entry is recorded:

Profit and Loss A/c----- Dr. (with the amount of provision)

To Provision for doubtful debts A/c

The bad debts arising during the year are first written off from the 'provision for doubtful debts' account. In doing so, the opening balance outstanding to the credit of the provision for doubtful debts account may not be sufficient to meet the current amount of bad debts as also the requirements of future doubtful debts. This deficit is to be provided for at the end of the year by a charge to the profit and loss account.

In case, the annual amount provided for is to be adjusted for any unused surplus representing credit balance. The following are the journal entries required when the provision for bad debts exists in the books:

PROVISION FOR DISCOUNT ON DEBTORS

Generally when the money is collected from the debtors they are for discount. A business firm usually allows this cash discount to their customers. Once it is known out of experience that an X amount of discount is usually allowed, then in order to calculate the true profits it is advisable to create a provision for discount on debtors with that X amount. The tenure of the

cash discount period may spilt-over into the following accounting year for the sales made during the current year. The accounting treatment is given here as under;

11.4 RESERVES

A part of the profit may be set aside and retained in the business to provide for certain future needs like growth and expansion or to meet future contingencies such as workmen compensation. Unlike provisions, reserves are the appropriations of profit to strengthen the financial position of the business. Reserve is not a charge against profit as it is not meant to cover any known liability or expected loss in future. However, retention of profits in the form of reserves reduces the amount of profits available for distribution among the owners of the business. It is shown under the head Reserves and Surpluses on the liabilities side of the balance sheet after capital. Examples of reserves are:

- General reserve:
- Workmen compensation fund;
- Investment fluctuation fund;
- Capital reserve;
- Dividend equalisation reserve;
- Reserve for redemption of debenture.

Types of Reserves

A reserve is created by retention of profit of the business can be for either a general or a specific purpose.

- **1. General reserve:** When the purpose for which reserve is created is not specified, it is called General Reserve. It is also termed as free reserve because the management can freely utilise it for any purpose. General reserve strengthens the financial position of the business. The creation and maintenance of general reserve helps in realizing certain well recognized purposes especially from the view point of financial management.
- Improvement of the general financial position of the business by conserving resources, which would have otherwise been frittered away at the expense of prudent management.
- Arrangement for meeting unforeseen and abnormal losses irrespective of their nature.
- Providing avenues for the further expansion of business operations.

General reserve is created by debiting the profit and loss appropriation account and crediting general reserve account. The latter account is placed on the liabilities side of the balance sheet. When the balance on this account is used for any purpose, general reserve account is debited. Any such use of general reserve has to be stated in some way in the balance sheet. A number of provisions have been included in the companies Act for the regulation, creation and utilization of general reserve. This underlines the importance attached to it in the functioning of corporate enterprises. A word of caution about the commonly perceived role of general reserve is necessary.

General reserve is widely regarded as a means of strengthening the overall financial position of the business entity. However, this depends upon the proper valuation of the assets and liabilities of the business. In case assets and liabilities are properly valued, the balance on general reserve is indicative of the financial health of an enterprise but it is not so in the absence of this vital condition.

- **2. Specific reserve:** Specific reserve is the reserve, which is created for some specific purpose and can be utilised only for that purpose. There can possibly be any number of reserves in business, every one of them characterized by some peculiar feature dictated by the specific purpose which they are meant to serve. However, there are some common characteristics shared by them: -
- they are sharply focused from the viewpoint of their use because they are built up for some specific purpose or the other.

• a business-like approach to the management of these reserves may require that their balances be invested outside the business. All specific reserves are presented on the liabilities side of the balance sheet, as they are credit balances. When any specific reserve is utilized, the amount drawn upon is debited to the account of the reserve concerned. The reserves are credited at the time of the preparation of financial statements by allocations decided to be made to them by management and the corresponding credit is given to profit and loss appropriation account.

Examples of specific reserves are given below:

- (i) Dividend equalisation reserve: This reserve is created to stabilise or maintain dividend rate. In the year of high profit, amount is transferred to Dividend Equalisation reserve. In the year of low profit, this reserve amount is used to maintain the rate of dividend.
- (ii) Workmen compensation fund: It is created to provide for claims of the workers due to accident, etc.
- (iii) Investment fluctuation fund: It is created to make for decline in the value of investment due to market fluctuations.
- (iv) Debenture redemption reserve: It is created to provide funds for redemption of debentures.

Reserves are also classified as revenue and capital reserves according to the nature of the profit out of which they are created.

3. Revenue reserves: Revenue reserves are created from revenue profits which arise out of the normal operating activities of the business and are otherwise freely available for distribution as dividend. All distributable profits are not always available for paying dividend since a certain amount may be required to be kept aside either by law (minimum) or as a managerial decision (higher amount) for business needs. It is only after this that profit will be available for distribution by way of dividend.

Examples of revenue reserves are:

- General reserve;
- Workmen compensation fund;
- Investment fluctuation fund;
- Dividend equalisation reserve;
- Debenture redemption reserve;
- **4. Capital reserves:** Capital reserves are created out of capital profits which do not arise from the normal operating activities. Such reserves are not available for distribution as dividend. These reserves can be used for writing off capital losses or issue of bonus shares in case of a company.

Capital reserve comes into existence from out of the capital profits arising from:

- profits emerging from the revaluation of fixed assets after observing all restrictions;
- profits accruing on the sale of fixed assets;
- profits from the re-issue of share once forfeited by a company's
- issue of shares at premium
- profits arising at the time of amalgamation and absorption of companies
- profit prior to incorporation of a company;
- Creation of capital Redemption Reserve upon the redemption preference shares.

Capital reserves, always have credit balance which are shown on the liabilities side of the balance sheet. Whenever this reserve is utilized, capital reserve account is debited. It is also required that the manner of the utilization of capital reserve during an accounting period must be clearly stated in the balance sheet either in its body itself or by way of a foot-note to the financial statements. This is due to the reason that there are rigid restrictions, both laid down by law and enforced by accounting standards, on the use of capital reserve.

Difference between Revenue and Capital Reserve

Revenue reserves and capital reserves are differentiated on the following grounds:

Importance of Reserves

Creation of reserve is important in the sense that a business firm consider it proper to set up some mechanism to protect itself from the consequences of unknown expenses and losses, it may be required to bear in future. It may also regard it as more appropriate in certain cases to reduce the amount that can be drawn by the proprietors as profit in order to conserve business resource to meet certain significant demands in future. An example of such a demand is the much needed expansion in the scale of business operations. This is presented as the justification for reserves in business activities and in accounting. The amount so set aside may be meant for the purpose of:

- Meeting a future contingency
- Strengthening the general financial position of the business;
- Redeeming a long-term liability like debentures, etc.

11.5 SECRET RESERVE

Secret reserve is a reserve which does not appear in the balance sheet. It may also help to reduce the disclosed profits and also the tax liability. The secret reserve can be merged with the profits during the lean periods to show improved profits. Management may resort to creation of secret reserve by charging higher depreciation than required. It is termed as 'Secret Reserve', as it is not known to outside stakeholders. Secret reserve can also be created by way of:

- Undervaluation of inventories/stock
- Charging capital expenditure to profit and loss account
- Making excessive provision for doubtful debts
- Showing contingent liabilities as actual liabilities

Creation of secret reserves within reasonable limits is justifiable on grounds of expediency, prudence and preventing competition from other firms. The biggest advantage is that business concern is enable to absorb any unexpected losses without the information to public. Further it helps the firm in maintaining the rate of dividend during adverse trading conditions without disclosing this matter to the public. The entry of the competing business firms may be avoided by using secret reserve.

There are certain drawbacks as well. Management may utilize this reserve to cover their mistakes or misdeeds. Presence of secret reserve makes the financial statements not to disclose a true and fair view of the financial position of the enterprise. Creation of secret reserve is not a healthy practice as it leads to violation of accounting assumption.

RESERVE FUND

A reserve fund is usually created either to replace a fixed asset at the end of its useful life or to repay a liability in the future, e.g. redemption of debentures etc.

Funds are cash or cash equivalents. In accounting, the term 'fund' means money invested in assets which can produce income, e.g. securities. It should have a ready market and can easily be converted into cash. Funds also refer to assets for specific purposes, which are not generally available for normal business activities, a fund sets aside cash or other assets to achieve specific objectives. Reserves are not usually represented by earmarking assets, if they are , they are expressed as 'reserve fund'. A reserve represented by an earmarked asset is usually cash or marketable securities. For example, if an organization set aside profits for building construction, the reserve so

created is known as 'building funds'. When an amount equal to the reserve created is invested outside the business in securities, the reserve so created is known as 'building fund'.

11.6 DIFFERENCE BETWEEN RESERVE AND PROVISION

According to Subhash Chandra Das, provision means providing an amount for unknown liability which cannot be determined with accuracy. Provisions are charged to profit and loss account, As per Indian Companies Act, the provision shall mean any amount written-off or retained by providing for depreciation, renewals or diminution in value of assets, or retained by providing or known liability which cannot be determined with substantial accuracy. The provisions are created to take care of decrease in asset or increase in liability. Whereas 'reserve' refers to undistributed profit used for meeting some liability. It is created out of profit by appropriating profit for redemption of liability. For example, preference shares, debentures, or for replacing assets. Reserve is the amount which is in excess of provision.

However, following table explains the points of difference between reserve and provision:

11.7 LET US SUM UP

The assumption of going concern states that the business is to continue for the long period. This it becomes important to consider current as well as future contingencies into account while ascertaining the profit for the year. Provisions and reserves are related to future needs of the business firm for which part of current earning must be set aside while preparing final accounts. Provision refers to the amount retained by way of providing for a definitely existing liability whose amount can not be determined accurately. It is created in order to provide funds for the known liability in future, to calculate the correct net profits, to find out the true financial position, and for equitable distribution of expenses. Reserve is the amount set aside of the profits with a view to strengthen the financial position of the business entity. The reserve can be general reserve, specific reserve contingency reserve, reserve for expansion, investment fluctuation reserve, workmen compensation reserve, etc. Besides strengthening the financial position of the business reserve is helpful in meeting future unanticipated loss, equalizing dividends, fulfilling specific purpose like debenture redemption etc.

11.8 KEY WORDS

Provision: Provison is any amount written-off or retained by providing for depreciation, renewals or diminution in value of assets, or retained by providing or known liability which cannot be determined with substantial accuracy. The provisions are created to take care of decrease in asset or increase in liability.

Reserve: Reserve refers to undistributed profit used for meeting some liability. It is created out of profit by appropriating profit for redemption of liability. For example, preference shares, debentures, or for replacing assets. Reserve is the amount which is in excess of provision.

Secret Reserve: The reserve which cannot be disclosed in the balance sheet is known as secret reserve. This reserve may be created by (a) charging excess depreciation, (b) showing contingent liability as real liability and (c) excess provision for bad and doubtful debts etc.

General Reserve: This reserve is created to meet any future contingency to provide additional working capital.

Specific Reserve: This reserve is created for specific purpose, for example, capital redemption reserve and so on.

Reserve Fund: A reserve fund is usually created either to replace a fixed asset at the end of its useful life or to repay a liability in the future, e.g. redemption of debentures etc.

12.1 INTRODUCTION

The basic objective of preparing financial records is to see whether the business is in profit or loss. For this the entire accounting cycle is followed. As discussed in previous lesson that the transactions of a business enterprise are first recorded in the journal, then posted there from into the ledger and lastly a trial balance is prepared to test their arithmetical accuracy. From the trial balance final accounts are prepared. Preparation of final account is the last stage of the accounting cycle. It helps businessman to ascertain the financial position of his business firm as a whole during the particular period. Final accounts include Manufacturing and Trading, Profit and Loss Account and Balance Sheet. The determination of profit or loss is done by preparing a Trading, Profit and Loss Account. The purpose of preparing the Balance Sheet is to know the financial

soundness of a concern as a whole during the particular period. In this lesson we will learn how the statements of the financial position are prepared after preparing manufacturing account, trading account and profit and loss account.

12.2 DEFINITIONS OF FINANCIAL STATEMENT

According to **John N.Myer** "The financial statements provide a summary of the accounts of a business enterprise, the Balance sheet reflecting the assets and liabilities and the Income statement showing the results of operations during a certain period."

These final accounts consist of financial statements that are discussed as follows:

- 1. Trading Account, Profit and loss account, and
- 2. Balance Sheet.

12.3 MANUFACTURING ACCOUNT

Manufacturing account is prepared by the business enterprises that are engaged in manufacturing activities. In order to ascertain the cost of goods manufactured, the manufacturing account is prepared. In this account, both direct and indirect expenses relating to the process of manufacturing are recorded (i.e., debited to this account). The manufacturing account is closed by transferring its balance (cost of goods produced) to the trading account.

12.4 TRADING ACCOUNT

Trading account is a constituent of financial statements. In practice, it is treated along with Trading and Profit and Loss Account, as one account and one unit. Trading account is prepared to know whether a business enterprise has earned profit or suffered loss. Gross profit or gross loss is the difference between cost of goods and sales. Therefore, for preparing a trading account, we need to know:

- (1) Net sales revenue=Cash sales + Credit sales Sales return
- (2) Cost of Goods Sold= Opening stock + Net Purchases Closing stock + Direct expenses
- (3) Net purchases = Cash purchases + Credit purchases Purchases return
- (4) Gross profit= Net Sales Revenues- Cost of Goods sold

Items appearing on the debit side of the Trading Account:

- 1. Opening Stock: Stock In hand on the commencement of the year or period is termed as opening stock.
- 2. Purchases: It indicates total purchases both cash and credit purchases.
- 3. Purchases Returns or Returns Outwards: Purchases return are the goods sent back to the person from whom we have purchased the goods because of the defect in the goods or goods are not as per the order made. These are subtracted from the purchases to get the Net purchases.
- 4. Direct Expenses on Purchases: Some of the direct expenses are:
 - (a) Wages: It is also known as productive wages or manufacturing wages.
 - (b)Carriage or Carriage inwards
 - (c) Octroi duty: Duty paid to bring goods within municipal limits.
 - (d) Customs duty, dock dues, clearing charges, import duty etc.
 - (e) Fuel, power, lighting charges related to production
 - (f) Oil, Grease, waste

Items appearing on the credit side of the Trading Account:

- (a) Sales: It Indicates Total sales both cash and credit sales.
- (b) Sales Return or return: These are subtracted from the sales to get the Net sales.
- (c) Closing stock: The stock left at the end of the year.
- (d) Carriage outwards:

Balancing of Trading Account

The difference between two sides of Trading Account indicates either Gross profit or Gross Loss. If the total on the credit side is more, difference represents Gross Profit. On the other hand, if the total side of debit side is high, the difference represents Gross loss. The Gross profit or Gross loss is transferred to Profit and Loss Account.

Closing Entries of Trading Account:

Trading Account is a ledger account. Hence, no direct entries should be made in the trading account. Several Items such as Purchases, Sales are first recorded in the journal and then posted to ledger account. The same accounts are closed by transferring them to the trading account. Hence it is called closing entries. These are as follows:

1. For transfer of opening stock, net purchases and direct expenses to Trading account:

2. For transfer of net sales and closing stock to Trading Account:

Advantages of Trading Account: Following are the advantages of preparation of trading account:

- 1. The result of Purchases and sales can be clearly ascertained.
- 2. Gross profit ratio to sales can also be ascertained. It helps to determine price.
- 3. Gross profit ratio to direct expenses can also be ascertained. And so that unnecessary expenses can be eliminated.
- 4. Comparison of trading account details with previous year details help us to draw better administrative policies.

Differences between Trading Account and Manufacturing Account

A Trading Account differs from Manufacturing Account on the following aspects:

12.5 PROFIT AND LOSS ACCOUNT

The purpose of profit and loss account is prepared to ascertain the net profit or net loss suffered by a business enterprise during an accounting period. This account starts with gross profit on the credit side which is brought forward from the trading account. It is followed only by the items of revenue incomes and revenue losses. But profit or loss brought on sale of capital items is recorded here. After recording all items, both sides of the Profit and Loss account are totalled. If credit side total exceeds debit side, the difference is Net Profit. On the other hand, if debit side exceeds the credit side such difference is termed as Net Loss.

Some the terms that are frequently appearing in the preparation of Profit and Loss Account have to be understood in the proper context. They are as follows:

- **(1) Outstanding Income:** The amount which is due and not yet received. A person is entitled to receive the "outstanding income" once it becomes due legally.
- (2) Accrued Income: The amount which is earned but not yet due and receivable.

Items appearing on the debit side of Profit and Loss Account:

Followings are the items which are included in the debit side of profit and loss account.

- 1. Gross Loss: Gross loss is the debit balance of trading account which transferred to the profit and loss account.
- 2. Selling and distribution expenses: Expenses incurred for the promotion of sales and distribution of sold goods are selling and distribution expenses. Packing charge, carriage, freight outward, sales tax, forwarding charge, export duty, travelling expenses etc are the examples of selling and distribution expenses.
- 3. Administrative Expenses: Administrative expenses are those expenses which are incurred for day to day running of office management.
- 4. Financial Expenses: Financial Expenses are incurred for arranging fund to run the business. Cash discount allowed, interest on capital, interest on loan discount on bill etc. are the examples of financial expenses.
- 5. Maintenance Expenses: Expenses incurred for maintaining the fixed assets are called fixed expenses. Repair and renewable depreciation of assets are some examples of maintenance expenses.
- 6. Abnormal Losses: Abnormal losses are those losses which are incurred due to the carelessness of the management. Loss on sale of asset, stock lost by fire etc are the examples of abnormal losses.

Items appearing on the credit side of Profit and Loss Account:

Following items are included in the credit side of profit and loss account

- 1. Gross Profit: Gross profit is transferred from trading account and it is the beginning item of profit and loss account.
- 2. Non-trading Income: Interest received from bank, in comes received from outside investments like share and debenture are known as non-trading incomes.
- 3. Other incomes: Those incomes other than income from sale of goods are called other income. Discounts or commission received are the examples of other income.

Advantages of Profit And Loss Account

The main advantages of profit and loss account are as follows:

- 1. Profit and loss account gives the actual information about net profit or net loss of the business for an accounting period.
- 2. Profit and loss account gives the actual information about indirect expenses.
- 3. Profit and loss account serves to determine the ratio between net profit to sales.
- 4. Profit and loss account helps in determining the ratio between net profit to operating expenses.
- 5. Profit and loss account helps in controlling indirect expenses.

Closing Entries Relating to Profit and Loss Account

The preparation of Profit and Loss Account requires the transfer of all items (nominal accounts relating to Profit and Loss Account) in the Trial Balance to the Profit and Loss Account with the help of the following closing entries:

A. For Debit: (items of revenue expenses and losses) (or for items other than those record in debit side of Trading Account)

12.6 BALANCE SHEET

A Balance Sheet is the statement prepared to show the financial position of business. It is prepared only after the Trading and Profit and Loss account have been prepared. After Trading and Profit and Loss Account have been prepared, balances remaining in the trail balance represent either assets or liabilities existing on the date of financial close. It summarises on the one side-the right hand side-the assets of the business enterprise and on the left hand side-liabilities of the business enterprise. Hence, a balance sheet may be called as a statement of Assets and Liabilities of a business entity at a particular date.

Objectives of preparing Balance Sheet

The main objectives of preparing a Balance Sheet is to ascertain the financial position of the business on a particular date. While ascertaining the financial position, we also obtain the following additional information:

- **1. Nature and Value of the assets:** A balance sheet contains various assets in classified, from with their respective values and as such it gives a clear picture about the nature and the value of different assets Comprising fixed assets, current assets etc.
- **2. Nature and extent of liabilities and actual capital:** Like assets, a balance sheet also contains different liabilities in a classified form and shows the amount of liabilities the business owes to different types of creditors. It also shows the actual capital of the business at the end of trading period, representing the excess of assets over liabilities.
- **3. Solvency of the business:** If the assets exceed the liabilities the business is considered as solvent. Greater is the difference, stronger is the financial position. On the other hand, if liabilities exceed the assets, the business is considered as insolvent.
- **4. Over-trading and under-trading:** If the total creditors exceed assets Cash, Bank, Investments, Debtors etc., the position of the business is financially unsound, indicating over-trading. For sound financial position, a business must have sufficient working capital. On the other hand, under-trading indicates excess liquid assets over current liabilities, showing idleness of the funds.

Characteristics of Balance sheet

- 1. It is prepared on particular date and not for particular period.
- 2. It is prepared after preparation of Trading and profit and loss account
- 3. As assets must be equal to total liabilities, the two sides of the balance must have the same total
- 4. It shows the financial position of a business as a going concern.
- 5. It is a statement of assets (debit balances) and liability (credit balances) and not an account.

Contents of Balance Sheet

The right-hand side of a balance sheet is called the "Assets" side and the left-hand side is called the "Liabilities" side.

Items shown on the Assets side of a Balance Sheet: The debit balances of ledger accounts were not transferred to the Trading and Profit and Loss Account are to be shown on the Assets side of the balance sheet. Assets are generally classified as Current Assets, Investments and Final Assets. Further, fixed assets are classified into two categories-Tangible assets and Intangible assets.

Current assets: Current assets are those assets which are held for a short period and can be easily be converted into cash.

Example: Cash in hand, Cash at bank, Raw material, Stock of goods, Bills receivable, Debtors, Prepaid expenses and so on.

Investments: Acquisition of assets which in turn earn interest, dividend, rent or any other incomes are referred to as investments.

Example: Shares, Debentures, Bonds and Fixed Deposits. These are usually held in business for a long period, generally more than a year.

Fixed Assets: The term fixed assets refer to those assets for use in business activities rather than for resale in the course of the business. They are usually held in the business activities rather than for resale in the course of the business. They are usually held in the business for a relatively longer period. Fixed assets are classified into Tangible fixed assets and Intangible fixed assets.

Tangible Fixed Assets: Assets can be seen and they posses physical existence. For example- Land, Building, Plant, Machinery, Furniture and Fixtures and Vehicles etc.

Intangible Fixed Assets: Assets cannot be seen and they do not posses any physical existence. For example-Goodwill, Patents, Copyrights and Trademarks etc.

Fictitious Assets: These are the assets which do not have any tangible existence or realizable value but represents actual cash expenditure. These are not shown in the balance sheet. For example- Share issue expenses by a corporate, preliminary expenses and issue of debentures etc.

Items shown on the Liabilities side of a Balance Sheet:

Fixed Liabilities: Those liabilities which are payable to the owners only on the liquidation of the company after making the payment of other outside liabilities are called fixed liabilities.

Current Liabilities: Current liabilities are those type of liabilities which are payable out of current assets within the next accounting period. Bills payable, short term bank overdraft are the examples of current liabilities.

Long term Liabilities: Long term liabilities are those liabilities which are not payable within the next accounting period but will be payable within next few years. Debentures are the example of long term liabilities.

Advantages of preparing Balance Sheet:

The preparation of Balance sheet gives following advantages:

- It is helpful in ascertaining the financial position of the business by showing assets and liabilities of the concern on a specific date.
- It discloses the solvency of business by showing how much assets are available for payment of liabilities.
- It also disclose the proprietary interest of owner.
- It helps in calculation of various ratios which help in better management of business.
- It helps in comparison of assets and liabilities of business on two dates to ascertain the progress being made by business.
- It helps to ascertain the amount of capital employed in business.

Sequence of items in the Balance Sheet (Marshalling of Assets and Liabilities):

Assets and Liabilities shown in the balance sheet may be put down in two ways:

- 1. In order of permanence or
- 2. In order of Liquidity

1. In order of permanence: Under this method, the assets are arranged in the decreasing order of permanence. Permanence means affinity of an asset to stay with the organisation or the longevity of the life of an asset with the organisation. The longer an asset stays with an organisation, the more permanence it has.

2. In order of Liquidity: Under this method ,the assets are arranged in the decreasing order of their liquidity. Liquidity is the characteristic of an asset to get converted to cash, the faster an asset an can be converted into cash the more liquid it is.

Difference between Trial Balance and Balance Sheet

The difference between Trial Balance and Balance Sheet are:

- Trial Balance is the 'means' of a accounting process of which Balance sheet is the 'end' because a balance sheet is always prepared from the figures taken out of trial balance.
- The purpose of preparing a trial balance is to check the arithmetical accuracy of account books; but balance sheet is drafted to reveal the financial position of the business.
- The two sides of balance sheet are called 'liabilities' and 'assets' sides respectively but in case of trial balance the columns are 'debit' and 'credit' columns.
- For completing the accounting cycle, the preparation of balance sheet is necessary; but the preparation of trial balance is not always necessary.
- Trial balance contains in it all the three types of account viz. personal, real and nominal, but balance sheet contains only personal and real accounts.
- Generally, trial balance does not contain closing stock but balance sheet does.

12.7 LET US SUM UP

Final accounts are prepared to ascertain the net profit or loss for a period and the financial position of the business entities on a particular date. Trading account is treated along with profit and loss account as one. Next stage after preparation of trail balance is the preparation of trading account to ascertain gross profit or loss for the period. After the preparation of trading account profit and loss account is prepared to ascertain the net profit which is to be transferred to capital account in balance sheet. Balance sheet is the statement comprising the summary of financial position of enterprise on a particular date and it is prepared after making the necessary amendments.

12.8 KEY WORDS

Balance sheet: a statement of the assets, liabilities, and capital of a business or other organization at a particular point in time, detailing the balance of income and expenditure over the preceding period.

Gross profit: A company's revenue minus its cost of goods sold. Gross profit is a company's residual profit after selling a product or service and deducting the cost associated with its production and sale.

Profit and loss account: an account in the books of an organization to which incomes and gains are credited and expenses and losses debited, so as to show the net profit or loss over a given period.

Trading account: The part of an income statement that shows how the gross profit was generated through trading activities.

13.0 OBJECTIVES

13.1 INTRODUCTION

In the previous lesson we got to understand how the last step of accounting cycle i.e. preparation of final accounts is done. But even after preparation of final accounts we find that there are certain transactions which do not result in any inflow or outflow of cash into the business but are necessary to give effect for ascertaining the correct amount of profits. Such transactions are related to depreciation on fixed assets, Provision for doubtful debts, interest on capital and drawings etc.

Matching concept of accounting lays down that all expenses of current year which have been paid or not must be debited to the profit and loss account of current year. It means that all such expenses which have become due but not yet paid or those expenses which have been paid but were not yet due must be adjusted, otherwise, the profits disclosed by Profit and loss account will not be true profits. Matching concept of accounting also applies to incomes which lays down that income of current year must be credited in profit or loss account of current year irrespective of the fact whether they have been received or not.

So this lesson is specifically devoted to understanding of the effect of these adjustments and also how these adjustments would be treated in the final accounts.

13.2 ADJUSTMENT ENTRIES

A fundamental principle in the preparation of the Trading and Profit and Loss Account is that expenses and incomes for the full accounting period are taken into account in the calculation of gross/ net profit or loss. The income statement must contain any revenue or expenses relating to preceding or succeeding period. This means adjustments have to be made for outstanding expenses, advance payments, accrued incomes, incomes received in advance, provision for bad debts etc. Adjustment entries are passed to give effect to these adjustments. There are many adjustments because earlier we have not passed any journal entry, so at the time of making final account we have to adjust them.

Following are the adjustment entries are explained in detail:

13.2.1 Closing Stock

Closing stock is the amount of inventory that a business still has on hand at the end of a reporting period. It includes raw materials, work-in-progress and finished goods. The amount of closing stock can be ascertained with a physical count of the inventory. It can also be determined by using a perpetual inventory system and cycle counting to continually adjust inventory records to arrive at ending balances.

(a) When closing stock is not given within the trial balance but is given as a information for adjustment, then adjustment entry will be as follows:

Closing Account ----- Dr.

To Trading Account

First it will be shown at trading account credit side and then at assets side of balance sheet as current asset.

(b) When closing stock is shown inside the trial balance then it has to be shown only on the assets side of balance sheet as current asset.

Effects on Final Accounts

- 1. Closing stock will be shown at trading account credit side.
- 2. Closing stock will be shown on assets side of balance sheet as current asset.

13.2.2 Interest on Capital

The proprietor may wish to ascertain his profit after considering the interest which he losses by investing his money in the firm. Interest to be charged is an expense for the business on one hand and income to the proprietor on the other hand. Interest on capital being an expense is debited to profit and loss account and same amount of interest on capital is added to capital on the Liabilities side.

Following adjusting entry is recorded at the end of accounting period:

Interest on Capital A/c ----- Dr.

To Capital A/c

- 2. The amount of interest on capital is added to capital on the Liabilities Side.

13.2.3 Interest on Drawings

As business allows interest on capital it also charges interest on drawings made by the proprietor. Interest so charged is an income for the business on one hand and expense for the proprietor on the other hand. The interest on drawings being an income is credited to profit and loss account and is shown as a deduction from the capital at the Liabilities side of Balance sheet.

Following adjusting entry is passed at the end. of accounting period:

13.2.4 Provision for Discount on Debtor

It is normal practice in trade to allow discount to customers for prompt payment and it constitutes a substantial sum. Sometimes the goods are sold on credit to customers in one accounting period where as the payment of the same is made by them in the next accounting period and so discount is to be allowed. It is a prudent policy to charge this expenditure to the period in which sales have been made, so a provision is created in the same manner, as in case of provision for doubtful debts

NOTE: An important point to note is that no discount will be allowed on debts that become bad. Therefore, the provision required for discount will be in respect of the other debts only. So the amount of provision for discount be calculated after deducting the provision for bad debts from sundry debtors.

Following adjusting entry is passed at the end of accounting period:

13.2.5 Provision for Discount on Creditors

Prompt payment, if made, enables a businessman to receive discount. The question arises whether this discount should be treated as income of the period in which purchases were made or of the period when the payment is made, if both events are in different accounting years, it has been well decided by accountants that it should be treated as income of the period in which purchases are made. So on last date of accounting period if some amount is still payable to creditors, a provision should be created for such probable income and amount should be credited to the profit and loss account of that year in which purchases are made and subtracted from creditors on the liabilities side of Balance sheet.

Following adjusting entry is passed for it:

Provision for Discount on Creditors A/c ----- Dr.

13.2.6 Outstanding expenses or expenses payable or expenses due but not paid

Certain expenses relating to a particular period may not have been paid in that accounting period. All such expenses which are due for payment in one accounting year but actually paid in future accounting years or payment of which is postponed are all outstanding or unpaid expenses. All such expenses must be accounted for in that accounting year in which they are incurred, irrespective of the fact whether they are paid or not. In other words, all paid and also unpaid expenses must be recorded in an accounting year if they relate to that accounting year only with a view to ascertain true trading results e.g. if salaries for the last month are not paid, no entry will appear in books of accounts unless these are paid. So profit and loss account in respect of salaries will thus be under charged than the actual expenditure, therefore the profit will be more.

13.2.7 Advance expenses

The benefit of some of the expenses already spent will be available in the next accounting year also, Such a portion of the expense is called pre-paid expense; since such expenses are already paid, they are also recorded in the books of accounts of that period to which they do not relate. The result shown by the final accounts of a particular period will not be correct because such expenses relate to future periods. Therefore, such prepaid expenses must be adjusted in the books of accounts to arrive at true profit. Generally insurance, taxes, telephone subscriptions, rent etc. are paid in advance, thus requiring adjustment e.g. Rent paid by x for one year on 1.7.14 when his accounting year is calendar year; thus rent for 6 months will remain unexhausted and will be carried forward to the next year.

14.2.13. Provisional for doubtful debts

At the end of the year, after writing off the bad debts about whom we were sure of becoming irrecoverable, there may still be some customer balances from whom it is doubtful to collect the entire amount. However, it can't be written off as bad because non-recovery of such amount is not certain. But at the same time the balance in sundry debtors account should be brought down to its net realizable figure so that balance sheet may not exhibit the debtors at more than their actual realizable value. Therefore, to show the approximately correct value of the sundry debtors in the balance sheet a provision or reserve is created for possible bad debts. Such an adjustment entry is recorded at the end of accounting year.

Provision for bad debts is an attempt to anticipate possible losses due to bad debts and to keep aside an amount out of profit to meet the loss estimated in the following years.

Some important considerations while creating provision for bad debts

- (i) Sundry debtors account should not be credited with the amount of provision for doubtful debts because the loss has not actually been incurred.
- (ii) Treatment of bad debts or provision for bad debts appearing inside the trial balance. If some balance (credit) is already appearing in provision for doubtful debts account inside the trial balance, it is the previous years unutilized balance of this account. If some bad debts are also appearing on the debit side of the trial balance, these should be transferred to provision for bad debts account, with the help of following entry:

Provision for bad debts A/c ----- Dr.

To Bad debts A/c

It is important to note that, as these items appear inside the trial balance, so these are to appear only in profit and loss account as debtors have already been reduced during the year.

(iii) When bad debts and provision for bad debts appear in trial balance, new provision is to be created and further bad debts are to be written off. If already bad debts and provision for bad debts are appearing in trial balance, these should be adjusted and only difference should be taken to profit and loss account.

If bad debts written off plus bad debts to be written off plus new provision for bad debts is more than the credit balance of old provision appearing in the trial balance, the difference should be debited to profit and loss account.

14.2.14. Commission to manager on profits

Sometimes the manager is entitled to a commission on profits.. Such commission may be:

- (a) Fixed percentage on net profits before charging such commission.
- (b) Fixed percentage on net profits- after charging such commission.

Such commission being an expense is debited to commission account. However, as it has not yet been paid, so commission payable account is given the credit and finally it is shown in the balance sheet as a liability. Calculation of Commission First of all trading account should be prepared in usual manner and after transferring the gross profit or loss all expenses and incomes should be debited or credited except the commission which is still to be calculated.

13.5 KEY WORDS

Interest on Drawings : Interest on drawings is charged on the drawings made. The interest so charged is an income for the business on one hand and expense for the proprietor on the other hand. The interest on drawings being an income is credited to profit and loss account and is shown as a deduction from the capital at the Liabilities side of Balance sheet.

Advance expenses: The benefit of some of the expenses already spent will be available in the next accounting year also, Such a portion of the expense is called pre-paid expense; since such expenses are already paid, they are also recorded in the books of accounts of that period to which they do not relate. The result shown by the final accounts of a particular period will not be correct because such expenses relate to future periods. Therefore, such prepaid expenses must be adjusted in the books of accounts to arrive at true profit.

Income received in advance: Sometimes, traders receive certain amounts during a particular trading period which are to be earned by them in future periods. Such incomes though actually received and therefore, recorded i.e. not yet earned. Such incomes should be credited to the profit and loss account of the year in which these are earned. Therefore, such income though received is not the income but a liability of that period.

Goods use for personal use or Drawings: Drawings are goods or cash taken from business by the Owner for this personal use. Drawings of goods will be deducted from the amount of purchases in Trading account and also from the Owner's equity in Balance sheet. Drawing of cash will be just deducted from Owner's equity in balance sheet.

Goods destroyed by fire: If Goods in case gets destroyed by fire then it will be shown in credit side of trading account and also in profit and loss account's debit side. And it will not go to balance sheet.

Depreciation: The value of fixed assets diminishes gradually with their use for business purposes. Although this decrease in the value happens every day but its accounting is done only at the end of accounting period.
