Dt.: 07.03.2020

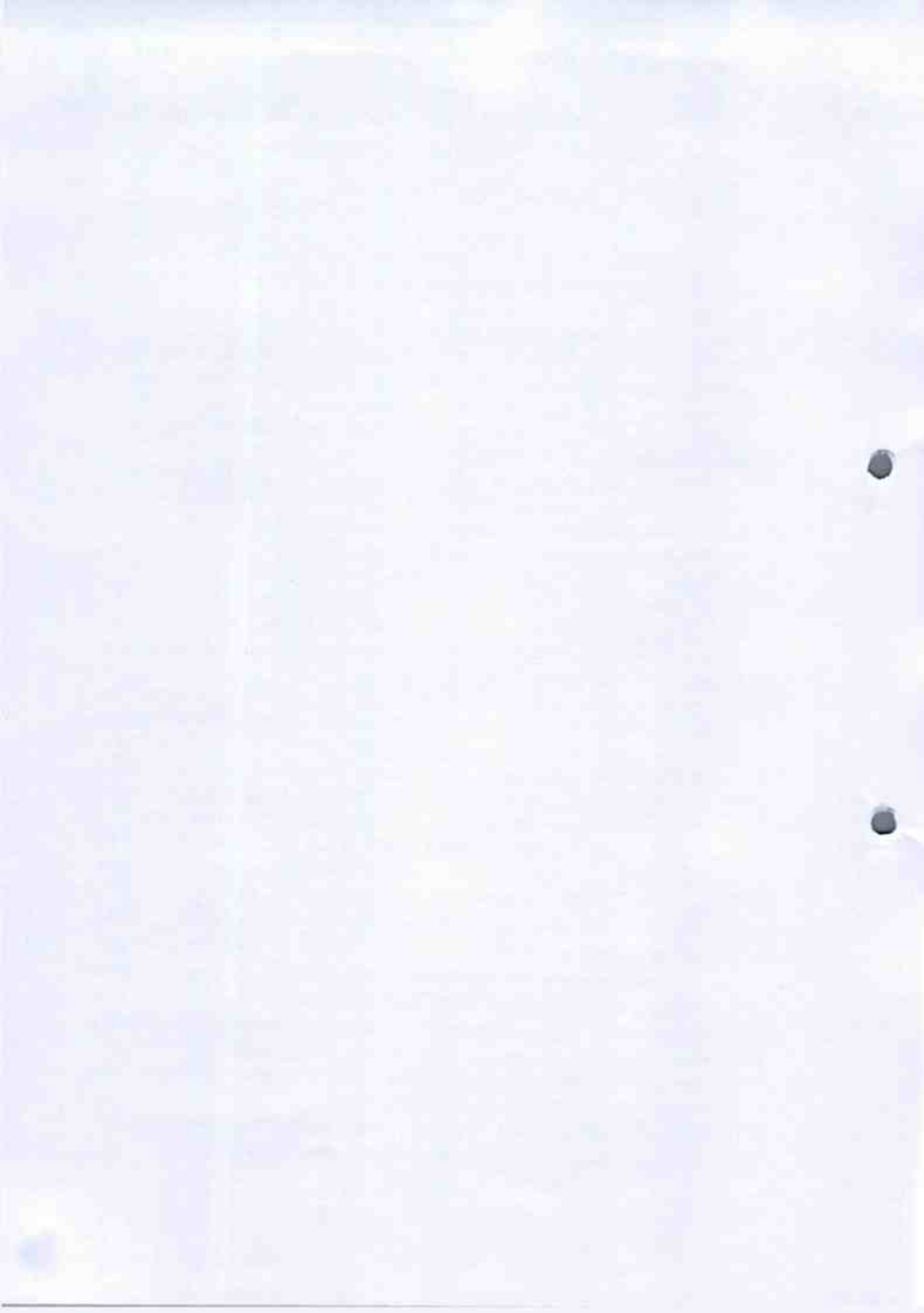
The Board of Studies ( BOS ) committee meeting was held on 07 March 2020 at 11.00am in conference Hall , fifth floor at Teerthanker Mahaveer Dental College and Research Centre.

The minutes of the meeting are as under :

- 1) The PhD students are Sunita R Melwani , Tina Agarwal and Sonam Rastogi have successfully submitted their semester progress report and was well appreciated and recommended by all the CRC members . Their course work got completed in Research methodology at TMU from 27 February to 03 March, 2020 and is approved by BOS Committee members.
- 2) The PhD student Dr. Ankita Jain submitted all six semester progress reports along with her Pre thesis submission of the hard copies. she has attended 04 national conferences, 2 articles published in the indexed journal and has cleared the Research methodology examinations of both part 1 & 2 .Dr. Ankita Jain presented her Review of literature (ROL ) and 04 credit points were assigned by CRCmembers. She has more than 12 credit points to her credit and completed her work in time. All the BOS members , principal and External experts were approved the same and sent to the university. The recommended list of the panel of examiners has been sent to the university for the approval.
- 3) The PhD first year student Dr. Swati agarwal has not reported to the CRC meeting for her synopsis presentation. Hence the BOS committee approves the cancellation of her candidature for the PhD course.
- 4) The BOS committee members and External experts approved the cancellation of non reporting two PhD students Dr. Mohan Gundappa and Dr. Ranjana mohan have not reported to any CRC meetings for their semester progress report presentations.
- 5) The Academic Time table will remain the same till july 2020. The first year BDS admission will take place in the month of july and the Academic year will commence in August. Further will be modified accordingly next academic year.
- 6) Our Principal mentioned the implementation of Basic computer classes, communication skills and patient management skill courses from this academic year 2020-21. These skilled courses will be conducted for the BDS first year and second year students without disturbing the DCI teaching curriculum

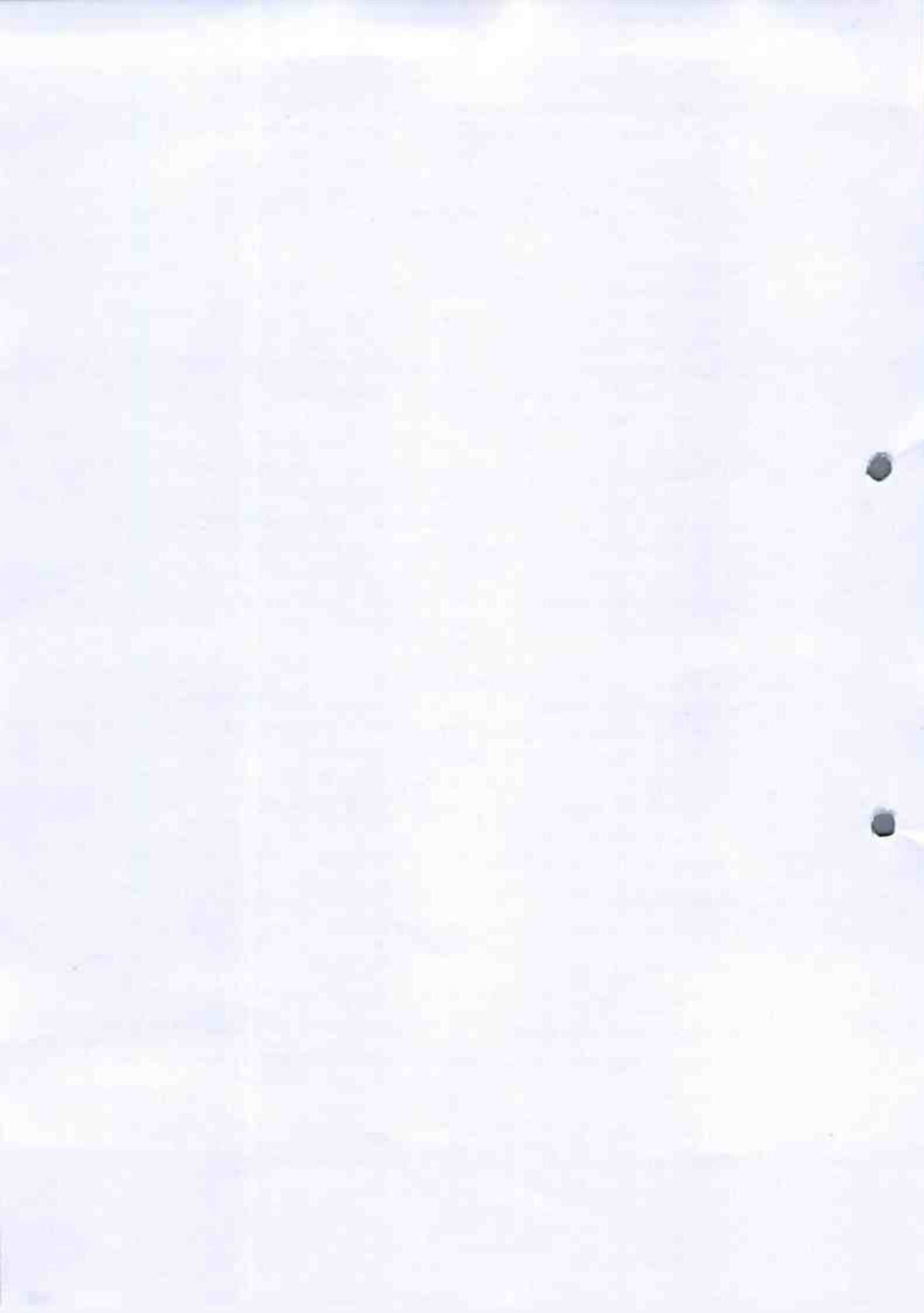

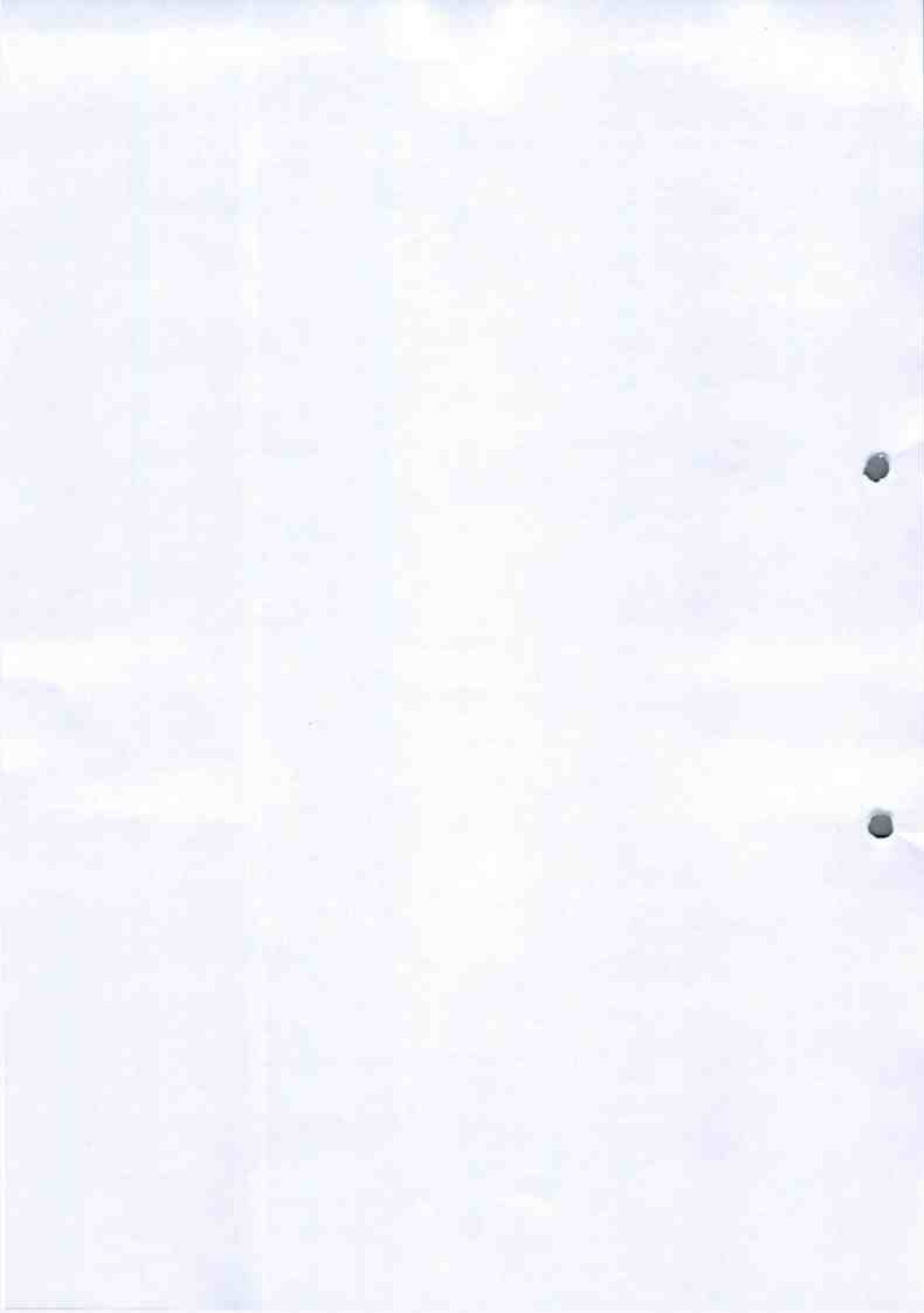

The minutes of the meeting are as under

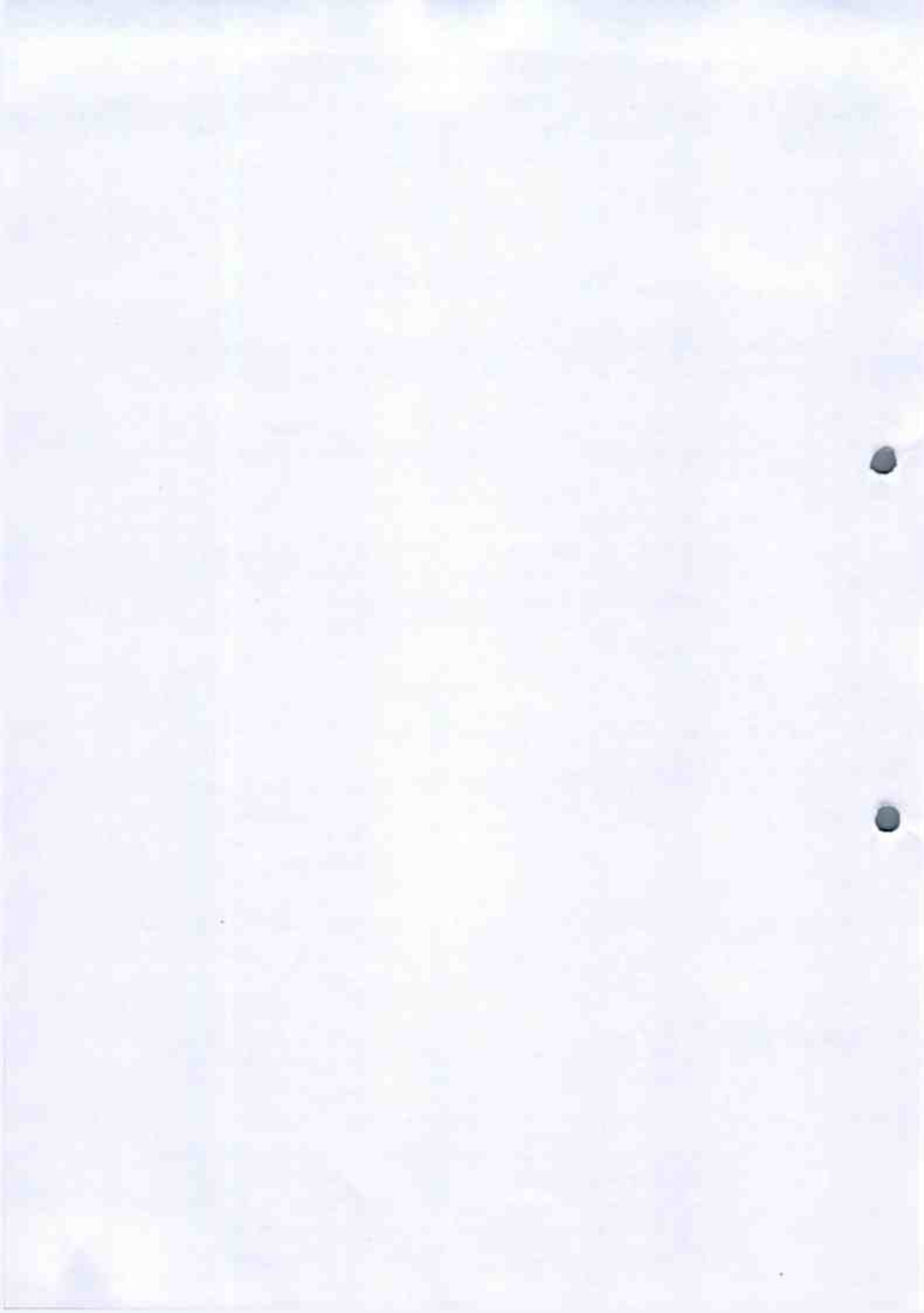
- 1) The final year PhD student Dr. Ankita Jain has successfully submitted the semester progress report and was well appreciated and approved by our Principal and other BOS members.

It includes MCQ , long essay and short questions were considered.

The distribution of marks for the BDS examination as in part A and part B of total 70 marks . It as follows

MCQ . = 5 x 1 = 5

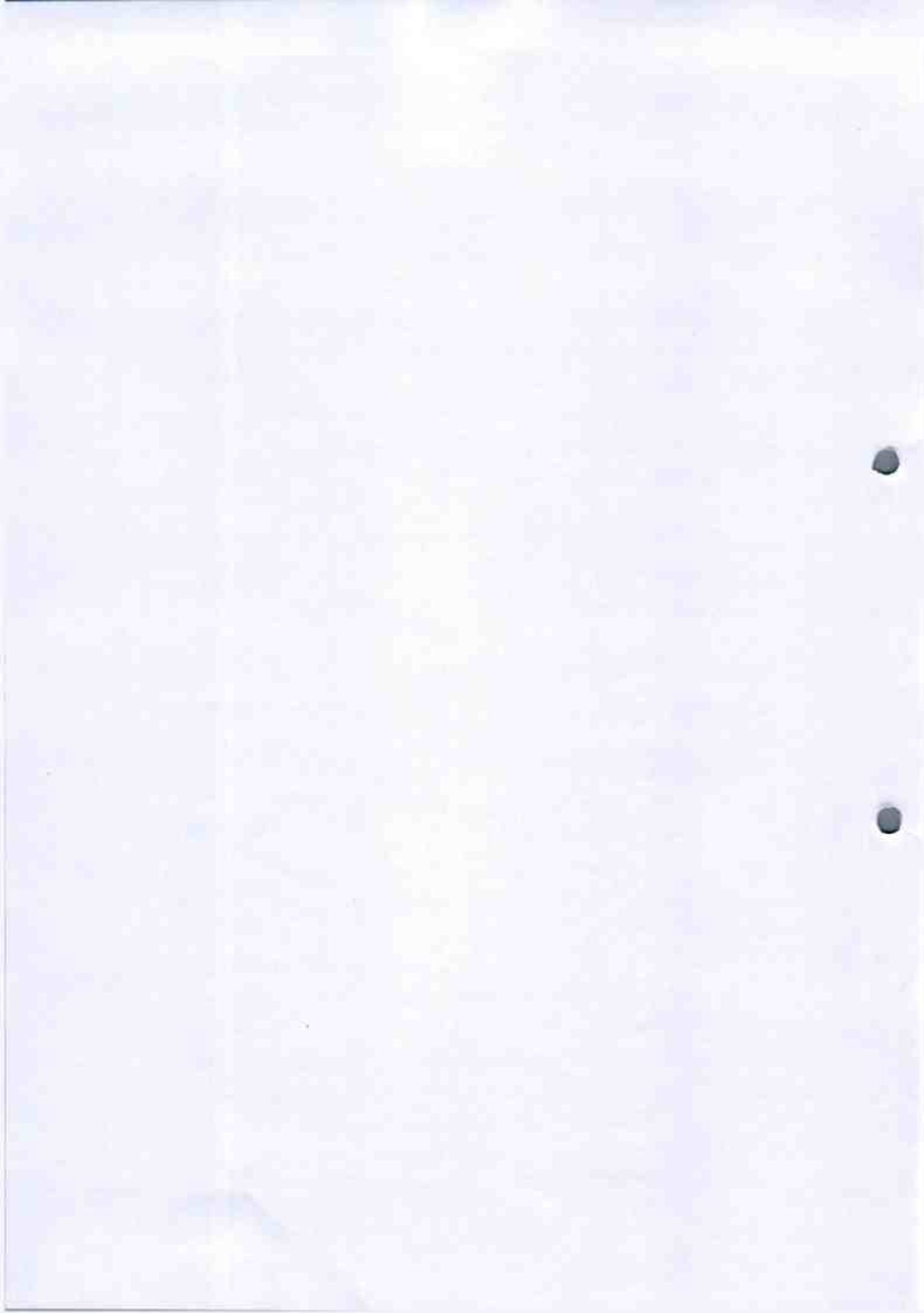
Long essay = 01 x 15 = 15 ( optional )

Both these Part A and Part B answer scripts to be corrected by both Internal and External Examiners was considered.

The BOS committee members has recommended the new list of panel of Examiners for both BDS and MDS examinations from every subject and the same to be submitted to the University with prior approval of the Principal.

- 7) The BOS committee approved the change in the Academic Time Table for BDS students with increased the number of clinical hours and one theory classes.
