For Post Graduation Programs:

- Cases and numerical components may be highlighted in subjects such as QT, and Accounting etc.

For Under Graduate Programs:

- 1. In references APA style should be followed althrough.
- The formatting needs to be uniformed in the presentation of the contents of the syllabi as well as in the reference and text books.
