All the BOS & BOF members are present to discuss the modification in the current running syllabus of annual to convert in credit-based semester scheme for programme Bachelor of Optometry & B.Sc. in Medical Lab Technology.

1. Stakeholders Students, Alumni, Experts, Teacher, Professionals, Employer suggested for credit-based semester course scheme for programme in place of annual syllabus.

1. For Bachelor of Optometry:

The course code for the Bachelor of optometry for credit-based semester scheme for programme will start from BCO-S-101, BCO-S-201 & so on..., where BCO will signify Bachelor, "S" will signify the semester and 101 will signify theory course of 1st Semester, 201 will signify theory course of 2nd semester and so on. The code of practical course will be BCO-S-151, BCO-S-251, similar to annual syllabus only "S" is added which will signify the semester system.

The following new course are introduced

Clinical examination of visual system (BCO-S-306), Indian Telemedicine (BCO-S-307), Pathology (BCO-S-404), Introduction to Quality & patient safety (BCO-S-406), Medical Psychology (BCO-S-407), Practice Management (BCO-S-604), Medical Law And Ethics (BCO-S-606), Internship-II (BCO-S-851)

Minutes of Meeting

ANNEXURE- I (A)

Event: Meeting of Board of Studies (BOS) for Master of Science in Medical Laboratory Technology (M.Sc. MLT/ MMLT)

Date: 11 /09/17

Roll Call: All BOS internal as well as external members were present (list of members attached)

Purpose of meeting: Meeting was conducted to discuss the proposed syllabus for departments in College of Paramedical Sciences; Department of Medical Laboratory Technology (MLT).

The following proposal were given by the external and internal experts during the meeting

1. The BOS approved the common ordinance of the M.Sc. MLT which will be as per the college ordinance.
 - The University will permit admission and shall hold examination for the MMLT as approved by Academic council.
 - The candidate should have 50% marks in the prescribed qualifying examination MMLT to be eligible for admission in MMLT program offered by the University.
 - The admission of a student at any stage of study shall be cancelled if he/she is found involved in an act of ragging indisciplinary activities or violating the University Code of conduct.
 - All the fees including the tuition fees and the examination fees as determined by the University from time to time will be payable by the students at the beginning of each session.
2. Syllabus and Curriculum for MMLT was approved
 - The syllabus and Curriculum designed as per the standard set by Ministry of Health & Family Welfare was approved.
 - Each course shall be assigned a weightage in terms of specified credits.
 - Medium of examination shall be English only.

The maximum permissible period for completing the program for which the prescribed duration is n years shall be (n+2) years. All the program requirements shall have to be completed in maximum (n+2) years.

3. BOS has suggested that the minimum passing marks should be 50% (subject wise and aggregate) for future consideration.
 - Currently as per the university norms in Bachelor degree courses a student is required to obtain a minimum of 45% marks in each course for earning its assigned credits. He/she should have secured at least 50% marks in aggregate to clear the semester.
 - However BOS has suggested that the minimum passing marks should be 50% in both subject wise as well aggregate for future consideration.

4. Final research project should be submitted by the third month of the fourth semester.

- Each student will carry out project work under the supervision of a faculty member guide

- Synopsis of the project on which the student shall work is to be submitted by the end of second month of the first semester.
 - The synopsis shall be reviewed by the College Research Committee before the end of the third month of the first semester.
 - The progress of the project will be regularly monitored by the guide.
 - The thesis not exceeding 100 pages typed on A4 papers on one side is to be submitted in the university through the guide in the third month of the fourth semester.
 - Thesis will be evaluated by the panel of examiners (one internal and one external at least)
5. Internal and External faculty should be involved in final research project and viva.
- For dissertation in final year of masters program the internal and external evaluation shall be done in order to earn it's assigned credits.
 - BOS has suggested limiting the maximum intake to 20 seats for master program so as to not compromise on the quality of on hand skills imparted to the students.
 - The students shall submit a duly signed log book from the hospital or clinic where he was working.
 - It was suggested that clinical posting be kept in only first three semesters The fourth semester shall include Research Project in place of clinical posting.
