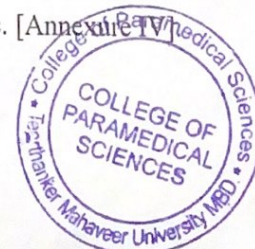
Detailing of the points suggested/recommended by the external as well as internal experts during the meeting.

1. The BOS approved the changes in as follows

- I. The nomenclature, syllabus, credit & evaluation scheme of the English Communication and Soft skills I, English Communication and Soft skills II, English Communication and Soft skills III & English Communication and Soft skills IV has been changed as per the recommendation of the university and has been reviewed and approved by the BOS Committee members. - II. The credit of some of the courses viz. BFS-S-199 (new code BFSE101), BFS-S-299 (new code BFSE201), BFS-S-399 (new code BFSE301), BFS-S-499 (BFSE401), BFS-S-501, BFS-S-502, BFS-S-503, BFS-S-504, BFS-S-601, BFS-S-602, BFS-S-603, BFS-S-604 the overall credit is now maximum - 148 and minimum 142 - [Annexure II]
- III. There is change in Syllabus with minor modification in some of the courses viz. BFS-S-101, BFS-S-103, BFS-S-153, BFS-S-201, BFS-S-203, BFS-S-253, BFS-S-301, BFS-S-303, BFS-S-304, BFS-S-353, BFS-S-401, BFS-S-403, BFS-S-453, BFS-S-502, BFS-S-503, BFS-S-505, BFS-S-553, BFS-S-601, BFS-S-603, [Annexure III].
- IV. There is change in nomenclature of Basics of Forensic Science (BFS-S-101) to Fundamentals of Forensic Science, Basics of Computer Science (BFS-S-104) to Fundamental of Computer Science, Criminal law (BFS-S-201) to Fundamentals of Forensic Science II and basics of cyber forensic (BFS-S-204) to Basics of Digital and Cyber Forensic. - V. Shuffling has been done between the core papers of Semester Fourth to sixth. [Annexure IV].
- VI. There is one paper in semester fourth "Forensic Anthropology" and in semester sixth "Introduction to Research Methodology" has been dissolved.
- VII. In current syllabus there is an elective pool (Basic of chemistry + Basic of biology) / (Basic of Physics + Basic of biology) from semester I to IV, elective pool is modified (Chemistry/ Physics) from I to VI semester.

BOS has suggested following points on the syllabus:

- I. There should be an introduction of two paper of Zoology (zoology I & zoology II) in first year and Botany (botany I & Botany II) in Second year.
- II. In semester fourth instead if quality management of laboratory Paper, they suggested to add one paper of basic instrumentation paper.
- III. In syllabus Digital and Cyber Forensic paper are remaining in four semesters (semester I, II, IV, V) instead of this there should be only two papers of Digital and Cyber Forensic.
- IV. Project study should remain in Six Semester.

BOS has suggested following points for the Department

- I. TMU is successfully running B.sc Forensic Science Course since 2011.
- II. TMU has all the required facility to run M.sc forensic programme.
- III. The grading of university depends on research potential of students as well as faculties.
- IV. In India forensic science courses are in only 40-50 Universities out of 800-900 Universities.
- V. It is a matter of proud that TMU has well established forensic science department.
- VI. For the development of department and university, committee members strongly recommend to start M.sc forensic science programme as soon as possible. it will be beneficial for the students of B.sc forensic science of TMU also.

1. The BOS approved the changes in as follows



Detailing of the points suggested/recommended by the external as well as internal experts during the meeting.







1. The BOS approved the changes in as follows

 - iii. In unit-III, method of detection of food adulteration is added.
- In BML-S-204(Annexure III), changes are approved.
- In BML-S-405(Annexure IV),
 - i. In unit-III, demonstrations of nucleic acid are removed from proposed changes and rest is approved as such.

- Hospital posting should not be the part of I & II semester instead new introduced course as Microbiology in both semester is added
