  - The External member approved Eye Banking however he suggested substituting Ocular Prosthesis with Dry Eye or Refractive Surgery in the Semester IV, and the internal i. members agreed to Substitute Ocular Prosthesis with Dry Eye. [Annexure II];
  - As per his suggestion, we drafted syllabus for the Course Dry Eye and forwarded it to the external member for his approval. He further suggested few changes in the draft syllabus. After incorporation of the suggested changes, the syllabus for Dry Eye was approved by the internal & external members.

- 3. The changes in the credit of BCO-S-751, BCO-S-851 & BCO-S-852 was done as per the guidelines. The same was approved by the internal & external members.[Annexure I]
