Members discussed the syllabus and suggested that Course related to B.Ed. should be included with B.Sc. course in every semester upto VI Semester. Avoid big difference of credits among all semesters. Some papers are needed to revise syllabus under the supervision of subject experts.

#### B.A. B.Ed. :

Members suggested that Course of B.A. and B.Ed. should be in equal proportion. Revision of papers related to B.A. course should be done according to view of subject experts. Credit required for the course should be properly decided by keeping in mind the guide line of NCTE regulations.
