## Agenda 3: Approval of Programme Outcomes (POs) & Course Outcomes (COs)



The members discussed the syllabus with all members and they approved the revised syllabus of two years (04 Semesters) B.Ed. Programme after incorporating a few modifications:


- In revised syllabus Minimum Credits required B.Ed. Degree is 90.

- In Course: Pedagogy of Commerce Course Code 135/235 add topic "Innovative instructional method: Micro Teaching" in Unit-II and Concept of evaluation & measurement, Need of evaluation, Comprehensive and continuous evaluation (C.C.E.) in Commerce in Unit-V. Topic: "Knowledge of the subject matter content up to high school" of Unit-V merged in Unit-I.
- In Course: Pedagogy of Mathematics Course Code 138/238 add topic "Innovative instructional method: Micro Teaching" in Unit-II.
