1. Scope of Agreement

The purpose of this agreement is to collaborate programs for students at Teerthanker Mahaveer University to simultaneously pursue courses leading to the award of dual MBA degrees by both TMU and UCAM University (Universidad Católica de Murcia), Spain, a partner university of Westford. The program will allow students at TMU who have completed their 3rd or 4th semester in TMU to map their subjects and continue their studies in Westford entities and require only 3 or 2 modules and thesis, as the case may be, for dual MBA degrees. Apart from the MBA degree from UCAM University, students will also be eligible for a diploma from Cambridge International Qualification (CIQ).

2. Duration

This Agreement commences on 23rd January 2023 and will continue until either party ends in accordance with this Agreement's terms.

3. Program Implementation, Enrollment and Fee

- a) Westford will enroll TMU students who meet all admission or specific requirements for pursuing the UCAM University MBA degree, including language proficiency.
- b) Eligible students must complete the application for admission to Westford and submit all required supporting documents, including official transcripts, etc. for mapping subjects.
- c) Students shall be enrolled by Westford as recognised prior learning students undertaking research and modules presenting a thesis leading to the award of MBA by UCAM University and a diploma certificate from Cambridge International Qualification.
- d) Within 7 days from the date of enrollment with Westford, Fee of USD 2200 (Two Thousand Two Hundred USD Dollars) per student must be paid.

3. Degree Completion and Conferral

- a) The parties will ensure that students have completed all modules as per the requirement of the UCAM University.
- b) Upon successful completion of the program, including submission of a successful research thesis to Westford, students will be awarded dual MBA degrees from Teerthanker Mahaveer University, India and UCAM University, Spain, and a diploma certificate from Cambridge International Qualification (CIQ).

4. Academic Co-ordinators

5. Data Protection

a) Each Party shall ensure that it always complies with the applicable Data Protection Laws during the term of this Agreement.

b) Each Party agrees to provide the other Party with such reasonable cooperation and assistance as is necessary to enable each Party to comply with its obligations as a Data Controller in respect of student's Personal Data, including to enable each Party to comply with the student's and/or potential student's rights in respect of their Personal Data and to respond to any other queries or complaints from the students and/or potential students in connection with the processing of Personal Data.

c) Each Party agrees that it shall have in place its own policies that must be followed in the event of a Data Security Breach, taking into account the applicable Data Protection Laws and any associated guidance.

d) Each Party agrees to provide the other reasonable assistance necessary to facilitate the handling of any Data Security Breach in an expeditious and compliant manner.

e) Teerthanker Mahaveer University shall always indemnify and keep indemnified UNIVERSITY against any and all losses, claims, costs, demands, expenses and any other liabilities (including legal fees) suffered by UNIVERSITY arising from any breach of this clause by TMU or its workforce or any other person or organisation employed, engaged, connected to it.

6. Termination

Either Party may terminate this Agreement for any reason by providing not less than one month written notice to the other Party. The event of termination will not affect students from completing their studies already initiated or ongoing unless otherwise mutually agreed.

7. Applicable Law and Settlement of Disputes

(a) Any dispute arising out of this agreement shall be referred to arbitration in London, one arbitrator being appointed by each party, in accordance with the Arbitration Act 1996 or any statutory modification or re-enactment thereof for the time being in force. On the receipt by one party of the nomination in writing of the other party's arbitrator, that party shall appoint their arbitrator within fourteen days, failing which the decision of the single Arbitrator appointed shall apply. If two Arbitrators properly appointed shall not agree they shall appoint an umpire whose decision shall be final.

(b) The parties to this Agreement irrevocably agree that the courts of England shall have the jurisdiction to settle any dispute which may arise out of or in connection with this Agreement and that accordingly any Proceedings may be brought in such courts.

Westford Education Group and Teerthanker Mahaveer University have agreed to the areas of collaboration on academic and research related activities as mentioned in this MoU.

2. Scope

The Scope of collaboration on academic and research activities in this Memorandum of Understanding includes the following categories:

- 1) Developing research projects jointly and availing funding.
- 2) Exchange of academic information, materials, and facilities.
- 3) Students Exchange.
- 4) Faculty Exchange.
- 5) Organizing/participation in Joint symposium, seminar, conferences, workshops etc.
- 6) Developing articulations for twinning/joint programs and allowing students to undertake part of the programme/course of study at each institution; and
- 7) Promoting such other activities/programs as mutually agreed from time to time.

2.1 Developing Research Projects Jointly and Avail Funding

Both institutions may jointly undertake research projects/activities through sharing of research ideas, data and academic resources that can lead to joint publications, development of any product or other intended outcome. Such collaboration activities may also include joint research conferences, visitations and sabbaticals at each other's institution. Faculty from both Institutions will collaborate in the supervision of joint research in disciplines of mutual interest. All such joint research activities will be governed by the terms and conditions laid out by separate written agreement by both Institutions.

2.2 Exchange of Academic Information, Materials and Facilities

Both institutions may exchange academic information, facilities, resources etc. as mutually agreed from time to time.

2.3 Students Exchange

2.3.1 Student Exchange Programs


Both institutions may develop programs whereby the students of either institution can have the opportunity to study at the other institution with mutual recognition of the credit hours arising therefrom. It is desired by both institutions that there will be significant flow of students in exchange as reciprocal. Both Institutions may facilitate internship facilities for exchange students as mutually agreed. Pursuant to the specific agreement for academic exchange, both will exchange students according to the terms and conditions laid out by separate written agreement by both Institutions.

2.3.2 Short Courses/ Summer School

These courses, usually two to four weeks in duration, will normally be held in spring or summer as mutually agreed. The programs will facilitate visits by students and faculty to learn about the









business environment and culture in the host country. In addition to various topics on business operations and culture, the course would include meetings with business executives, and visits to various industrial and business establishments. The cost and other terms of such programs will be mutually worked out separately each year.

2.4 Faculty Exchange

Both institutions agree to develop opportunities for faculty to teach courses, conduct seminars and undertake such other activities at each other's campus as mutually agreed. Visiting faculty will be provided with opportunities to observe and share teaching methods and curriculum. Both institutions will exchange faculty according to the terms and conditions as mutually agreed upon.

2.5 Organizing/ Participation in Joint Symposium, Seminar, Conferences, Workshops etc. Both institutions will promote their faculty participation in the conferences, conclaves and seminars organized by each other to strengthen the ties between both the institutions and may

also jointly organize symposium, seminars, conferences, workshops and other programs as mutually agreed.

2.6 Developing articulation for Twinning/Joint Programs allowing Students to Undertake Part of the Program/Course of Study at each Institution.

Both the institutions agree to work towards the development of joint program offerings and the articulation of various academic credits between the institutions as mutually agreed for various programs/courses which entitles the students to complete a part of the program of study at each institution and will be awarded the respective degree or other respective academic transcripts upon successful completion of requirements as agreed in the separate articulation agreement.

3. Advertising & Publicity

Both the institutions may publicly advertise the collaboration under this MoU among students, staff etc. where reasonably possible, in making advertisements or public announcements in relation to this MoU, each institution shall acknowledge the participation of the other institution and the contribution that other institution has made if any.

4. Relationship


Arrangement between the institutions is on a principal-to-principal basis and not to be deemed to constitute a joint venture, agency, a partnership, franchisor-franchisee or principal-agent or alike relationship under any circumstances, and neither party shall have any right to act or assume or create or transfer any obligation on behalf of or for or to other party.

5. Commencement, Renewal, Termination and Amendment

This MOU will come into force upon affixing of the signatures of the representatives of the both institutions and will remain in effect for five (5) years. This MoU may be renewed upon its expiry, as per mutual agreement of both Institutions. If either institution wishes to terminate the MoU at the end of the five years period or in between the period of five years, it must notify the









other institution not less than six months prior to the expiry of the MoU. The event of termination will not affect participants from completing their activities at the host party already initiated or ongoing unless otherwise mutually agreed. This MoU, its renewal and the actions taken under it may be reviewed at any time. Modifications to MoU may be made by mutual consent and any amendment or extension to the MoU may be formalized by the exchange of letters between the two institutions.

6. Coordinators:

Each institution agrees to appoint an overall Coordinator for the administration of this MoU. The Coordinator will serve as the contact person on campus. These coordinators will ensure smooth flow of communication and would be responsible to ensure that necessary approvals are in place for student/faculty exchange, articulation agreement etc. These coordinators will be responsible to ensure the effectiveness and enforcement of MOU. Both Institutions are responsible for keeping their contact details up to date. Contact details and address of the designated coordinators are given hereunder: -

This MoU shall be signed in counterpart. Each counterpart will constitute an original document and these counterparts taken together shall constitute one and the same MoU.
