MEMORANDUM OF UNDERSTANDING

This Memorandum of Understanding (MOU) sets out a general framework of cooperation and networking between the Partners through which a climate of mutual trust, well being and understanding is established.

Between

Teerthanker Mahaveer University N.H.-24, Delhi Road, Moradabad - 244001 (U.P.) and represented by its Joint Registrar, Dr. Aditya Sharma (which expression shall mean and include its successors in office and assigns).

And

Abhinav Prodhyogiki Udhyamee Vikas Simiti , having its office at Chauraha Gali, Bartan Bajar, Chimte Wali Gali, Near Temple, Moradabad, Uttar Pradesh represented by Mr. Kapil Rastogi

In consideration of the above, the parties agree to enter into this Educational Cooperation Agreement for the Awareness programmes on Road Safety, awareness programmes on environment, organize Health Camps and awareness on re-cycling of Hygiene items/ reusable items.

And Whereas

Teerthanker Mahaveer University, which has been established under the Uttar Pradesh Govt. Act No. 30 of 2008 to facilitate and promote teaching, research and extension work in emerging areas of higher education with focus on professional education in the disciplines of Management, Dental, Medical, Engineering, Pharmacy, Nursing, Para-medical Sciences, Physiotherapy, Law, Education, Physical Education, Agriculture Sciences, Computing Sciences, Hospital Administration, Fine Arts etc.

Abhinav Prodhyogiki Udhyamee Vikas Simiti is society, which created for the purpose of awareness of khaadi gramudyog, education for backward class, to promote social welfare in society and awareness for road safety etc.

Objectives of the Collaboration:

The parties are exploring the possibility of working together in areas of mutual interest and wish to enter into this Memorandum of Understanding ("MoU") to set out the areas of cooperation to take advantage of the strengths of both the organizations. Thus **Teerthanker Mahaveer University** and **Abhinav Prodhyogiki Udhyamee Vikas Simiti** have agreed for the collaboration for mutual benefits with focus on the awareness programmes.

Area of Co-operation:

The parties shall collaborate in the following areas:

- Awareness programmes on Road Safety
- · Awareness programmes on environment
- · Organize Health Camps
- Awareness on re-cycling of Hygiene items/ reusable items.

The Parties here to agree to enter into this MoU, and shall not do or cause to be done anything derogatory to the reputation of the other.

During the term of this MOU and thereafter for reasonable period, all the Parties here to undertake on behalf of their respective sub-contractors / employees / representatives / associates to maintain strict confidentiality and present disclosure thereof, of all the information and data exchanged / generated pertaining to work / activity under this MOU for any purpose other than that specified in this MOU.

None of the Parties will be held responsible for non- fulfillment of their respective obligations under this MOU due to the exigency of one or more of the force majeure events such as but not

limited to acts of God, war, flood, earthquakes, strikes, lock-outs, epidemics, riots, civil commotions, etc., or for any other reason beyond the control of the Parties, provided on the occurrence and cessation of any such events, the Party affected thereby shall give a notice in writing to the other Party within one month of such occurrence of cessation. If the force majeure conditions continue beyond six months, the Parties shall jointly decide about the future course of action.

There is no **financial involvement** on both the parties. Each party will make its own expenditure to ensure the success of the MoU.

Notwithstanding the terms of any other provisions of this MoU, this MoU is not legally binding and nothing contained in this MoU shall impose any legal obligations on either party whatsoever.

This MoU may be amended by agreement of both parties in writing from time to time for mutual benefit.

Both parties agree to:

Communicate regularly via emails, meet formally at least every three months to review progress, update their respective Senior Managers/Executive Team quarterly of progress of this MoU.

During the Tenure of this Agreement / MOU, Parties hereto may terminate the agreement either for breach of the terms and conditions of the agreement or otherwise by giving 03 (three) months notice in writing to the defaulting / Other Party.

Dispute resolution:

If any dispute difference question or disagreement arises between the Parties hereto or their respective representatives or assignees at any time, in connection with construction, meaning,

operation, effect, interpretation or out of the MoU or breach thereof, the same shall be decided by a committee comprising of the advisory board of the Teerthanker Mahaveer University which shall be as follows:

Chairperson: Joint Registrar (Governance), Teerthanker Mahaveer University

Co-Chairperson: Secretary, Abhinav Prodhyogiki Udhyamee Vikas Simiti
