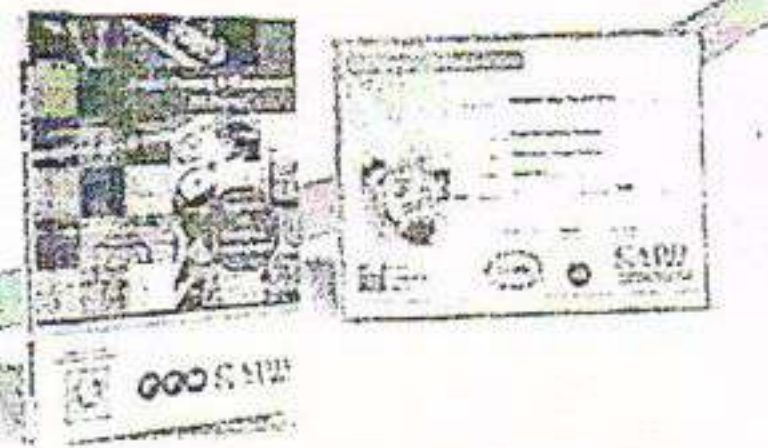
Programme Coordinator

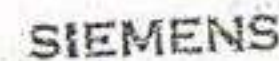
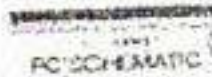
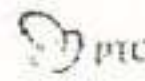
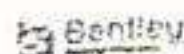
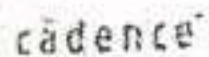
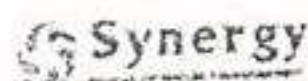
COMMENCEMENT OF COURSE

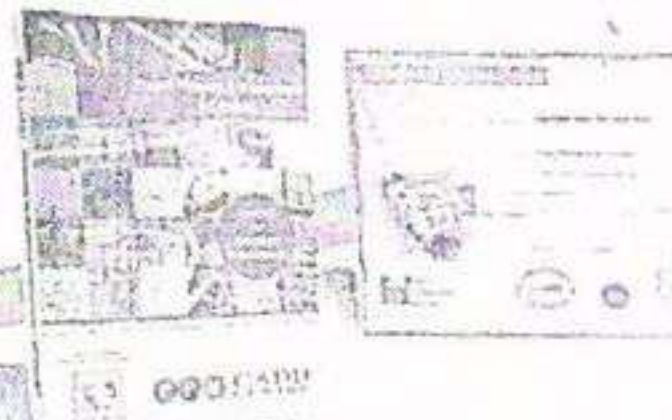

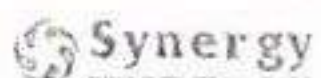

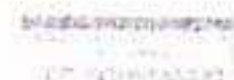
