



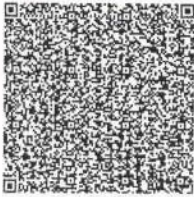

Party 2

Chetna Vikas Swarajya Trust, Regional Council under PGS & Trainer Organic Farming, Ministry of Agriculture & Farmers Welfare, Govt of India. Having its office at Vill.- Behta, Bulandshahar, U.P. and represented by Padam Shri Dr. Bharat Bhushan Tyagi, President.

In consideration of the above, the parties agree to enter into this Educational Cooperation Agreement for the performance of external training and development programmes for students & faculty members on organic farming, training & entrepreneurship.

And Whereas

Teerthanker Mahaveer College of Agriculture Sciences, TMU was established in the year 2014, offers B.Sc. (Hons) Agriculture.

Chetna Vikas Swarajya Trust, Bulandshahar, U.P. which provides training of various agricultural and allied activities.

Objectives of the Collaboration:

The parties are exploring the possibility of working together in areas of mutual interest and wish to enter into this Memorandum of Understanding ("MoU") to set out the areas of co-operation to take advantage of the strengths of both the organizations. Thus both parties have agreed for the collaboration for mutual benefits.

Area of Co-operation:

The parties shall collaborate in the following areas: -

1. Value education and training for organic agriculture.
2. Immersive training of students and faculty through project management.

During the term of this M O U and thereafter for reasonable period, all the Parties here to undertake on behalf of their respective sub-contractors / employees / representatives / associates to maintain strict confidentiality and present disclosure thereof, of all the information and data exchanged / generated pertaining to work / activity under this MOU for any purpose other than that specified in this MOU.

None of the Parties will be held responsible for non- fulfillment of their respective obligations under this MOU due to the exigency of one or more of the force majeure events such as but not limited to acts of God, war, flood, earthquakes, strikes, lock-outs, epidemics, riots, civil commotions, etc., or for any other reason beyond the control of the Parties, provided on the occurrence and cessation of any such events, the Party affected thereby shall give a notice in writing to the other Party within one month of such occurrence of cessation. If the force majeure conditions continue beyond six months, the Parties shall jointly decide about the future course of action.

There is no financial binding on both the parties.

Notwithstanding the terms of any other provisions of this MoU, this MoU is not legally binding and nothing contained in this MoU shall impose any legal obligations on either party whatsoever.

This MoU may be amended by agreement of both parties in writing from time to time for mutual benefit.

Communicate regularly via emails, meet formally at least every three months to review progress, update their respective Senior Managers/Executive Team quarterly of progress of this MoU. Meetings will be held alternatively in the TMU and Chetna Vikas Swarajya Trust, Bulandshahar, U.P.

During the Tenure of this Agreement / MOU, Parties hereto may terminate the agreement either for breach of the terms and conditions of the agreement or otherwise by giving 03 (three) months notice in writing to the defaulting / Other Party. Any such termination shall not affect the smooth Course completion of the existing batch of students and upon serving of notice of termination by any of the Parties.


