

In consideration of the above, the parties agree to enter into this Educational Cooperation Agreement for consultancy, research and training.

And Whereas

College of Agriculture Sciences, TMU was established in the year 2014, offers B.Sc. (Hons) Agriculture.

Area of Co-operation:

The parties shall collaborate in the following areas: -

- Training of students, faculty & staff of Party 1 by Party 2 on various activities related with the manufacturing/ marketing of the products.
- 2. Consultancy, research and training by the Party 1 on the request of Party 2 as and when requested.

During the term of this MoU and thereafter for reasonable period, all the Parties here to undertake on behalf of their respective sub-contractors / employees / representatives / associates to maintain strict confidentiality and present disclosure thereof, of all the information and data exchanged / generated pertaining to work / activity under this MoU for any purpose other than that specified in this MoU.

None of the Parties will be held responsible for non-fulfillment of their respective obligations under this MOU due to the exigency of one or more of the force majeure events such as but not limited to acts of God, war, flood, earthquakes, strikes, lock-outs, epidemics, riots, civil commotions, etc., or for any other reason beyond the control of the Parties, provided on the occurrence and cessation of any such events, the Party affected thereby shall give a notice in writing to the other Party within one month of such occurrence of cessation. If the force majeure conditions continue beyond six months, the Parties shall jointly decide about the future course of action.

There is no financial binding on both the parties.

Notwithstanding the terms of any other provisions of this MoU, this MoU is not legally binding and nothing contained in this MoU shall impose any legal obligations on either party whatsoever. This MoU may be amended by agreement of both parties in writing from time to time for mutual benefit.
