MEMORANDUM OF UNDERSTANDING

This Memorandum of Understanding (MOU) between Joint Registrar, (Governance) Teerthanker Mahaveer University, Moradabad- U.P. (herein after called "TM University") represented by Prof. Anurag Verma (Registrar) of the One Part.

KLE College of Pharmacy, Belagavi, established in 1985 and engaged in teaching, training and research in Pharmaceutical Science (herein after called "The Institute") represented by Dr. Sunil S. Jalalpure (Principal) of the One Part.

Aims and Objectives of the MOU

- 1) By entering into this MoU the Institute and TM University agree to set up a frame work to encourage and develop collaboration between TM University, and the Institute in the areas of mutual interest in the field of Pharmaceutical Science.
- 2) The initial specific objectives between the parties are as under:
 - a) Cooperation in the exchange of information relating to their activities in teaching and research in fields of mutual interests:
 - b) Promotion of appropriate joint research projects with particular emphasis on DST/DBT/University funded projects;
 - c) Endeavour to encourage staff to spend periods of time in the host University. The host institution agrees to assist in the seeking of appropriate housing and to supply work space, library and technical facilities as appropriate.
 - d) Conduct study tours for students, mutually agreed in writing between the Universities prior to commencement of this activity.
- 3) The parties shall not at any time during or after the term of this MOU, divulge, or allow to be divulged, to any person, any confidential information (including, but not limited to, any information relating to the accounts, finance, contractual arrangement, products, business or affairs of the parties) unless the said information comes in public domain without breach by either party.
- 4) This MOU shall be in operation for a period of 03 years from the date of signing.
