## I. <u>INTRODUCTION</u>

This binding MEMORANDUM OF UNDERSTANDING ("Memorandum"), is dated Date, 2021 executed at Moradabad, between "College of Paramedical Sciences, Teerthanker Mahaveer University", a full-fledged State Private University established by Act No. 30 of 2008 of the Government of Uttar Pradesh and has been approved by University Grants Commission under Section 2 of UGC Act, 1956 situated at Delhi Road, NH 24, Bagadpur, Uttar Pradesh 244001 represented by "Registrar, Dr. Aditya Sharma"; and Lenskart Eyetech having its registered office at W-123, Greater Kailash – II, New Delhi 110048 represented by Sumit Marda, collectively referred to as the "Parties" and individually as a "Party".

#### II. PREAMBLE

WHEREAS, "College of Paramedical Sciences, Teerthanker Mahaveer University", the Partner, is an organization established with the goal of providing education in the field of optometry, Forensic Science, Medical Lab Techniques, Radiological Imaging Techniques.

This Memorandum shall take effect upon signing by both Parties and shall remain in effect for a period of 1 year from that date unless earlier terminated.

Neither Party may assign or transfer all or any portion of this Memorandum without the prior written consent of the other Party.

The Memorandum may be renewed at the end of this period by mutual written agreement by both Parties.

The provisions of this Memorandum may only be amended or waived by mutual written agreement by both Parties.

Lenskart may terminate this Memorandum (and any related agreement, work plan and budget, if executed/agreed) at any time and for any reason by giving thirty (30) days prior written notice to the Partner.

#### X. TRANSFER OF FUNDS

The Parties acknowledge and agree that this Memorandum does not create any financial or funding obligation on either Party, and that such obligations shall arise only upon joint execution of a subsequent agreement or work plan (if entered between the Parties) that specifically defines the terms and nature of such obligations and that references this Memorandum. Such subsequent agreements or work plans, and budgets, will be subject to funding being specifically available for the purposes outlined therein.
