



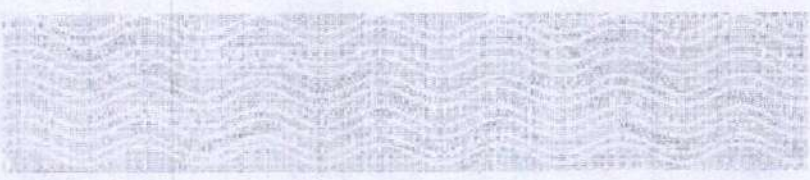

### AGREEMENT FOR SERVICES

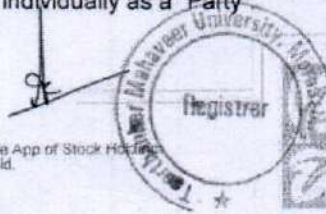


