Private Universities Act 2019, having its principal office at Bagadpur, Pakbara, Delhi Road, Moradabad, India. (Hereinafter referred to as "**TMU**"), which expression shall include its successors in office and permitted assignees of the SECOND PART
AND

TEERTHANKER MAHAVEER INSTITUTE OF MANAGEMENT TECHONOLY SOCIETY registered under Societies Registration Act, 1860, having its principal office at Delhi Road Moradabad UP 244001 India. (Hereinafter referred to as "**TMIMT**"), which expression shall include its successors in office and permitted assignees of the THIRD PART

Each of UR SERVICES, University & Society hereinafter collectively referred to as a "Parties" and individually referred to as a "Party".

AND WHEREAS

1. UR SERVICES has initiated Industry Interface partnership with a view to impart education, training, seminars, enhance management skills, dissemination of practical knowledge through internship, personality development and other related activities.
2. TMU conducting various degree courses having authority to conduct such educational courses, training for students and has ability, authority and capacity to enter into such tie-ups and arrangement in order to educate and impart knowledge to students.
3. TMIMT is the sponsoring body of TMU and shall be responsible for charging the fee from the students and making the due payments to UR Services as per the terms and conditions of this MoU.

4. TMIMT, TMU and UR SERVICES are keen and desirous to join hands and enter into such tie-ups, arrangements whereby students registered with TMU can be educated and get additional knowledge, enhance their skills and get corporate exposure, are desirous to enter into this arrangement on the terms and conditions mentioned herein.

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. DEFINITION

Unless contrary to the context, the terms used in the Agreement shall have following meaning:

2. INTERPRETATION

Same to the extent that the context or express provisions of this Agreement otherwise require:



- a. Headings and sub-headings are for ease of reference only and shall not be taken into consideration in the interpretation or construction of this Agreement;
- b. All reference to Clauses and Annexure is reference to Clauses of and Annexure to this Agreement;
- c. The Annexure to this Agreement are an integral part of this Agreement and reference to Agreement includes reference thereto;
- d. All references to the act, statute or statutory provisions shall include reference to any act, statute, statutory provision which amends, extends, consolidates or replace the same or which has been amended, extended, consolidated or replaced by the same and shall include, without limitation, any bye laws, regulations, rules, notices, orders, circulars, code of conduct, code of practice made under the relevant statute;
- e. Words importing the singular include the plural and vice versa;
- f. Words importing a particular gender include all genders;
- g. The term "including" means including but without limitation.

3. SCOPE

The TMU will provide Bachelor of Business Administration (BBA) a bachelor's degree in Business Administration.

In their BBA programme, the TMU has expressed desire to include the modules delivered by UR SERVICES's Corporate Model Centre Program **Annexure I** of this Agreement provides the modules to be delivered by UR SERVICES.

The schedule of Programme for various Modules/Courses will be jointly decided and agreed by the parties. The schedule will be structured in such a way that the entire module/course will be finished in the provided timelines. In the event of any change in the agreed schedule by UR SERVICES, UR SERVICES will inform the TMU about such change due to non-availability of trainer due to illness, any emergency, etc., or for any other purpose and the TMU will try to schedule on some other day and time as agreed by the parties. Provided that, UR SERVICES will send the trainers on the schedule date and time to the best of is endeavor and complete the modules/courses as per the schedule decided by the parties.

4. ROLES AND RESPONSIBILITY OF UR SERVICES

- a. The Contents of the Modules/Courses will be prepared by UR SERVICES for the modules/courses to be delivered by UR SERVICES in consultation with TMU and same will be approved through TMU academic body, before start of academic session.
- b. UR SERVICES will provide trainers to the TMU for the purpose of imparting lectures and training on such agreed modules/course mentioned in the Curriculum in Annexure I which will fulfill the norms as defined by TMU from time to time & seek prior approval of the trainers from TMU (Out of total trainers being provided by U.R. Services, minimum 05 Trainers would be from reputed



organizations in Bangalore/ Mumbai/ Pune). UR SERVICES will not conduct classes/ training through non approved trainer. UR SERVICES will provide qualified, knowledgeable, experienced, professional trainers to train the students on the respective modules/courses details of which will be provided before start of semester. UR Services shall bear with all the expenses for the trainers including their remuneration, lodging & boarding, travelling and alike.

- c. UR SERVICES will obtain written feedback of the students about the module/course contents; trainer and training imparted to them and shall endeavor to take action as per the feedback provided by the students.
- d. UR SERVICES shall ensure that the trainer undertakes to perform the services with the highest standard of professional and ethical competency and integrity.
- e. Regular assessment / evaluation of the students will be done by TMU as per its ordinance. However, UR SERVICES can conduct assessment of all enrolled students of the module /course delivered by them, but this assessment shall not have any impact on the evaluation/assessment done by TMU as per its Ordinances.
- f. UR SERVICES will provide the internship / summer training at its tie up companies or will facilitate in other corporate for 6-8 weeks (Approx 60 days) for each of the students who are enrolled for this programme. However, UR SERVICES do not guarantee for any stipend. UR SERVICES do not guarantee lodging, boarding, traveling arrangements and it has to be borne by the students, however UR Services shall facilitate the students in getting such arrangements. UR SERVICES will try to provide internship / summer training opportunities at other companies based on other company's criteria/requirement and on their terms. The concerned companies will provide letter/certificate to such candidates who will successfully complete their internship.
- g. UR Services will responsible be to line up Industrial visits for all enrolled students, However Bus facility will be provided by TMU (Fuel & Permit expenses will be born by UR Services)
- h. UR SERVICES will provide placement assistance to the students who are enrolled under this course.
- i. UR SERVICES will provide each student summer training / internship/OJT certificate and course completion / other certificate as agreed by both parties.



5. ROLES AND RESPONSIBILITY OF TMU & TMIMT

- a. TMU shall ensure the entire process of admission, as mentioned in **Annexure II** of this Agreement. TMU will be responsible to provide Id cards, code of conduct, guidelines, procedure, policies, rules, bye-laws to the students who are enrolled under this course.
- b. TMIMT will issue challans to the students upon receipt of payment of fees and required documents and based upon the receipt of the required fee and clearance from TMIMT, TMU shall provide them admission. TMIMT shall be responsible and liable for collection of fees.
- c. The batch will contain maximum of 60 students.
- d. TMIMT shall provide and maintain proper infrastructure to the trainers of UR SERVICES for conducting and imparting training to the students. TMU shall be liable to maintain well equipped library, training room, computer room, sufficient number of computers with internet facility, study material, modules, etc
- e. TMIMT will make necessary arrangement for boarding & lodging of UR SERVICES trainers during their stay in the University for delivery of modules/courses, examination time, conducting training and for any other related purpose on paid basis as per TMU Guest House policy and availability of the accommodation.
- f. TMU will share the performance of each student who are enrolled under this programme with UR SERVICES on their regular assessment and send the performance reports to UR SERVICES within seven (7) days from the date of declaration of results of such assessments, similarly all information of the assessment by UR SERVICES will be shared with TMU.
- g. TMU and UR SERVICES will clearly communicate to the students that the programme provided herein does not guarantee any placement but UR Services will facilitate in the placements of the enrolled students. In the event of any issue, complaint received in this regard both the parties will resolve the issues.
- h. TMU and TMIMT shall be responsible for doing and performing all acts, roles, responsibilities and obligations whether administrative, supervisory or otherwise, which it is required to do under normal circumstances for such courses conducted by them.
- i. TMIMT will charge fee to the students for this programme as approved by the competent authority from time to time. Presently, the tuition fee decided for the programme from session 2020-21 is Rs 35000/- per semester. There will be no increase in fee for one batch.



6. REPRESENTATION AND WARRANTIES PROVIDED BY UR SERVICES

- a. Has necessary and sufficient trainer/s to provide the training under this Agreement.
- b. Is capable and permitted under the existing laws, rules and regulations as applicable and have authority to enter into such arrangement and is not barred under any law and under any contractual relationship with anyone;
- c. Shall abide and comply with all the applicable laws and any amendments thereto;
- d. Shall promptly assist TMU in resolving all queries, complaints and claims made by its students, regulators or any other person in regard to and/or in respect of and/or arising out of the modules provided herein by UR SERVICES;
- e. UR SERVICES shall provide teaching calendar with the names & profile of trainers well in advance & will seek approval in advance.
- f. Has not provided any false information or suppressed any material information.
- g. Will not do any such act or represent in a manner which will bring disrepute to TMU and spoil, hamper, damage the image, reputation of TMU and vice versa.

7. REPRESENTATION AND WARRANTIES PROVIDED BY TMU & TMIMT

- a. TMU will award degrees as notified by University Grant Commission (UGC) from time to time.
- b. TMIMT has adequate resources, system, and infrastructure requirement in place, faculty member and staff for the purpose of this Agreement and ensure that work will not be affected in any manner. TMIMT will provide boarding and lodging facilities to the Trainers of UR SERVICES on paid basis as per the TMU Guest House policy.
- c. TMU has authority and permission to conduct such educational programmes and TMIMT shall collect fees and is not barred under any law, rules and regulation applicable to them.
- d. TMU has permission, approval to conduct the examination and to do assessment.
- e. TMU has necessary registration, permission, authority, government approval to run and issue valid and recognized degrees and certificates to the students.
- f. Shall abide and comply with all the applicable laws, government orders, bye laws, rules and regulation, etc. and any amendments thereto.
- g. Is capable and permitted under the existing laws, rules, regulation, government orders as applicable and have authority to enter into such arrangement and is not barred under any contractual relationship with anyone.



- h. Has not provided any false information or suppressed any material information.
- i. Will not do any such act or represent in a manner which will bring disrepute to UR SERVICES and spoil, hamper, damage the image, reputation of UR SERVICES and vice versa.
- j. All rules and regulations at TMU will be applicable to students enrolled under this program.

8. Payment and Consideration

- a. TMIMT agrees to pay to UR SERVICES for this arrangement as per the **Annexure III** annexed with this Agreement in the manner provided in the said Annexure. (40% of Tuition fee in every semester)

9. Term and Termination

- a. The term of this Agreement shall commence on January 14, 2020 (hereinafter referred to as "Commencement Date") and shall be valid for a initial period till 6 years or completion of BBA Degree Program of 2 Batches from the date of Commencement Date (hereinafter referred to as the "Term") unless otherwise terminated in accordance with the provisions contained herein. This Agreement may be renewed with the mutual consent of the parties and reduced in writing signed by or behalf of the parties.
- b. Either Party may terminate this Agreement without assigning a reason prior to the commencement of new session (Admissions of new students in new academic year).
- c. In the event either party has committed a breach of any of the covenants, representations, warranties or other terms and conditions of this Agreement or has defaulted in the performance of any of its obligation under this Agreement (provided that the non- breaching/non-defaulting party has first given the other party written notice of the grounds supporting the breach or default and the breaching/defaulting party has not cured or has not commenced to cure in a reasonable manner and with all due speed, the breach of default within one (1) week of receipt of such notice) the breaching/defaulting party shall be held in default and the non-breaching party shall be entitled to terminate this Agreement and shall have all the remedies as specified in this Agreement and applicable laws.
- d. In the event of termination or expiration of this Agreement for whatsoever reason, both parties shall immediately cease to have rights (if any) to use any of the logo, trade name in connection of the arrangement or any other rights granted under this Agreement, shall immediately return all course content, training material, reports, information, data, marketing, promotional and advertising material and any other material, information and belongings of the other party. However, both parties will ensure that students enrolled shall continue to study and complete the program as per agreed procedure and both parties will fulfill their obligations.



- e. Any termination of this Agreement (howsoever occasioned) shall not affect any accrued rights or liabilities of either party nor shall it affect coming into force or the continuance in force of any provisions hereof which is expressly or by implication intended to come into or continue in force on or after such termination.

10. Dispute Resolution

This Agreement shall be governed by and constructed in accordance with the laws of India

10.1 The Parties shall attempt to amicably settle all disputes arising out of this Agreement and the obligations hereunder ("Dispute"). Either Party may give written notice of a dispute to the other Party within (10) days of the occurrence of the event which gives rise to such Dispute or the date of such event.

Any dispute in connection with this Agreement shall be referred to the designated officials of both the parties for mutual discussions and resolution.

10.2 A Five (5) member committee will be constituted to resolve the issue with two members TMU, one member from TMIMT Society & Two members (2) from UR Services.

10.3 If no settlement can be reached through mutual discussions and negotiations, then such matter shall be finally settled by Honorable Vice Chancellor, TMU.

11. Waiver

Neither waiver by any one party of the other party's obligation under this Agreement shall be deemed effective unless made by the party in writing, nor shall any waiver by any one party in respect of any breach be deemed to constitute a waiver of or consent to any other or subsequent breach by the other party of its obligation.

12. Amendments

No addition, modification or amendment to any of the provisions of this Agreement shall be valid and binding unless made by a written instrument signed by a duly authorized representative of each of the parties.

13. Force Majeure

Neither party hereto shall be liable for any failure to perform its obligations hereunder to the extent that performance has been delayed, hindered or prevented by any circumstances beyond the reasonable control of that Party including without prejudice to the generality of the foregoing any act of God, war, riot, civil commotion, fire, explosion, flood, adverse weather, epidemic or other natural physical disaster, strike, lock-out or other form of industrial action or any form or governmental or supernatural



authority, intervention. Provided, however, that the party so affected informs the other party in writing as soon as possible, detailing the circumstances under which it is unable to fulfill its obligations under this Agreement and also stating as to when it would be able to recommence its performance under this Agreement.

14. Notice

All notices required to be given by the parties under this Agreement, will be given in writing and be sufficiently served, if delivered personally or by courier or by registered post, to the address mentioned herein below or such other address as party may intimate in writing from time to time.

16. Severability

If one or more of the provisions contained in this Agreement is found to be invalid, illegal or unenforceable in any respect, the validity, legality and enforceability of the remaining provisions shall not be affected. Such provisions shall be reformed only to the extent to make it enforceable.

17. Assignment

This Agreement or any rights assigned to each party under this Agreement shall not be assigned or transferred to others without prior written consent of other party and any attempt to assign or transfer this Agreement without such consent shall be null and void and constitute a material default hereunder.



18. Execution of this Agreement

This Agreement may be executed in two parts, each of which when so executed and delivered shall be deemed an original and which together shall constitute but one and the same instrument.

To qualify the course a student is required to secure a minimum of 45% marks in aggregate including the semester end examination and teachers continuous evaluation.(i.e. both internal and external).A candidate who secures less than 45% of marks in a course shall be deemed to have failed in that course. The student should have at least 45% marks in aggregate to clear the semester.

.Question Paper Structure

1	The question paper shall consist of eight questions. Out of which first question shall be of short answer type (not exceeding 50 words) and will be compulsory. Question No. 1 shall contain 8 parts representing all units of the syllabus and students shall have to answer any five (weightage 2 marks each)
2	Out of the remaining five questions, student shall be required to attempt all five questions with internal choice. There will be minimum one and maximum two questions from each unit of the syllabus. The weightage of Question No. 2 to 6 shall be 10 marks each.

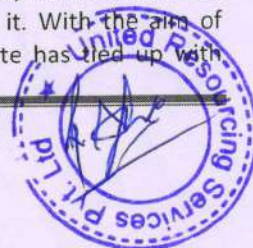
Students successfully completing this program will not only be able get hands-on exposure with various industries and their professionals but will also be able to develop and hone their skills matching with the present industry requirements.

B. Choice Based Credit System (CBCS)

Choice Based Credit System (CBCS) is a versatile and flexible option for each student to achieve their target number of credits as specified by the UGC and adopted by our University. The following is the course module designed for the BBA (IB&ED) program:

Core Course (CC): Core courses of BBA (IB&ED) program will provide a holistic approach to management education, giving students both an overview of the field, and a basis to build, and specialize upon. These core courses are the strong foundation to establish management knowledge and provide broad multi-disciplined knowledge that can be further be studied in depth during the elective phase. The core courses will provide students with more than just practical knowledge, case-based lessons and collaborative learning models, train students to analyze, decide, and lead-rather than merely know-while creating a common student experience that can foster a deep understanding, develop decision-making ability and contribute to the business and community at large. A wide range of core courses provide groundwork in the basic commerce disciplines: Accounting, finance, taxation, statistics, etc. The integrated foundation is important for students because it will not only allow them to build upon existing skills, but they could also explore career options in a range of industries, and expand their understanding of various management fields. This program offered 13 core courses of 4 credits each.

Ability Enhancement Compulsory Course (AECC): As per the guidelines of Choice Based Credit System (CBCS) for all Universities, including the private universities, the Ability Enhancement Compulsory Course (AECC) is a course designed to develop the ability of students in communication (especially English) and other related subjects where they might find it difficult to communicate at a higher level in their prospective job at a later stage due to lack of practice and exposure in the language, etc. Students are motivated to learn the theory, fundamentals and tools of communication which can help them develop and sustain in the corporate environment and culture. This program offered 6 AEC courses of 4 credits each.

Generic Elective Course (GEC): Generic Elective is an interdisciplinary additional course. The score of Generic Elective is counted in your overall CGPI under Choice Based Credit System (CBCS). This program offered 3 GE courses of 4 credits each.

Skill Enhancement Course (SEC): These courses may be chosen from a pool of courses designed to provide value-based and/or skill-based knowledge. This program offered 3 SE courses of 4 credits each.

Compulsory Specified Course (CSC): This is a compulsory course which does not have any choice and will be of 4 credits. Each student of BBA Program has to compulsorily pass the "Human Values & Professional Ethics" Course and acquire a total of 4 credits.

Discipline Specific Elective Course (DSEC): The discipline specific elective courses are chosen to make students specialist or having specialized knowledge of a specific domain International Business and



Entrepreneurship Development. It will be covered in fifth semester of third year of the program.. Each DSEC will carry 4 credits.

Viva Voce (VV): The viva- voce courses are chosen to make students have a clear and specific knowledge regarding their particular subjects and the type of projects they have undergone during their respective semesters.

C. Pedagogy & Unique practices adopted: "Pedagogy is the method and practice of teaching, especially for teaching an academic subject or theoretical concept". In addition to conventional time-tested lecture method, the institute adopts the following pedagogical approaches:

- **Case Based Learning:** Case based learning enhances student skills at delineating the critical decision dilemmas faced by organizations, helps in applying concepts, principles and analytical skills to solve the delineated problems and develops effective templates for business problem solving. Case method of teaching is used as a critical learning tool for effective learning and we encourage it to the fullest. We make it compulsory to teach at least one case study in each unit of every course in BBA (International Business and Entrepreneurship) program.
- **Role Play & Simulation:** Role-play and simulation are forms of experiential learning. Learners take on different roles, assuming a profile of a character or personality, and interact and participate in diverse and complex learning settings. Role-play and simulation function as learning tools for teams and groups or individuals as they "play" online or face-to-face. They alter the power ratios in teaching and learning relationships between students and educators, as students learn through their explorations and the viewpoints of the character or personality they are articulating in the environment. This student-centered space can enable learner-oriented assessment, where the design of the task is created for active student learning. Therefore, role-play& simulation exercises such as virtual share trading, marketing simulation etc. are being promoted for the practical-based experiential learning of our students.
- **Video Based Learning (VBL) & Learning through Movies (LTM):** These days technology has taken a front seat and classrooms are well equipped with equipment and gadgets. Video-based learning has become an indispensable part of learning. Similarly, students can learn various concepts through movies. In fact, many teachers give examples from movies during their discourses. Making students learn few important theoretical concepts through VBL & LTM is a good idea and method. The learning becomes really interesting and easy as videos add life to concepts and make the learning engaging and effective. Therefore, our institute is promoting VBL & LTM, wherever possible.
- **Experiential/Live Projects:** The students, who take up experiential projects in companies, where senior executives with a stake in teaching guide them, drive the learning. All students are encouraged to do some live project other their regular classes. There will be regular projects in all semesters for students, facilitating them to have live experience of the subjects covered with practical exposure.
- **Industrial Visits:** Industrial visit are essential to give students hand-on exposure and experience of how things and processes work in industries. Our institute organizes such visits to enhance students' exposure to practical learning and work out for a report of such a visit relating to their specific topic, course or even domain.
- **Special Guest Lectures (SGL) & Extra Mural Lectures (EML):** Some topics/concepts need extra attention and efforts as they either may be high in difficulty level or requires experts from specific industry / domain to make things/concepts clear for a better understanding from the perspective of the industry.
