BBALLB (H): Five-Year Integrated LLB Programme

A. Introduction:

Bachelor of Business Administration & Bachelor of Laws (Honours) is a 5-year course which is a professional integrated course with two interrelating subjects of humanities and law. It is called an Integrated Course because LLB course syllabus involves the study of Arts along with the in-depth study of law and legislature. The duration of the course is 5 years and consists of 10 semesters of study. This integrated bachelor degree consists of disciplines such as Management as major and Accounting, Finance and English as minor areas of study to supplement the wide range of law subjects as prescribed by Bar Council of India. The Job Opportunity varies depending on the area of interest and expertise gained by the student over the course at the same time. The maximum duration to clear the course is a period of Seven years from the date of admission to the First Semester Course.

B. Choice Based Credit System (CBCS)

Choice Based Credit System (CBCS) is a versatile and flexible option for each student to achieve his target number of credits as specified by the UGC and adopted by Teerthanker Mahaveer University. The following is course pattern designed for the BBALLB 5 Years Integrated programme:

Discipline Specific Course (DSC): Discipline Specific Course of BBALLB 5 Years Integrated program will provide a holistic approach to Legal education, giving students an overview of the Law field, a basis to build and specialize upon. These Discipline Specific Course are designed and developed on the basis of the strict guidelines of Bar Council of India.

The Discipline Specific Course will provide theoretical as well as practical knowledge of the subjects with the latest developments of the Indian Parliament, Judiciary and of Executive too. It will train the students to understand, analyze, assess and develop deep understanding, decision-making ability and a sense of social responsibility. It will lead them to play a significant role in Justice Delivery System.

A wide range of Discipline Specific Course provides groundwork in the basic of management and Law disciplines. The college offers Discipline Specific Course from semester I to Semester X in a very systematic way.

Ability Enhancement Compulsory Course (AECC): Law professionals are known more for their way of communication and presentation rather than their subjective knowledge To develop the ability of students in communication (especially English) and presentation, English courses have been developed to make them able to communicate at a higher level in their prospective job or practice at a later stage. Students are motivated to learn the theories, fundamentals and tools of communication which can help them develop and sustain in the corporate environment and culture.

Skill Enhancement Course:

As per the guidelines of Bar Council of India 4 clinical courses have been added in the curriculum for skill enhancement, known as Skill Enhancement Course (SEC). These 4 papers are based on the very foundation of Law profession like drafting & pleading, professional ethics & etiquettes, ADR techniques & tools and also with moot and mock court practices. A law professional is required to be equipped with the knowledge of these in either role of judge, lawyer, advisor etc.

Open/Generic Elective Course (GEC): Open/Generic Elective is an interdisciplinary additional subject that is compulsory in the VII & VIII semester of a program. The score of Open/Generic Elective is counted in overall aggregate marks under Choice Based Credit System (CBCS). Each Open/Generic Elective paper will be of 3 Credits and students will have the choice of taking 2 Open/Generic Elective 1 each in Semester VII & VIII. Each student has to take Open/Generic Electives from department other than the parent department. Core / Discipline Specific Electives will not be offered as Generic Electives.

Value Added Course (VAC): A value added course is a non-credit course which is basically meant to enhance general ability of students in areas like soft skills, quantitative aptitude and reasoning ability required for the overall development of a student and at the same time crucial for industry/corporate demands and requirements. The student possessing these skills will definitely develop acumen to perform well during the recruitment process of any premier organization and will have the desired confidence to face the interview. Moreover, these skills are also essential in day-to-day life of the Law field. The aim is to nurture every student for making effective communication, developing aptitude and a general reasoning ability for a better performance, as desired in Law field. There shall be one course each in Semester IX & Semester X and will carry no credit, however, it will be compulsory for every student to pass these courses with minimum 45% marks. These marks will not be included in the calculation of CGPI.

Program/Discipline Specific Elective Course (DSEC): Since the BALLB program is honors program, the discipline specific elective course is chosen to make students specialist or having specialized knowledge of a specific domain like Criminal Law, Constitutional Law, Corporate Law and IPR. It will be covered in two
