- **5.1** In case, if a student chooses to withdraw from a programme of study in which he/she is enrolled, following system of fee refund shall be followed:

Further, it is also notified that there shall be no refund of <u>application processing</u>, <u>registration</u> fees and enrolment fee in case of withdrawal of admission.

In case of cancellation of admission of the student by the University, the fee refund shall depend upon the circumstances in which the University has cancelled the admission of the student.

- **5.2** If during an academic year/session, a student desires to leave a teaching department of the University, of which he has become the member and joins another institution/university, he shall:
 - i. Give notice of his intention to leave.
 - **ii.** Make payment of all the dues due upto the end of the month in which his / her name remains on the rolls of the University.
 - **iii**. Refund whatever scholarship or bursary has been paid to him / her from the funds of the University.
 - 2. **3.01** As per the provisions of the section 12 of the Act and clause 1.06 of the Statutes of the Teerthanker Mahaveer University, there shall be an Admission Committee.
 - The composition of the Admission Committee shall be as:
