Curriculum Development	We follow the curriculum approved by the statutory bodies like MCI, DCI, AICTE, NCTE etc. However, some modifications are made purposefully for systematic organization to frame the instructional strategy. On the basis of inputs from various stakeholders such as parents, teachers, institutional heads is obtained before proceeding with any revamp in curriculum. We gather the information from the subject matter expert. For the social and

	industry exposure the curriculum is designed to integrate the field visits for the students without interfering with the syllabi prescribed by the governing bodies.
Teaching and Learning	Proper planning is done before the commencement of semester and teaching plan is scheduled according to academic calendar. Each individual faculty prepares a Teachers diary which consists of Academic Calendar, copy of Syllabus, Self Time Table, Lecture Plan, Class test marks, Student performance in attendance and Academics. Lecture delivery status is maintained by all faculty members on daily basis. It is regularly monitored by HOD/ Director/Principal.
Examination and Evaluation	University exhibits various information to students through notice boards, public address systems university websites (www.tmu.ac.in) like academic calendar, time-table, and results. Faculty member are intimated about meeting etc.via e-mail SMS or sometimes via circulars. Colleges ensures finalization of date sheet, setting of question paper ,coding of answer sheets evaluation of answer books, scrutiny of answer books, declaration of result and issuing the mark sheets whole system is centralized. There is a set well defined system for handling the student grievances related to examination like UFM, question paper etc the process is well defined in university ordinances and decisions are centralized.
