(This shall be a recognized medical qualification when granted by Kumaon University, Nainital, Uttarakhand in respect of students being trained at Government Medical College, Haldwani, Uttarakhand on or after 2014.

Note: 1. The recognition so granted to a Postgraduate Course shall be for a maximum period of 5 years, upon which it shall have to be renewed.

2. The procedure for 'Renewal' of recognition shall be same as applicable for the

award of recognition.

 Failure to seek timely renewal of recognition as required shall invariably result in stoppage of admissions to the concerned Postgraduate Course.
