Circular

In view of the present COVID-19 pandemic situations, the University has decided to conduct the Annual Theory Examinations session 2020-21 for the first year to final year students of various programmes of Nursing (B.Sc., Post Basic B.Sc. and M.Sc.) through online proctored mode.

The Annual Examinations for final year students of B.Sc., Post Basic B.Sc. and M.Sc. programmes are scheduled tentatively from **July 15, 2021 (Thursday)**.

The Annual Examinations for Third year students of B.Sc. programmes are scheduled tentatively from **July 22, 2021 (Thursday)**.

The Annual Examinations for Second year students of B.Sc. programmes are scheduled tentatively from **July 26, 2021 (Thursday)**.

The Annual Examinations for first year students of B.Sc., Post Basic B.Sc. and M.Sc. programmes are scheduled tentatively from **August 02, 2021 (Thursday)**.

In case, if any student as mentioned above is not able to appear for the Examination due to connectivity or other technical issue, the students will inform the concerned Principal/HoD. There shall be alternate arrangement for such students for the conduct of online proctored examination at the University campus. Such students will be informed about the process to be adopted by the Controller of Examinations to appear for the Examinations.

In case, if the exam is interrupted in between due to technical reason for a student, such student then shall be given the opportunity to appear for the Examination in another shift on same day or on other suitable date which shall be conveyed to him/her in advance.

The Standard Operating Procedure (SOP) pertaining to the Online Proctored Examinations as above for students and faculty members (Invigilators) and Centre Superintendents shall be released by the Controller of Examinations by **June 10, 2021**. The SOP for conduct of Practical Examinations shall also be released by the Controller of Examinations by **June 12, 2021**.

There shall be a dry run/ mock drill of the Exam at least five days prior to the conduct of Examinations and the information for same shall be given to the college Principal/Vice Principal by the Controller of Examinations, who in turn inform all concerned to participate in the mock drill.
